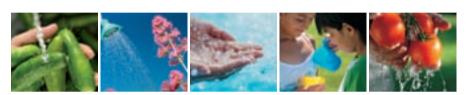

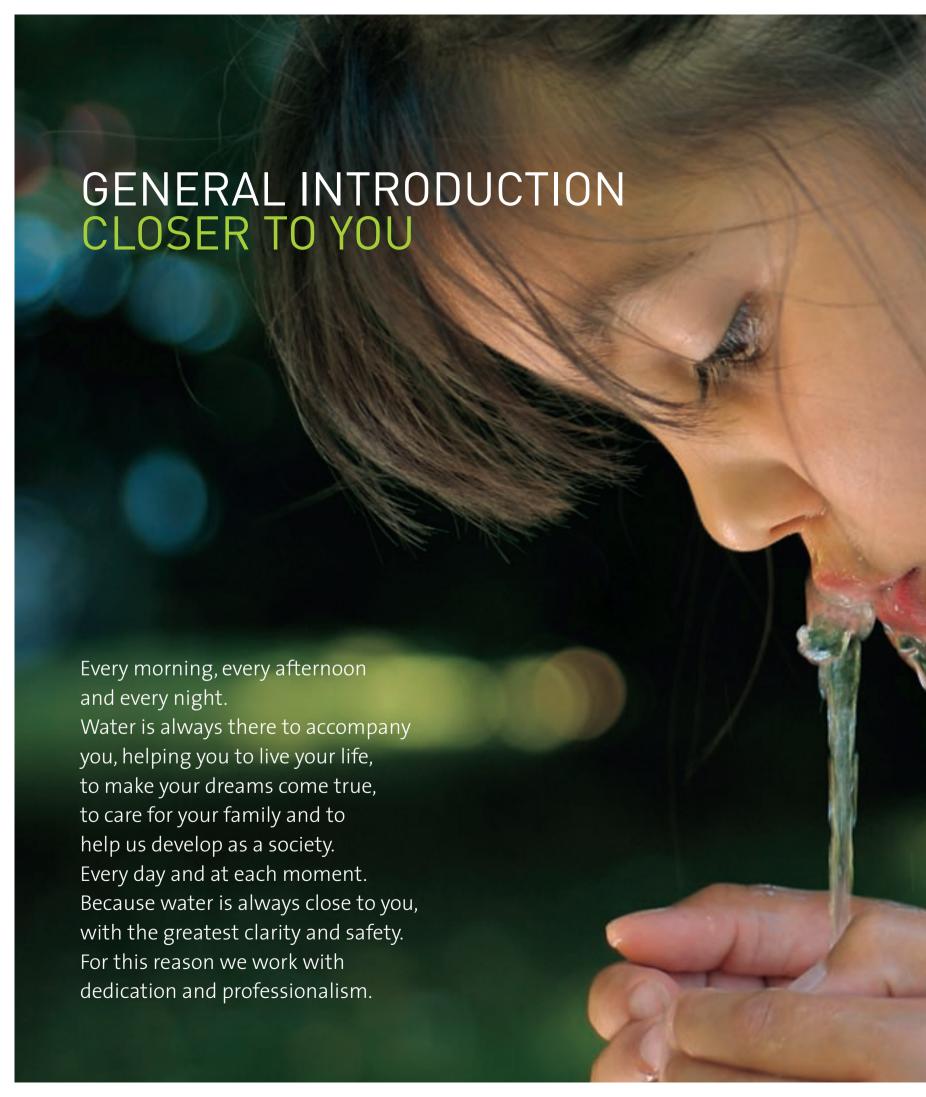

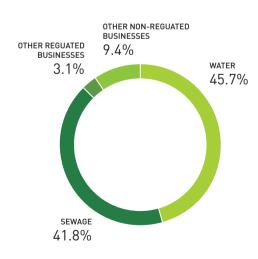

CHILEAN PESOS PER SERIES A SHARES.

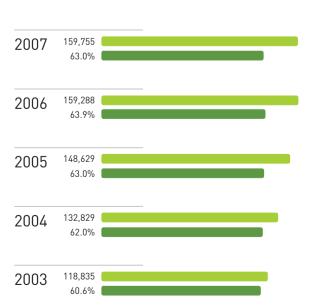

- 1861 Our history commences with the foundation of Empresa de Agua Potable de Santiago and the first study on improving collection at the Quebrada de Ramón.
- 1865 We constructed the first reservoirs for storing water.
- 1894 We initiated a program of works with the construction of drains in Vitacura for collecting filtered water from the Mapocho River and of a 20-thousand cubic meter tank on Calle Antonio Varas.
- 1903 The Sewerage and Paving of Santiago Law was enacted and this boosted the construction of mains for potable water and sewerage in the city.
- 1909 We installed 1,112 domestic connections and the first hydrants in Santiago.
- 1917 We inaugurated the Laguna Negra Aqueduct, which transports water

- from the mountains through its 87-kilometer extension.
- 1946 We put into operation the Las Vizcachas Plant with the purpose of producing potable water for Santiago.
- 1969 We inaugurated the Las Vizcachitas Plant together with the Paralelo Aqueduct.
- 1977 Our Company changed its name to Empresa Metropolitana de Obras Sanitarias (EMOS).
- 1984 We inaugurated the Ingeniero Antonio Tagle Potable Water Production Plant.
- 1989 EMOS was transformed into a corporation, subsidiary of Corporación de Fomento de la Producción (CORFO), the Chilean State Development Corporation.
- 1990 We initiated the construction of the first water treatment projects in the region

- such as the Zanjón Collector Interceptor and the piping of the A-H Canal.
- 1993 We inaugurated the West Santiago Sewage Treatment Plant.
- 1997 We inaugurated our Corporate Building located in the Parque de los Reyes in the municipal commune of Santiago.
- of the ownership of the Company was acquired by Inversiones Aguas Metropolitanas Ltda., owned by the Agbar Group (50%) and Suez (50%). Furthermore, we inaugurated the La Florida Potable Water Plant.
- 2000 We initiated the construction of the El Trebal Sewage Treatment Plant. The Company acquired 100% of Aguas Cordillera and 50% of Aguas Manquehue. We began to apply the Vita Plan to direct the organization towards



- an excellent service and to improving the efficiency and quality of the product.
- 2001 Change of name: The Company's name changed to Aguas Andinas S.A. We initiated the operations of the El Trebal Sewage Treatment Plant and started work on the construction of the La Farfana Sewage Treatment Plant. We established our subsidiaries, Anam and EcoRiles, and Aguas Maipo S.A. changed its name to Gestión y Servicios S.A.
- 2002 We inaugurated the most advanced Operations Control System in Latin America. We acquired the other 50% of Aguas Manquehue. We initiated the Eureka Plan in order to consolidate an organization network. In addition, we inaugurated the new Sewage Treatment Plants in San José de Maipo and Paine.
- 2003 . The La Farfana Sewage Treatment Plant commenced operations. This is the largest of its type in

- Latin America. We obtained an ISO 9000 on customer service.
- 2004 The Valdivia de Paine and El Monte Sewage Treatment Plant commenced operations in localities. Furthermore, we implemented a new organization model on the SAP platform. We obtained the ISO 9001 certification on invoicing and collections.
- 2005 We obtained the OHSAS certification in occupational health and safety. The Sewage Treatment Plants at Talagante and Curacaví commenced their start-up stage.
- 2006 The Aura Plan was initiated. This gives a new view of the Company and within it, we started the ADN focus on the customer program established to improve the quality of our attention. We inaugurated the Aguas de Ramón Nature Park and began the construction of the Sewage Treatment Plant in Melipilla.

- We obtained the ISO 9001 certification on the process of incorporating new clients into our network.
- 2007 We initiated the construction works on the Clean Urban Mapocho Project on the approval of the Environmental Impact Study. We renewed the ISO 9000, ISO 14000 and OHSAS 18000 for all the sanitation plants and all the scope of their activities, becoming the first sanitation company in the country to receive, jointly, all three certifications on its installations. We carried out the merger of Comercial Orbi II S.A. and Aguas Cordillera S.A., taking a further step in the corporate simplification of the Group.

CHAIRMAN'S LETTER WATER, A VITAL RESOURCE FOR LIFE

On closing the year 2007, I have the honor of submitting for your consideration the Company's Annual Report and Financial Statements corresponding to that period.

Once more we are able to witness that this was a favorable year for the Company. The serious, committed and professional work again proved to be the key to success in our performance.

Just over eight years ago, Aguas Andinas commenced an important modernization process which has become a path towards continuous growth and improvement. Thanks to this, our Company presents a clear orientation to the clients, with a permanent concern for its employees, seeking transparent relations with the authorities, closeness to the community and an improved yield for its shareholders.

In terms of Customer Service, we have achieved important goals. During the period we placed our efforts on the quality of the solutions to requirements and on improved customer attention. For this, we incorporated new tools to the Contact Center, the Web site, the commercial agencies and the operations on-site. With respect to the latter, I would highlight the implementation of the Teseo Project, a process model that has permitted us to raise the productivity of the teams on-site as a result of a more efficient use of resources and a better assignment of the tasks.

With respect to Operations, we raised even further our standards of quality and continuity in the supply of potable water in addition to optimizing our performance. In this way, we reduced the breakage and leaks in our distribution network by 28% in less than 2 years.

As a sanitation company and with a social responsibility, one of our principal focuses is on the environment. Currently we can say, with great satisfaction, that we undertake the treatment of 72% of the sewage generated in the Metropolitan Region, while in 1999 only 3% was purified. This significant increase in coverage has brought clear environmental, sanitary and financial benefits to the country and is part of the Sanitation Plan that we are carrying out.

Thus, the target of treating 100% of our city's sewage becomes increasingly close. During 2007 and once the Environmental Impact Study was approved, we initiated the construction of the Clean Urban Mapocho Project. With this project, we shall give Santiago a face-lift by decontaminating the Mapocho riverbed passing through the capital, just as we did before with the Zanjón de la Aguada and the Maipo River.

Another milestone we must highlight is the ISO 9001, ISO 14001 and OHSAS 18001 international certifications on our sewage treatment plants. This means that all the processes in our sanitation installations are controlled, reducing operating risks to a minimum, caring for the environment and protecting the personal safety of the workers and sub-contractors. In this way, we have taken a further step forward, becoming the first sanitation company to

obtain all three certifications.

Throughout 2007 our non-regulated subsidiaries have played a leading role in terms of growth. EcoRiles achieved an increase of 50% in its income; Anam has tripled its contribution to the Group's results in just two years; and Gestión y Servicios has exceeded its sales target and has signed an agreement with Metrogas to reutilize the biogas generated in the La Farfana Treatment Plant. This is one of the first non-conventional renewable energy projects in the country and becomes an important effort in the development and progress of Chile.

All these actions form part of a continuous improvement in performance and have had a bearing on the Financial Statements for the year 2007, to which I shall now refer.

Total investments for the period amounted to Ch\$39,740 million. Of this amount, 44% corresponded to works related to distribution and production of potable water; 46% to the collection and disposal of sewage; and the other 10% to other activities.

In addition, we closed the period having achieved net earnings of Ch\$97,059 million, representing an increase of 6.8% in relation to the previous period.

In order to consolidate our financial strength, during the first half of the year we carried out another restructuring of our borrowings, improving the maturity curve for the forthcoming years, increasing the duration of the consolidated debt and reducing the Company's financial expenses.

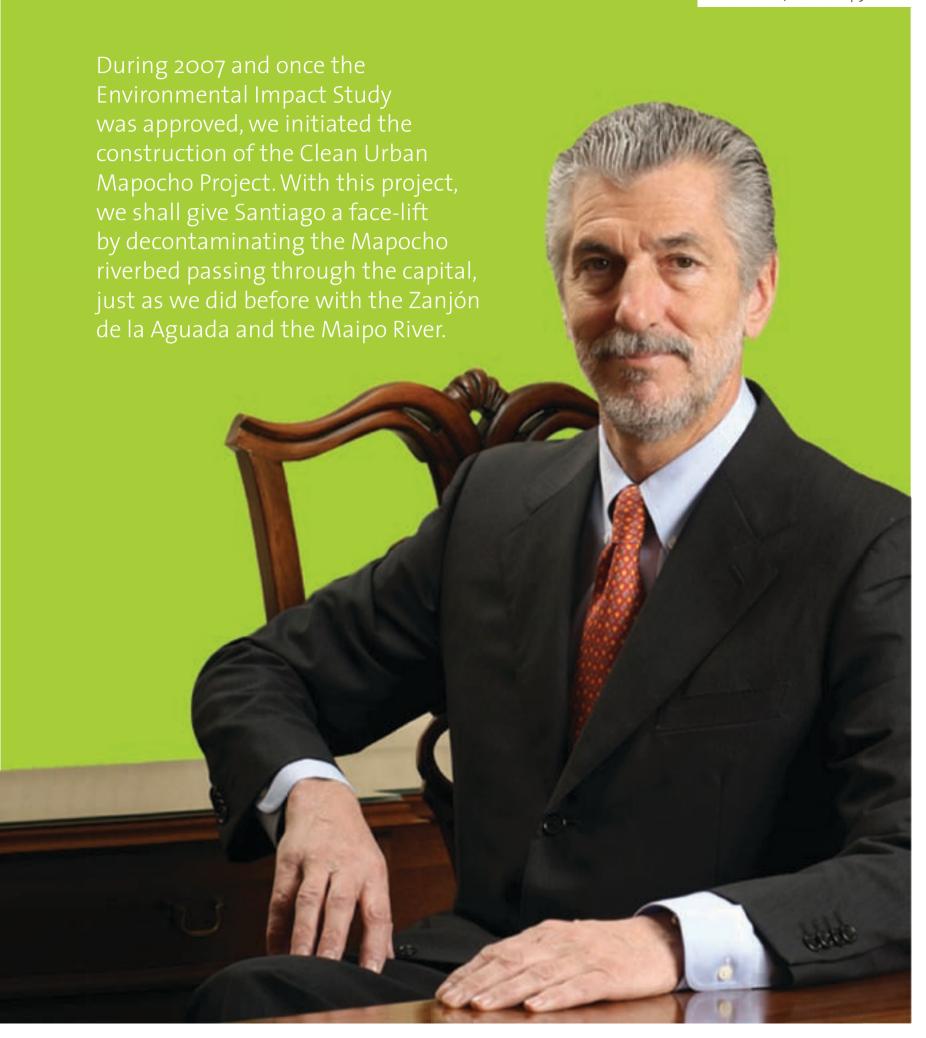
Furthermore, along the lines of optimization, during the period we concluded the various stages of the corporate simplification project.

On closing, I wish to express my gratitude to the Board, the Management, the Shareholders and to our employees for their commitment and dedication. We have all, together, assumed the challenge and objectives of this Company, which are set in our mission to achieve an environment free of contamination and contribute towards improving the quality of life of the inhabitants of Greater Santiago.

I invite you to join this effort to make Aguas Andinas a model of operating efficiency, quality of service and sustainable development.

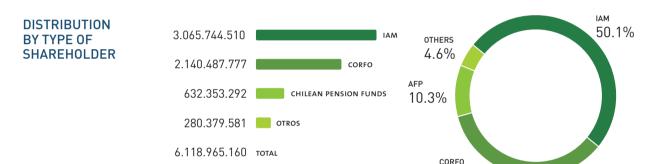

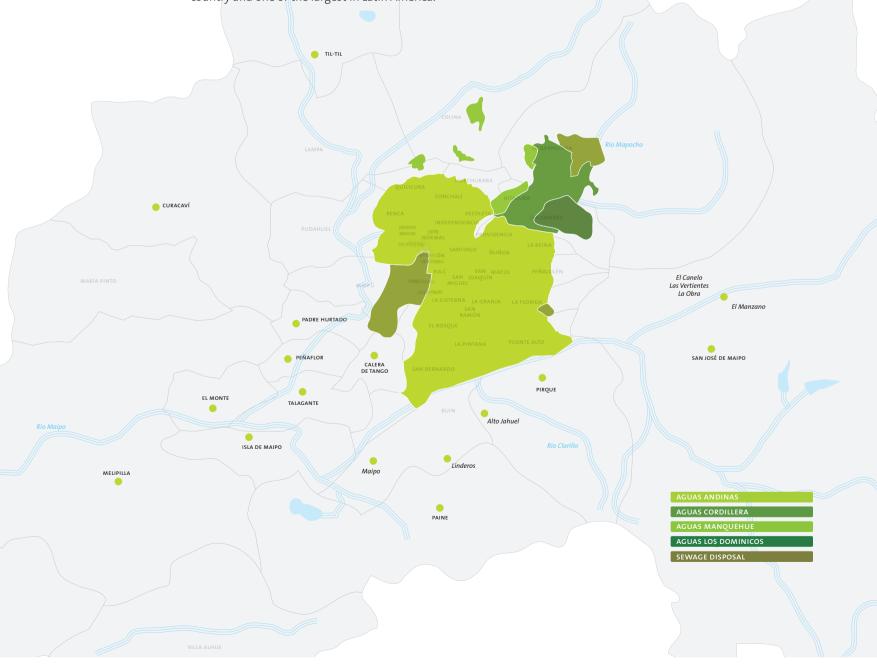


MAP OF COVERAGE IN SANTIAGO AND SURROUNDINGS

In the zone under concession to Aguas Andinas and its subsidiaries we attend close to 1.6 million residential, commercial and industrial clients, supplying sanitation services to more than six million people that live in Greater Santiago and peripheral surroundings.

This makes us the principal sanitation company in the country and one of the largest in Latin America.

The zone under concession covers approximately 70 thousand hectares in the Santiago Basin, which lies on the intermediate depression of Central Chile and borders with the Chacabuco Hill to the North and with Angostura de Paine to the South.

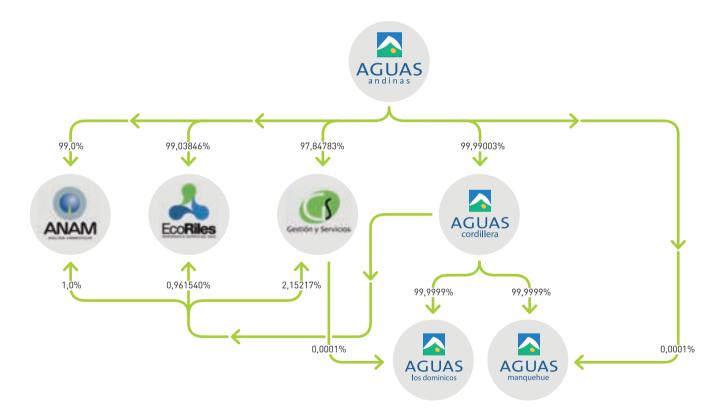


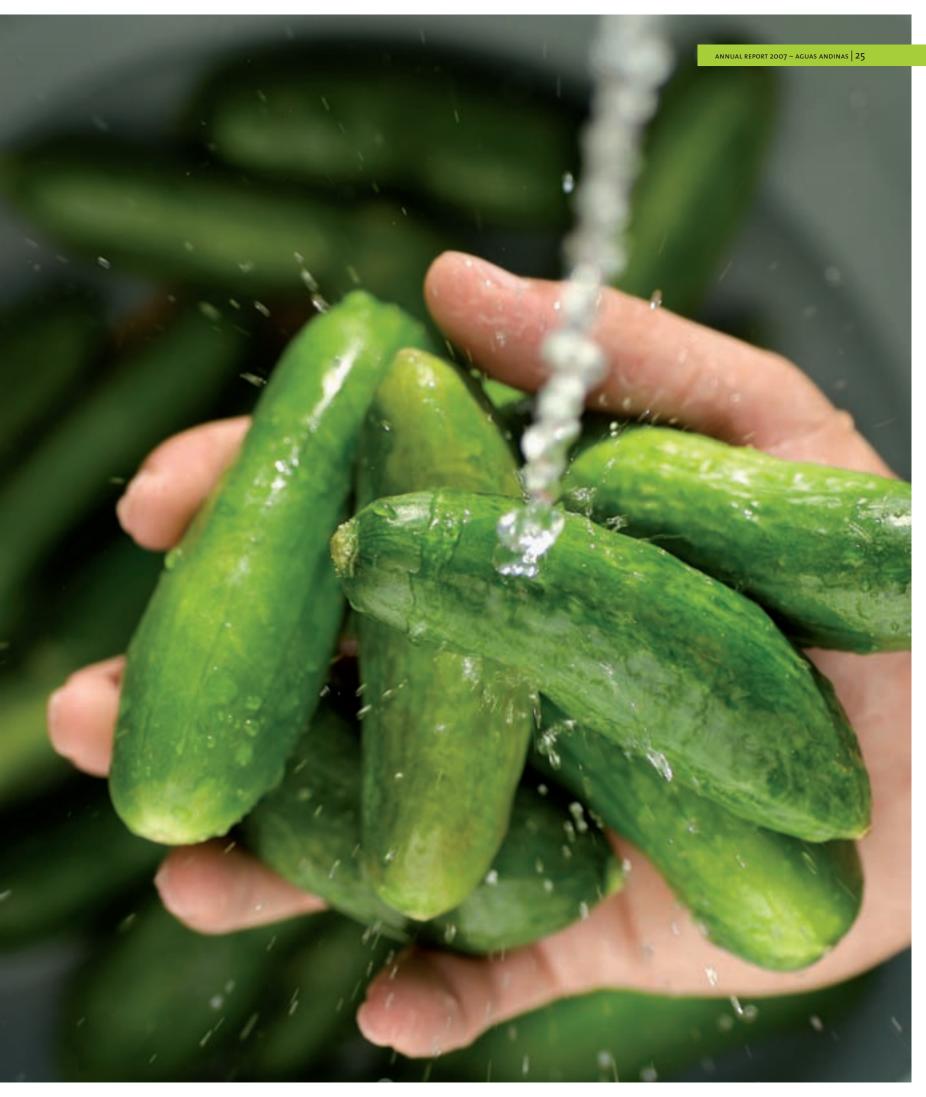
COMPANIES IN THE GROUP FOR AN INTEGRAL SERVICE

Aguas Andinas forms part of the Aguas Group, a group of related companies that provides a comprehensive service within the sanitation industry.

The regulated subsidiaries are: Aguas Andinas, Aguas Cordillera, Aguas Manquehue and Aguas Los Dominicos. Through these sanitation companies, services are provided in the production and distribution of potable water and the collection, treatment and final disposal of sewage.

Through the non-regulated subsidiaries, *EcoRiles, Anam* and *Gestión y Servicios*, the Group provides services related to the treatment of industrial waste, sales of equipment and laboratory analyses, respectively.









YEAR 2007: A FURTHER STEP TOWARDS EXCELLENCE

During the period we have advanced along our path towards providing a faster and better quality of service to our clients, with greater efficiency in the operations, always in tune with a sustainable development.

During 2007 the customer service activities were focused on seeking efficiency and speed in resolving their concerns, incorporating new applications in the channels of communications and operations on-site. Along these lines we implemented the Teseo Project, which permits the optimization of the assignment of on-site tasks required by the clients.

Continuing with the Sanitation Plan to which the Company is committed, during the period the construction of the Melipilla Sewage Treatment Plant was concluded. This project, which implied an investment of Ch\$2,434 million,

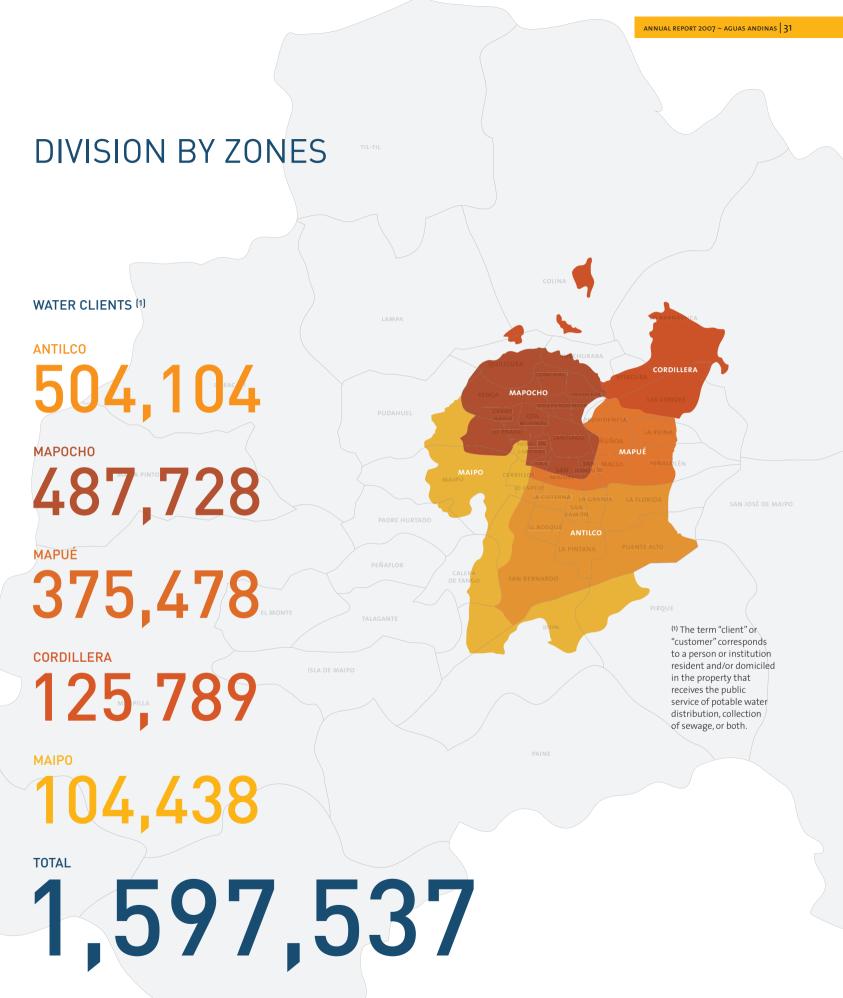
has a capacity of 192 l/s. Furthermore, the Environmental Impact Study was approved for the Clean Urban Mapocho Project. This project will raise our sanitation coverage to 84% by the year 2009 and will become an environmental milestone in Santiago and the country.

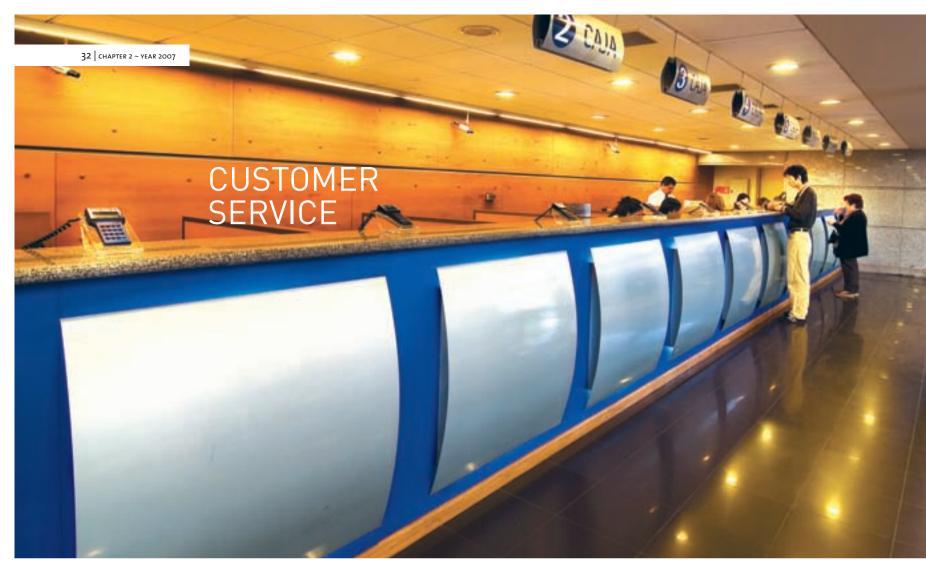
Through our subsidiary, Gestión y Servicios, we participated in a project to supply biogas from the La Farfana Plant to Metrogas, contributing in this way to Chile's energy needs.

During the year 2007 the focus of customer service was placed on the quality of the solutions to the concerns of our consumers, avoiding repetitions and preferably giving the solution in the first line. In fact, during the period, 8.7% of the solutions were given during the first contact.

Furthermore, we incorporated new applications to the commercial agencies, the Contact Center, the Web site and to the operations on-site, with the aim of giving a speedier and more efficient attention. In this way, more than 80% of the transactions carried out in the commercial agencies were automated.

The Web page increased its services and capabilities with the entry of facts and meter readings, permitting clients to know the state of their projects, print certificates and enter meter readings. Furthermore, an original format of a water bill was uploaded to the Web site in order to improve the perception of trust and clarity in the charges for services. Also, information is given on programmed emergency water cuts.

With respect to Fonoservicio, we increased the capability of our telephone operators to provide solutions on commercial matters, permitting them to resolve directly complaints related to consumption and invoicing problems. In order to improve the satisfaction of our customers and to expand the resolution of their concerns, during the first half of 2007 we implemented a new model of a telephone platform that permitted our Contact Center to be placed among the best in the country in terms of efficiency in its

attention. The implementation of opinion polls allowed us to divide the attention into segments, improving considerably our first line resolutions and granting a specialized attention, depending on the type of complaint.

These improvements, centered on human resources and on the attention model, shall be complemented during 2008 with the technological modernization of the Fonoservicio, converting the Call Center into a virtual office with a high problem-solving capability and excellence in its service.

In the collections area, we facilitated the payment of overdue bills through the external network of collectors—with the same payment conditions as in our own agencies—improving the perception of ease and speed in the payment of bills.

With regard to operations on-site, during the period we implemented the Teseo Project, a process model based on the incorporation of modern technologies and optimization criteria that permit an increase in the productivity of the teams on-site by means of improving the assignment of the tasks and a more efficient use of resources. Furthermore, we designed a new model for the attention of requirements from sewage, aimed at speed of attention through a better diagnosis and with more powers to resolve for our operators on-site and agency personnel.

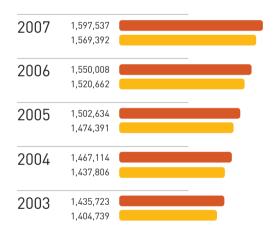
NUMBER OF CLIENTS

As of December 31, 2007 the number of clients of Aguas Andinas with potable water services reached a total of 1,471.748, reflecting an increase of 3.1% with respect to the previous year. In the sewage collection service, the clients rose to 1,445,385, which indicates an increase of 3.2% with respect to 2006.

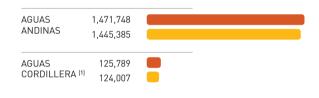
On a consolidated basis, the total number of clients of potable water was 1,597,537 and of sewerage 1,569,392.

Of the total number of potable water clients, 6.8% or 108,674 corresponded to clients with a subsidy, a fact that favors a pattern of stable payments and a lower level of bad debts for the Company.

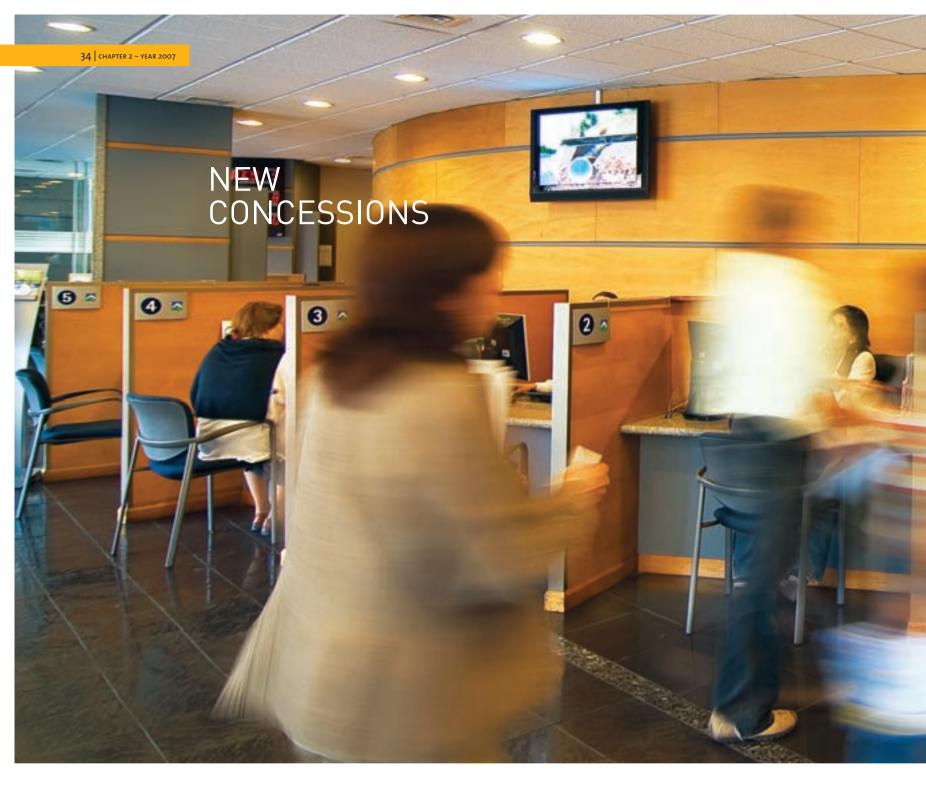
EVOLUTION OF THE CONSOLIDATED AVERAGE CONSUMPTION [2] (M³/MONTH/CLIENT)



AVERAGE CONSUMPTION YEAR 2007 [M³/MONTH /CLIENT](2)







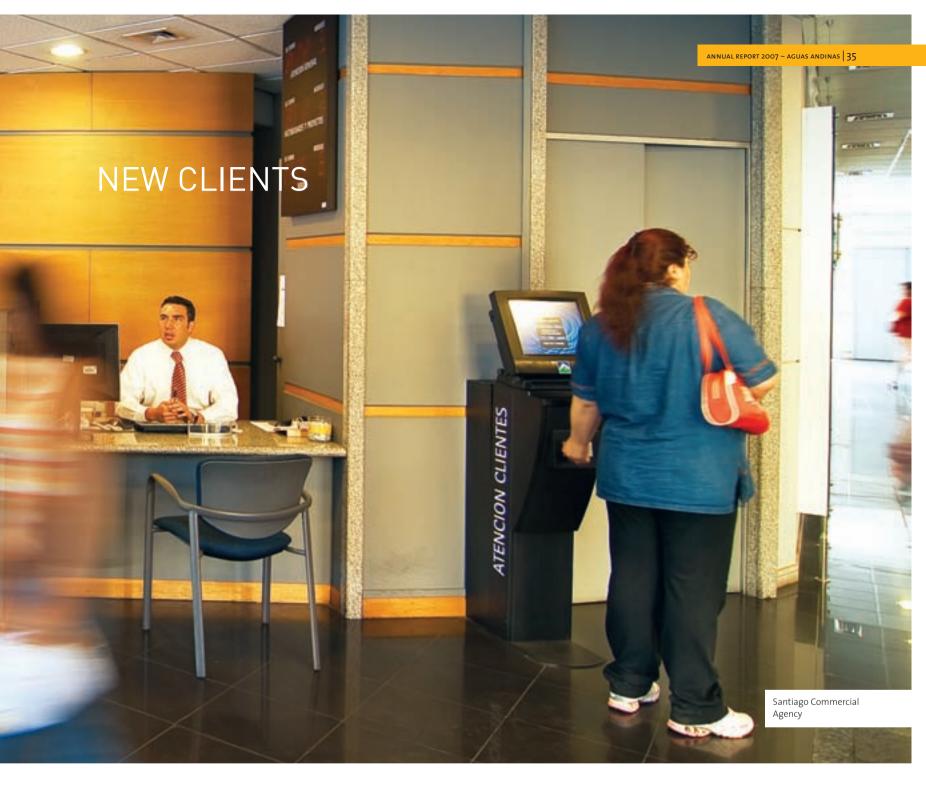
During 2007, our Company had six requests for increasing its concession approved.

The first, called Las Casas de Quilicura III, is located in the municipal commune of Quilicura and has a surface of up to 2 hectares with 70 new clients. The second, named San Javier de la Manana, is located in the municipal commune of Peñaflor and comprises an area of 18.53 hectares with 556 clients. The third, called El Alfalfal, is in the municipal community of Paine and covers an area of 19.84 hectares with 1,006 new clients. The fourth, called Alto del Parque, is located in the municipal commune of Melipilla, with an area of 4.2 hectares and 158 new clients. The fifth, named Villa Hermosa, is located in the municipal commune of Til-Til, with a totals area of 3.1 hectares and 214 new clients. The

sixth, called Los Castaños de Malloco, is in the municipal commune of Peñaflor, with an area of 0.5 hectares and 16 new clients.

Furthermore, still in process are the requests for the enlargement of the concessions in Padre Hurtado, Quilicura, Talagante, Puente Alto and Pudahuel, which jointly comprise a surface area of 163.56 hectares and 7,169 new clients.

In turn, sonce 2006, Aguas Manquehue has processing a request for the enlargement of the Alto Lamp concession in the municipal commune of Lampa with a surface area of 324 hectares and with 7,797 new services.



Throughout 2007, we have strengthened our relationships with real estate and construction companies and private individuals and potential new clients that require a connection to our networks.

Along these lines, and thanks to the evaluation of the Processes of Aguas Andinas' New Services undertaken by the DICTUC, we developed a model of integral attention that permits us to attend, in a centralized manner, the ten largest real estate companies in Santiago, from the feasibility study to the delivery of the final installation.

During the year, 8,475 water and sewerage projects were processed with the incorporation of 47,529 new clients. Furthermore, 25,491 new sanitation services feasibility certificates were issued.





RURAL POTABLE WATER

In virtue of the agreements signed with the Hydraulic Works Directorate of the Ministry of Public Works, Aguas Andinas participates in a Plan for Rural Potable Water, through training and consultancy on the maintenance and execution of works in remote areas where potable water networks are inexistent.

Thanks to the Plan for Rural Potable Water, 41,485 homes have benefited. These homes comprise an estimated population of 248,910 inhabitants reaching a coverage of 100% of the concentrated rural localities.

In 2007 investments of close to Ch\$ 1,110 million were arranged, principally in contracts to construct improvements or enlargements of services and in carrying out new projects to improve services.

SANITATION REGULATIONS

TARIFFS

In Chile, the current legislation establishes that the providers of sanitation services are subject to the supervision of the Superintendence of Sanitation Services (SISS). This entity is a decentralized service, with autonomy and its own equity, subject to the supervision of the President of the Republic through the Ministry of Public Works.

Furthermore, there are several regulations and laws that regulate the sector and the sanitation companies.

The principal applicable laws are:

General Law on Sanitation Services (Decree Law MOP No. 382 of 1988). This contains the principal provisions that regulate the treatment of concessions and the activities of the providers of sanitation services.

Regulation of the General Law on Sanitation Services (Decree MOP No. 1199/2004, published in November, 2005). This establishes the norms that permit the application of the General Law on Sanitation Services.

Law on Tariffs for Sanitation Services (Decree Law MOP No. 70 de 1988). This establishes the main provisions that rule the setting of tariffs for potable water and sewerage and the reimbursable financing contributions.

Regulation of the Law on Tariffs for Sanitation Services (Decree MINECON No. 453 of 1990). This contains the norms that permit the application of the Law on Tariffs for Sanitation Services.

Law that creates the Superintendence of Sanitation Services (Law No. 18.902 of 1990). This establishes the functions of the SISS.

Law on the Subsidies of the payment of the consumption of potable water and sewerage services (Law No. 18.778 of 1989). This establishes a subsidy on the payment of the consumption of potable water and sewerage for low-income clients.

Regulation of the Law on Subsidies (Decree HACIENDA No. 195 de 1998). This contains the provisions for the application of the Law on Subsidies.

During the year 2007, the prices charged for products on providing regulated services to our customers were updated in accordance with the procedure established in the respective tariff decrees.

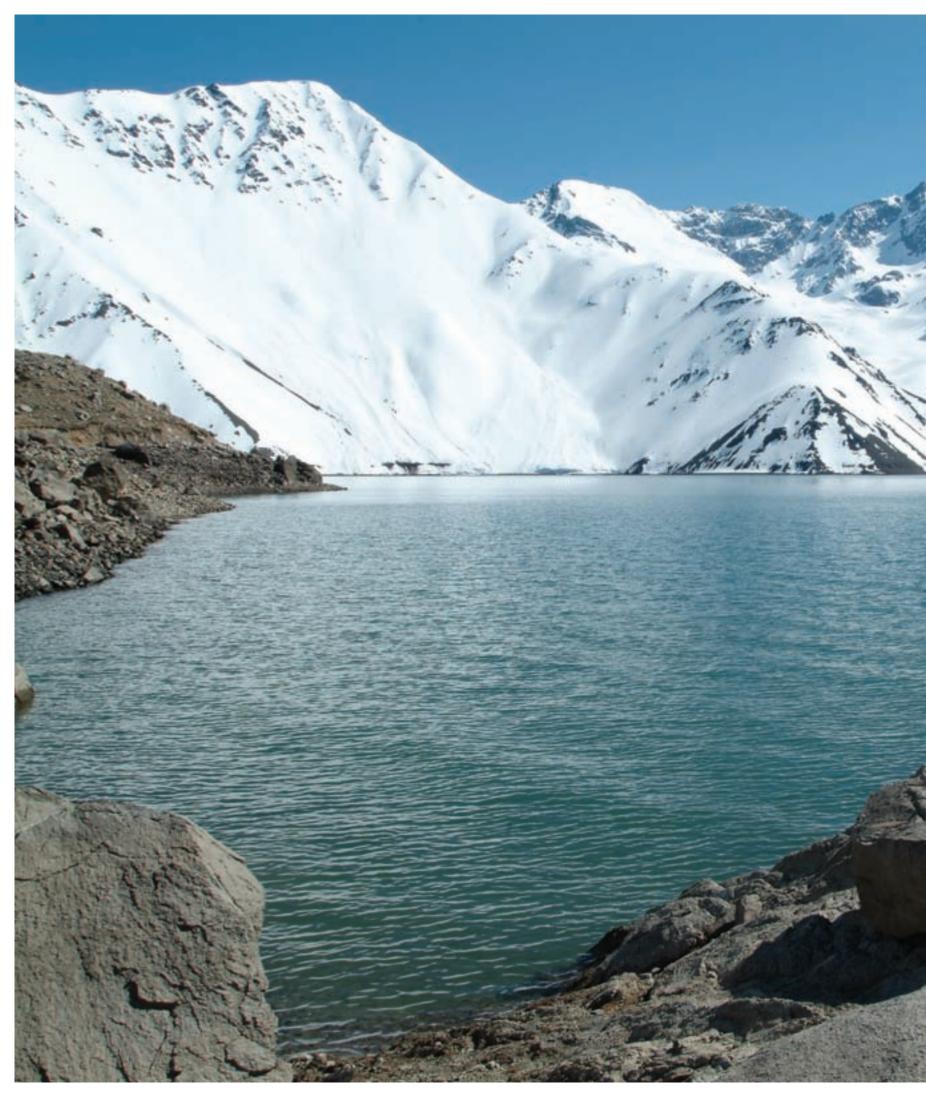
AVERAGE TARIFF YEAR 2007 (WITHOUT VAT, IN CH\$/M3)

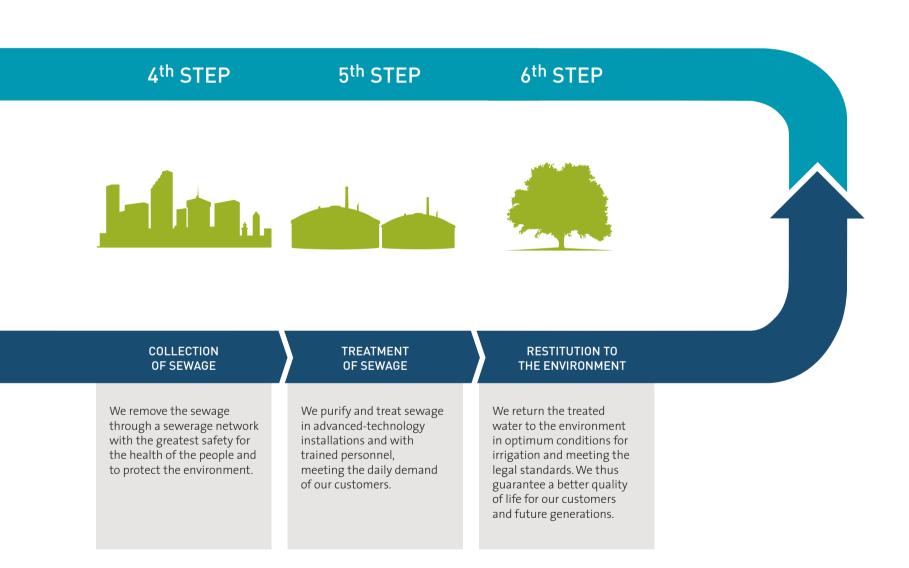
WATER CYCLE



WATER CYCLE AN INTEGRAL MANAGEMENT

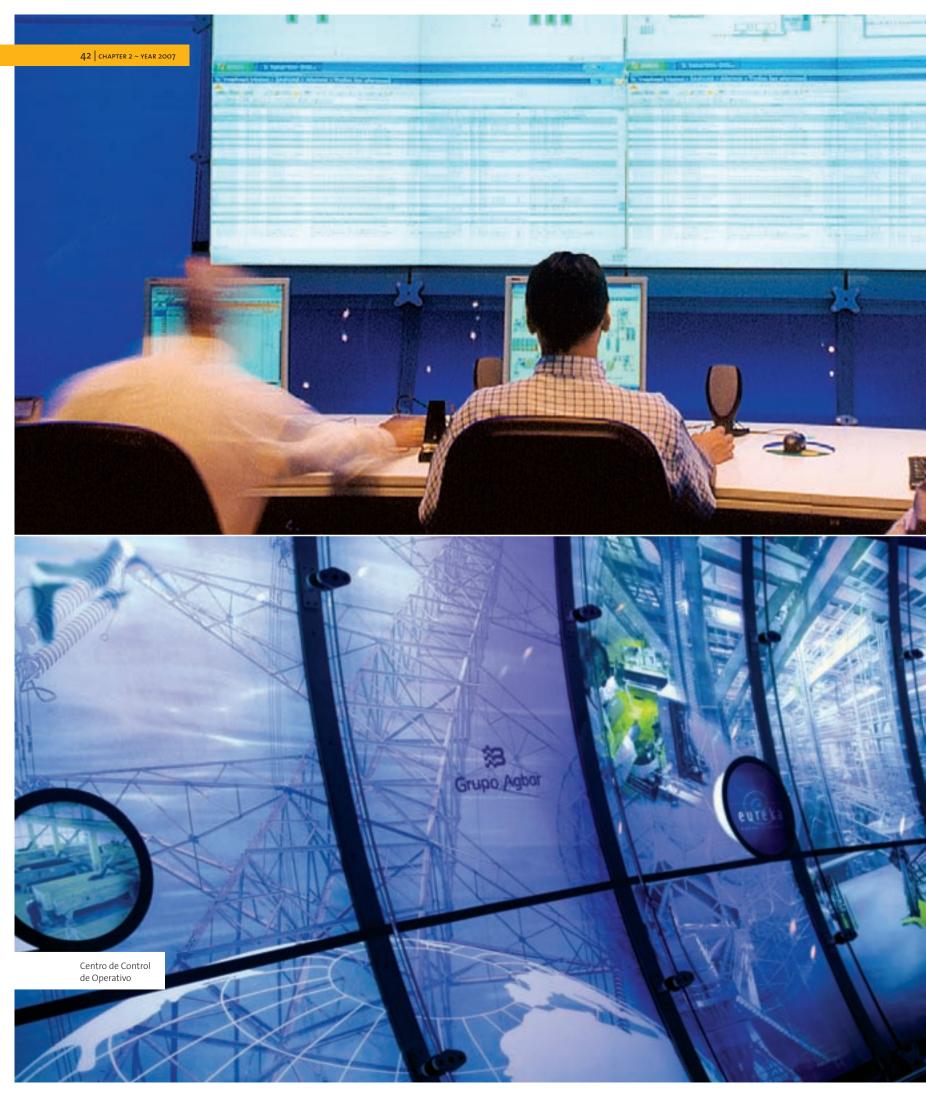


In Aguas Andinas we carry out the entire water cycle, which implies executing a correct and efficient operation of all the processes related to the sanitation services. To achieve this commitment we are backed by our professionalism and track record.











OCC IN PERMANENT GROWTH

The Operations Control Center (OCC) is the hub of the Company's operations. This tool, with the latest technology, operates 24 hours a day, 365 days a year, gathering in real time information on the operations, centralizing decision taking and optimizing the control of the water cycle.

In this way, we are able to guarantee and provide a quality service to more than 6 million inhabitants, managing a 23,500-kilometer network, distributed over an area of 650 square kilometers.

During the year 2007 the coverage of the Operations Control Center continued to expand, incorporating 8 thousand new variables to its Software for the Control and Acquisition of Data (SCADA), one of the large applications in the world in the public services sector.

The growth of OCC involved all the concessions. In Production and Distribution, the tele-controlled operation for underground water infrastructures, such as the new wells in Trapenses and Quilicura was implemented; we continued to improve the Potable Water Elevating Plants; and we incorporated new pumping stations such as the one in San Carlos Centro in the eastern sector and Quilín 3 in the southern sector of Greater Santiago.

In Sewage Collection, we added Aguas Manquehue's Piedra Roja and Aguas Andina's El Maitén Elevating Plants. In Treatment and Disposal we incorporated the supervision of the Curacavi, Talagante and Chamisero treatment installations.

Due to the current size of the OCC and its importance in the operations of the Company, we have started working on the design of an Alternative Control Center that will permit us to face contingencies in the event of a failure of the principal Control Center. This project is expected to be ready during 2008.

GEOGRAPHIC INFORMATION SYSTEM

Aguas Andinas has a modern database with a register and description of its infrastructure. This is called the Geographic Information System (GIS). This system controls the geographic positioning of all our potable water, sewage and client networks located on the basis of an urban map covering the whole of the Company's area under concession. Thus, this has become one of our principal sources of information for our daily operations, customer attention, planning, engineering and regulatory authorities.

A series of process modules have been developed on its platform. Among them: cuts and failures in the supply of potable water, fire hydrant maintenance, cleaning collectors, crisis management and Teseo for improved customer attention. GIS's other functions include the incorporation of high-resolution satellite images, aerial photography with laser technology, AVL-GPS technology for monitoring the fleet attending the domestic potable water networks and industrial Tablet PC for the operation of the large potable water networks

The efforts made in 2007 were focused mainly on improving the database in order to have more and better information in time for the next tariff process.





IMPROVEMENTS TO THE SYSTEMS AND TELE-CONTROL

RESEARCH AND DEVELOPMENT

In the Systems and Tele-control area we carried out the Teseo Project that permits us to optimize the assignment of the tasks on-site required by the clients. This system integrates the geographic information of the requirements with the availability and position of the teams and, according to a model of optimization, assigns the tasks. Furthermore, it permits the registration from the site of the work performed, leaving this information available on the central system, thus giving a better service to the clients.

Furthermore, we developed a project to provide on-site, information on the Company's networks on the Geographic Information System. For this we have supplied the staff on-site with robust computers that are on line to the central system via wireless Internet.

Continuing along the lines of modernization and efficiency, during the period we introduced more automated enquiry terminals in the commercial agencies, permitting our clients to rapidly obtain a copy of their bills and/or to arrange payment terms. Furthermore, we introduced supervision via Internet of the automatic system of control of the potable water network and of the register of operations. We increased the Wi-Fi network in various operating and production installations in our Company, enabling our operators and personnel to connect directly through their personal computers in different working areas. Also, we changed the corporate electronic mail platform.

Furthermore, in 2007 we participated in the IFRS Project, which, as of 2008 will generate from the SAP the information required for the financial statements under the new regulations.

With respect to the sewage treatment plants, we finalized the model of anaerobic digestion initiated in the year 2006, which has become a tool to support the operation and control of the digesters in the sewage treatment plants.

In addition, we concluded the construction of three scale-model reactors which have permitted us to carry out numerous experiments, achieving greater know how on the functions of the digesters and contributing valuable information when taking decisions on the influence of biosolids and of possible inhibitors or operating changes at the digestive stage.

These works, which have been carried out with the support of the Universidad Católica de Valparaíso and which have permitted us to be present in important local and international seminars, reflect the commitment of Aguas Andinas to research and development, fundamental pillars for the comprehensive water cycle activity and to guarantee the service provided to our customers.







During 2007 we continued with the development of the General Plans for Aguas Andinas, the principal purpose of which is to detect possible structural and functional deficiencies in order to, subsequently, propose solutions in advance.

During this period we updated the General Plan of Networks, which establishes the medium and long-term planning of the works required in order to adequately distribute the potable water in the Santiago Basin.

Furthermore, we prepared Hydrogeological Studies in the Quilicura and Los Trapenses zones with the purpose of establishing exploitation limits and projections of quality of underground waters which present a greater vulnerability in quantity and quality, respectively.

Also, we made modifications to the investment chronograms in the Development Plans which were approved by the Superintendence of Sanitation Services (SISS).

During 2007 the Company's plan of investments amounted to a total of Ch\$39,740 million, with Ch\$39,087 million corresponding to investments in sanitation subsidiaries and Ch\$653 million corresponding to investments in non-sanitation subsidiaries.

The majority of the resources were directed at potable water installations, an amount of Ch\$17,454 million. Of these, Ch\$11,805 million were invested in distribution works, particularly in the permanent renewal of potable water networks, with a total of Ch\$5,943 million. In production and transport, the more significant projects were the works for the supply of potable water to the northern zone of Santiago which implied Ch\$1,784 million; and the change of decantation modules in the Antonio Tagle Sewage Treatment Plant at the Vizcachas Complex, with an investment of Ch\$886 million.

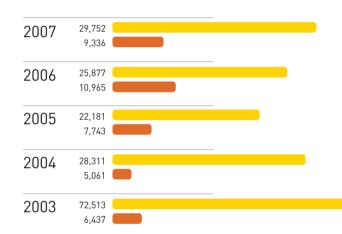
The works on the disposal and collection of sewage involved Ch\$18,113 million, with Ch\$9,183 million invested in sanitation, in particular, the conclusion of the Melipilla Sewage Treatment Plant that implied Ch\$2,434 million, and the Til Til Sewage Treatment Plant, with Ch\$1,135 million.

A total of Ch\$8,929 million were invested in sewage collection installations and directed at projects involving the permanent renewal of sewage works that implied Ch\$3,595 million; works on the North collector with an investment of Ch\$1,488 million; piping works from Cexas to the Esmeralda Sewage Treatment Plant for Ch\$1,348 million; and the Mapocho Interceptor, with an investment of Ch\$1,135 million.

On a consolidated level, 65.1% of the investment plan of the Company corresponded to an investment in expansion involving resources for Ch\$25,883 million.



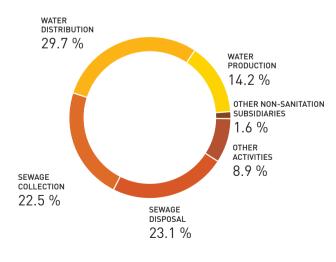
INVESTMENTS (CH\$MM)

We collect water resources to produce sufficient potable water and to satisfy the demand of nearly six million people in the Metropolitan Region.

SOURCES, RESERVES AND PLANTS

The Maipo and Mapocho rivers are the principal sources of raw water for Aguas Andinas, while the natural aquifers that cross our concession area comprise the secondary source.

As a way of ensuring supply when water becomes scarce, the Company maintains important reserves that provide additional water resources. Among these, the more important ones are:The El Yeso reservoir, with an operational capacity of 232 million m³; Laguna Negra, with 600 million m³; and the Lo Encañado Lake, with 50 million m³.

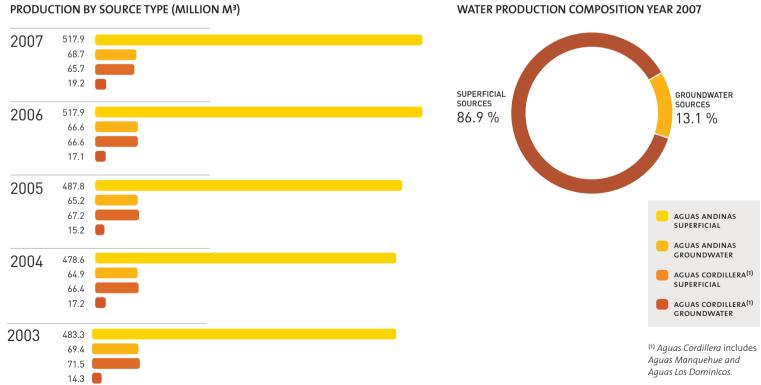
The potable water production plants have the task of purifying this essential resource. In order to carry out this mission, the Company possesses the Las Vizcachas Complex with a maximum production capacity of 15 m³/s which represents over 50% of our total production. The second largest installation is the La Florida Potable Water Production Plant which has a capacity of 4 m³/s, producing close to 18% of the total.

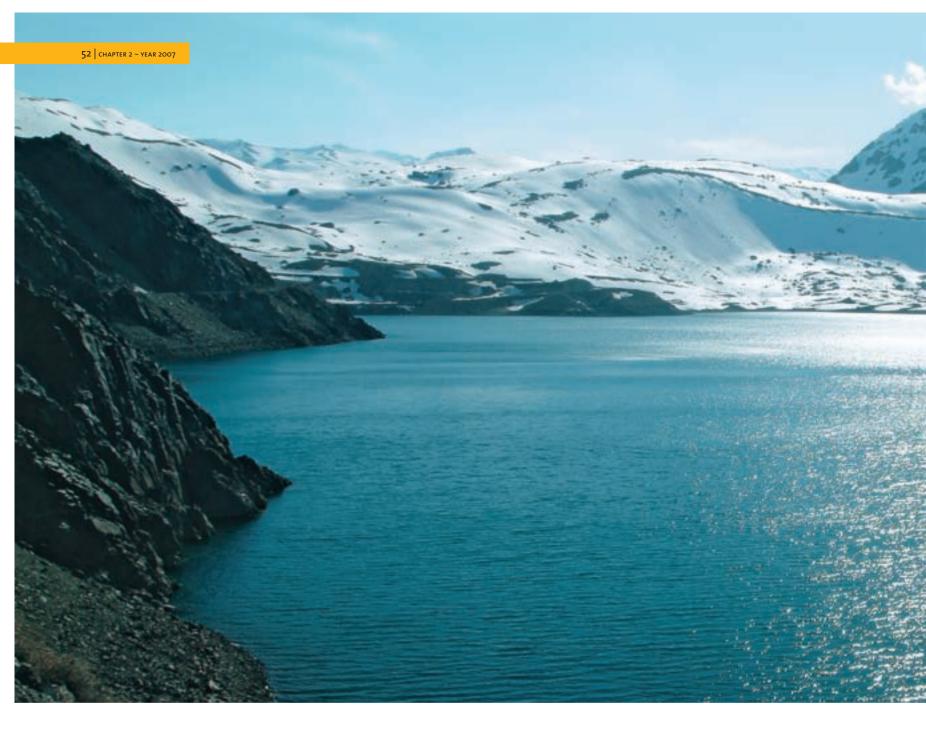
In addition, there are a further 12 installations of a smaller size, with the main ones being: Padre Hurtado, Lo Gallo, San Enrique and El Sendero Plants.

PRODUCTION BY TYPE OF SOURCE

During the period, the Company's total production of potable water, measured on leaving the plant, was 671.6 million m³; with 583.6 million m³ corresponding to surface waters and 87.9 million m³ to groundwaters.



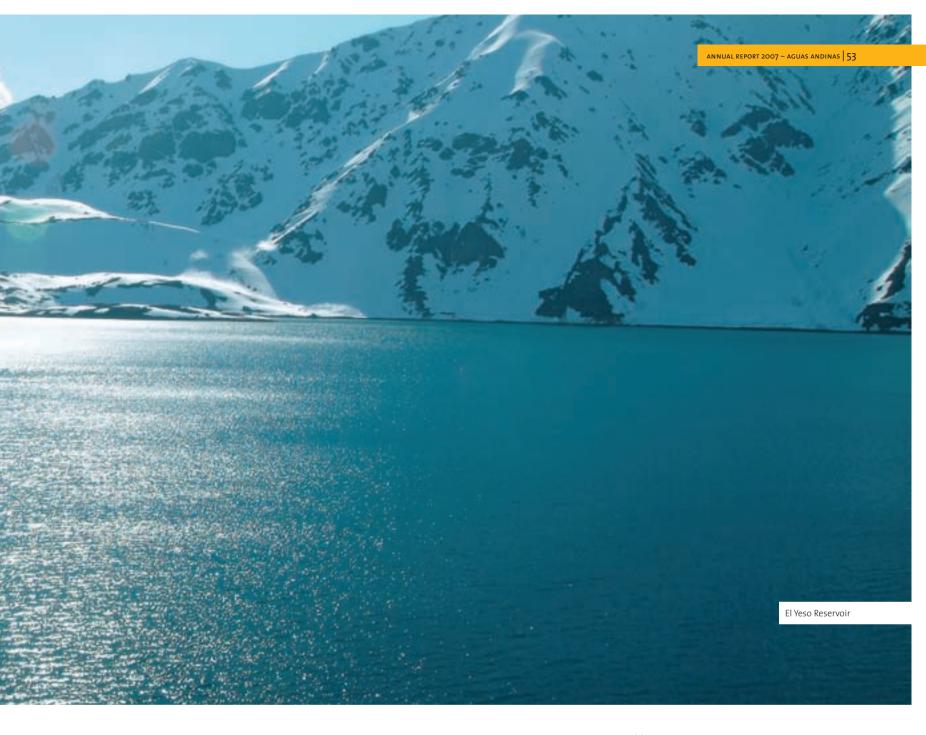




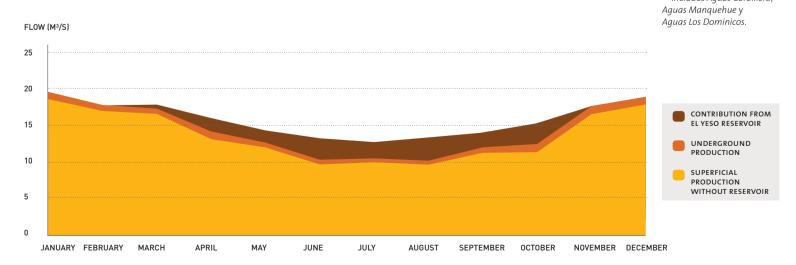
EL YESO RESERVOIR

Aguas Andinas' production of potable water counts on an important support, the El Yeso Reservoir. This great work of infrastructure has a capacity to reserve 232 million cubic meters, which allows us to regulate the contributions coming from the surface sources, even in times of drought, ensuring supply.

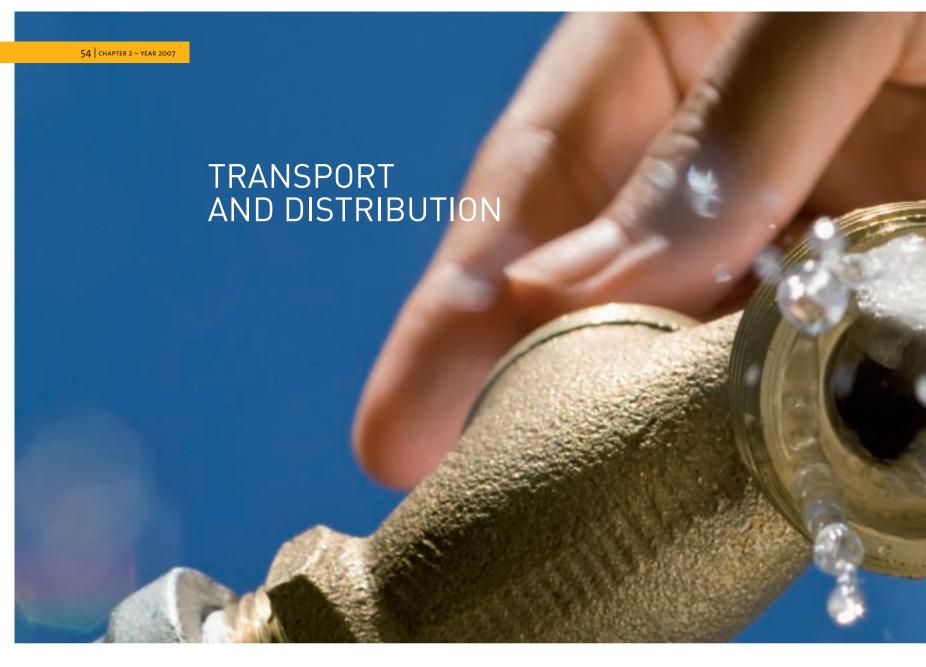
In order to maintain its installations in good shape and protect its useful life and reserve capacity, the Company makes regular investments in its infrastructure.

More than 12,500 kilometers of underground piping allow us to provide a continuous service to all our clients.

Our large potable water distribution network has the mission of providing a continuous supply, with the necessary precision, to the nearly six million inhabitants of the Santiago Basin.

This mass of piping, with its route coinciding with that of the streets, is permanently monitored by the Operations Control Center to ensure its correct functioning and to guarantee the distribution of the supply.

During 2007, the length of the distribution network grew by 1.3%, or 163 kilometers, reaching a total of 12,596 kilometers.

POTABLE WATER OPERATION

The potable water operation is carried out through a comprehensive function supported by a coordinated job and with centralized information. The objectives are to optimize the global operation, maintain an efficient control over costs and give priority to investments from the technical and financial viewpoint.

By virtue of the compliance with these guidelines, we have adequately confronted the crisis provoked by external events and we have improved the financial and technical efficiency of the Company, guaranteeing the supply with continuity and quality.

NEW NORMS ON QUALITY

The ever increasingly demanding international norms on the quality of drinking water have been reflected by the new norms on quality for the supply of drinking water in Chile, NCh 409. Our Company has successfully exceeded their



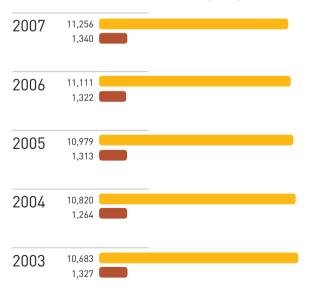
implementation as we have the structure and procedures necessary to reach the indexes stipulated in the norm.

WATER INFRASTRUCTURE AND NETWORKS

Year 2007 meant the definite consolidation of our Model for Managing Infrastructure and Networks. The information from empirical data on the state of the network issued by the Network Laboratory, together with complying with the policies on investments and renewal, have produced such results as minimal breakages in our general distribution network.

Thanks to the model we have evidenced a drastic reduction in failures to levels below 0.1 faults/km, an index well below those accepted as excellent by the large sanitation companies in the world. In particular, the reduction in breakages, a figure that has fallen some 27% with respect to the year 2005.

SEWAGE COLLECTION

We transport the sewage to the treatment or final disposal facilities using a network of more than 10 thousand kilometers.

One of the functions of the underground collection network is to avoid any direct contact between people and the sewage, preventing contagion and problems with contamination.

In order to keep up its correct operation and functioning, in the year 2007 we carried out periodic programs of improving the network, renewing or restoring 9 thousand meters of ducts in different sectors of the sewerage. Furthermore, we inspected the quality and quantity of the sewage in the various river basins by implementing a measuring network.

Thanks to the Program of Preventative Maintenance, we cleaned more than 1,167 kilometers of collectors utilizing high technology hydrocleaning trucks. This activity was complemented with the execution of an inspection of a total of 125 kilometers of ducts, utilizing a television camera and, in this way, being able to count on a diagnosis complementary to the operations and maintenance activities.

Another important aspect to consider was the application of the entire Norm on Emission of Discharges to the sewerage system (D.S. MOP 609/98), for which we intensified our controls over industrial waste, carrying out more than 2,940 monitoring exercises and 210 inspections.

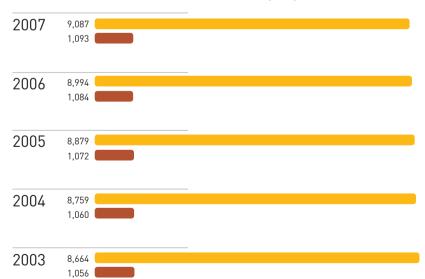
These programs fall within our commitment to have a complete sewage collection network in anticipation of our customer's requirements and to safeguard our infrastructure.

During the year 2007, the sewage collection network of Aguas Andinas grew by 102 kilometers, now totaling, on a consolidated basis, a length of 10,180 kilometers.

SEWAGE TREATMENT

In 1999, only 3% of the sewage of the Metropolitan Region was treated. Following an important plan of investments undertaken by Aguas Andinas, we are currently treating over 72%.

Thanks to the technology incorporated into our sewage treatment plants, it is possible to purify the residual waters permitting their return to the environment in optimum conditions for irrigation.

Currently, and thanks to the functioning of two large treatment plants - El Trebal and La Farfana – plus another 9 installations in the surroundings and 3 belonging to the north-eastern zone of Greater Santiago, the Aguas Group treats more than 72% of the sewage generated in the Santiago Basin.

During 2007, the La Farfana Sewage Treatment Plant, which has a purifying capacity of 8.8 m³/s, decontaminated 219.7 million m³, corresponding to sewage generated by close to 3.3 million inhabitants. El Trebal, which has a purifying capacity of 4.4 m³/s, decontaminated a total of 106.2 million m³, corresponding to a population estimated to be 1.7 million people in the south, southwest area of Santiago.

Thus, during the period, a total volume of 355.5 million m^3 of sewage was treated.

IN SUBURBS

There are currently 9 treatment plants operating normally in suburbs, with a joint purifying capacity of over 750 liters per second. During 2007, the volume of sewage decontaminated in these localities exceeded 27 million cubic meters, thanks to our permanent commitment to sanitation coverage in the entire Santiago Basin.

PROGRESS ON THE SANITATION PLAN

During the course of 2007 significant progress was made on Aguas Andinas' Sanitation Plan. Among the advances made we would highlight the construction of the Melipilla treatment installations – with a capacity of 192 l/s and that of Til Til which has a capacity of 11 l/s. Both plants initiated their start-up during the first months of 2008, replacing the operations of the old Cexas, Esmeralda and Los Olivos treatment plants. Also during the period, the Buin Maipo Sewage Treatment Plant came into operation with a purifying capacity of 137 l/s.

Furthermore, we carried out projects on improvements in the La Farfana Sewage Treatment Plant which included sifting sludge, deodorization, automatic loading and installation of neutralization of chlorine gas. The aim of all these improvements is to comply with Resolution on Environmental Rating 130/06 and, in addition, optimize the security conditions in the plant.

During 2007, the Environmental Impact Study of the Clean Urban Mapocho Project was approved. This project, which represents an investment of around 92 million Dollars and includes the closure of the 21 pipes that currently pour sewage into the Mapocho River's bed, will permit us to raise our sanitation coverage to 84% in the year 2009.

Finally, we obtained the approval of the Declaration of the Environmental Impact of the Project to Optimize and Improve the Operations in the El Trebal Sewage Treatment Plant

TREATMENT OF BIOSOLIDS

Conscious of the importance of a correct handling of biosolids, the Company is permanently exploring alternatives for their reutilization and beneficial use. Thus, during 2007 Aguas Andinas developed a line of action in order to optimize the use and procedures of the drying field in the El Trebal Sewage Treatment Plant by means of the implementation, on an industrial scale, of a novel process of biodrying. This process permits the complementation of solar drying during the months of low temperatures, improving the evaporation capacity and minimizing the emissions around the plant.

Furthermore, we continue studying and promoting the agricultural use of biosolids and we continued with the





Environmental Impact Study and the Master Plan of the El Rutal Comprehensive Use of Biosolids Center.

OTHER ACHIEVEMENTS IN TREATMENT

During the period we carried out a series of plans to maintain our high standards of quality in providing our treatment services, which represent pioneer applications in companies in the sanitation sector. Among these we would mention the renewal of the certifications on quality (ISO 9000), environmental protection (ISO 14000) and prevention of occupational risks (OHSAS 18000) for all the sewage treatment plants and for the entire scope of their activities. This makes us the first sanitation company in the country to have received, jointly, all three certifications for its purifying plants.

In addition, we incorporated the certification for quality in maintenance in the treatment process and we broadened the scope of the three certifications to cover the new installations in Talagante and Curacaví.

In research, we undertook projects related to the process of anaerobic digestion of sludge with the cooperation of the Universidad Católica de Valparaíso. These lines of research have allowed us to be present and to share experiences at important local and international conventions.

Finally, we implemented non-invasive tools and practices for maintenance at the plants which have permitted the optimization of the availability of their equipment, increasing their operating reliability. Among these new practices we would point out the determination of hot points through thermography, measurement of the conditions of oil and the analysis of vibrations in principal equipment.

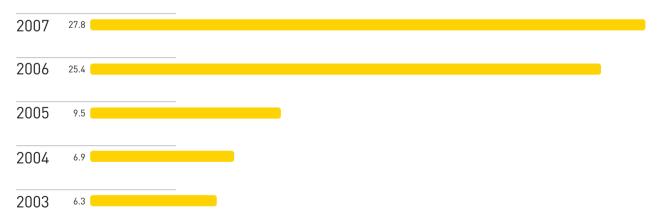

HUMAN RESOURCES THE KEY IN OUR ORGANIZATION

The professional and personal development of our workers is one of our principal concerns as a Company.

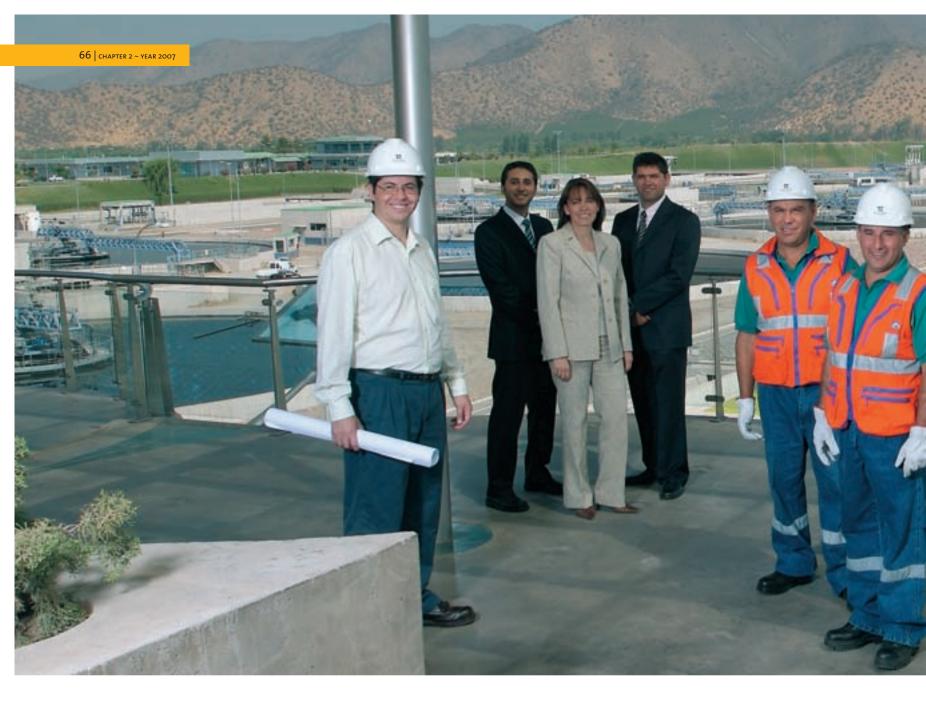
During the year 2007, we took important steps for the welfare and health of our workers. Among these, we would highlight the Plan for the Improvement of Safety, Order and Image in the Company's water and sewage operating premises. We also undertook a self-care campaign called "Wake your senses" and we carried out a program for knowledge, dissemination, training and control of the application of Law N° 20,123 on Sub-contractions in all our Company's contracts.

FORMATION, DEVELOPMENT AND TRAINING

Throughout this period, the development of our human capital was strongly orientated towards fomenting relationships with our workers. Thus, we implemented a program called "Focus Workers" which covered the entire organization in different training processes: leadership skills for the executive level; effective communications and development of people for sub-managers; training and specialization programs for skilled workers; and the inclusion in the Performance Evaluation system of all the administrative staff and operators. In this way, we trained 85% of the workers in an effort that implied more than 40 thousand hours of training.

The "Crecer" Development Program system covered all the different levels in the organization, including 12 administrative staff and 275 operators. Furthermore, we managed to consolidate our policy of internal mobility with 46% vacancies occupied with our own staff.

We also went ahead with a plan to renegotiate personal debts called "Personal Finances", offering all our employees a bank agreement at preferential interest rates, which 50% accepted. During the year we also renegotiated a health plan with the Health Plan Provider with most members from our organization which included all the employees.

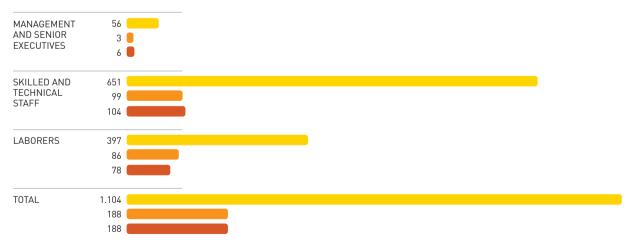
As of December 31, 2007 the staff complement of Aguas Andinas was 1,103 employees. On a consolidated level, the complement amounted to 1,480 workers.

COMMUNITY WALKING TOGETHER

For Aguas Andinas, social responsibility is backed by actions that permit the generation of value and progress for the community in which we are inserted and for society in general.

GOOD NEIGHBOR POLICY

The Good Neighbor Policy was initiated in 2005 in order to establish a channel of communications directly between Aguas Andinas and the residents close to its sewage treatment plants, mainly the neighbors of La Farfana, El Trebal and Montenegro (Til Til).

In this way, we have been able to incorporate the communities in the search for environmental and social solutions. Furthermore, we have strengthened relationships of confidence and collaboration based on knowing each other, the development of capabilities and strengthened leadership. In addition, we have provided special training to workers and sub-contractors in order to teach them to relate in a better fashion to the community.

One of the activities carried out during the year under the Good Neighbor Policy was the Working Tables with the object of detecting the principal concerns and problems of the neighbors of our installations – generally of the treatment plants – in order to be able to solve them through intervention plans and common development projects. The Working Tables count on the participation of neighborhood associations, community organizations, representatives of the municipal district, the Company and the Casa de la Paz and the Corporación para el Desarrollo Sustentable organizations.

The Working Tables held in the municipal communes of Pudahuel, Maipú, Til Til and Padre Hurtado, permitted the analysis of impacts, definition of responsibilities in common and the development of mutual collaboration projects such as educational programs related to the water cycle.

"NEIGHBORHOOD DREAMS" FUND

This entity, which organized the event for the second consecutive year, provides social funds which are bid for, to the communities close to the main purifying installation, La Farfana

Its aim is to contribute resources for environmental, social and cultural projects with the object of improving the quality of life of the neighbors, strengthen citizen participation in local environmental matters and promote territorial projects for the management and conservation of the environment.

Those that have benefited from this are various neighborhood associations, women's, sports, youth and cultural organizations, among others – which were invited to participate directly by the Company.

During the year 2007, 36 projects were submitted from which 16 were selected, four from Maipú and 12 from Pudahuel.

PRO TIL TIL CORPORATION

Another activity within the Good Neighbor Policy was the creation of the Business Sector Corporation for the Development of Til Til, known as "Pro Til Til". The object of this corporation is to contribute to the sustainable development of this municipal commune, promoting the generation of projects related to education, the environment, the development of small businesses, health and culture.

The organization was created by seven leading companies in the area, among which is Aguas Andinas.

COMMUNITY PROGRAMS

More than 75 participants were present at the water cycle educational programs and some 17 thousand people benefited from our getting closer to the low-income zones, thanks to a joint work with municipal communes and neighborhood organizations. This has permitted, with a focus on efficiency, 88% attendance by the neighbors from key zones.



GUIDED TOURS TO THE AGUAS DE RAMÓN NATURE PARK

During 2007 we initiated the program of guided tours to the Aguas de Ramón Nature Park, inaugurated in December 2006, permitting more than 1,000 people to visit the park and walk along its pathways, receiving on-site education on the environment, inique in this region.

The Aguas de Ramón Nature Park, is an area of 3,300 hectares of Andean foothills, located between the municipal communes of Las Condes and La Reina. The aim of this park is to foment the conservation of nature, scientific research and environmental education of the current and future generations.

On the site, ceded in commodatum by CORFO (The Chilean State Development Corporation), Aguas Andinas jointly with the Protege Association of Municipalities, set up a modern Center for Environmental Education and Information that will permit people to have a virtual view of the river bed, the ecological processes and their importance for the equilibrium of the surroundings of Santiago.

ENVIRONMENT IN TUNING IN WITH NATURE

The respect for the environment and its conservation for future generations of the Santiago basin is an essential part of our work.

CLEAN URBAN MAPOCHO

To be able to see and enjoy a clean Mapocho River, along its urban stretch, is only steps from becoming reality, thanks to the approval of the Environmental Impact Study by the Metropolitan Region's Regional Environmental Commission and the subsequent initiation of the construction works at the end of 2007, which will extend over the next 18 months.

The Clean Urban Mapocho Project seeks to eliminate 21 sewage discharge points that currently pour their contents into the Mapocho River during its flow through the city of Santiago, from the Municipal Commune of Las Condes to Maipú, permitting the decontamination of the Mapocho River in its stretch that crosses the city. For this, the project considers the construction and operation of an interceptor collector 28 kilometers long, which will permit these discharges to be diverted towards the La Farfana and El Trebal treatment plants.

Among the benefits of this project are the improvement of the quality of the river's water, the elimination of unpleasant odors, the decontamination of the La Punta, La Pólvora and Casas de Pudahuel irrigation canals and the recovery of riverside areas, among others.

MAPOCHO SEWAGE TREATMENT PLANT

The Mapocho Plant project consists of the construction of a new sewage treatment plant located close to the current El Trebal installations.

The future Mapocho Plant is designed for a treatment capacity of 4.4 cubic meters per second. With its operation,

the proportion of the sewage generated in the Santiago Basin that will be treated is expected to reach 100%, converting our capital into a city free of contaminated waters.

During the year 2007, the engineering studies commenced jointly with the environmental analyses. Furthermore, within the framework of our policy on social responsibility, we organized something never seen before which involved the voluntary and prior participation of the public which, during 10 months, informed the communities and the authorities of the zone of the characteristics of the project and took note of their principal worries and concerns.

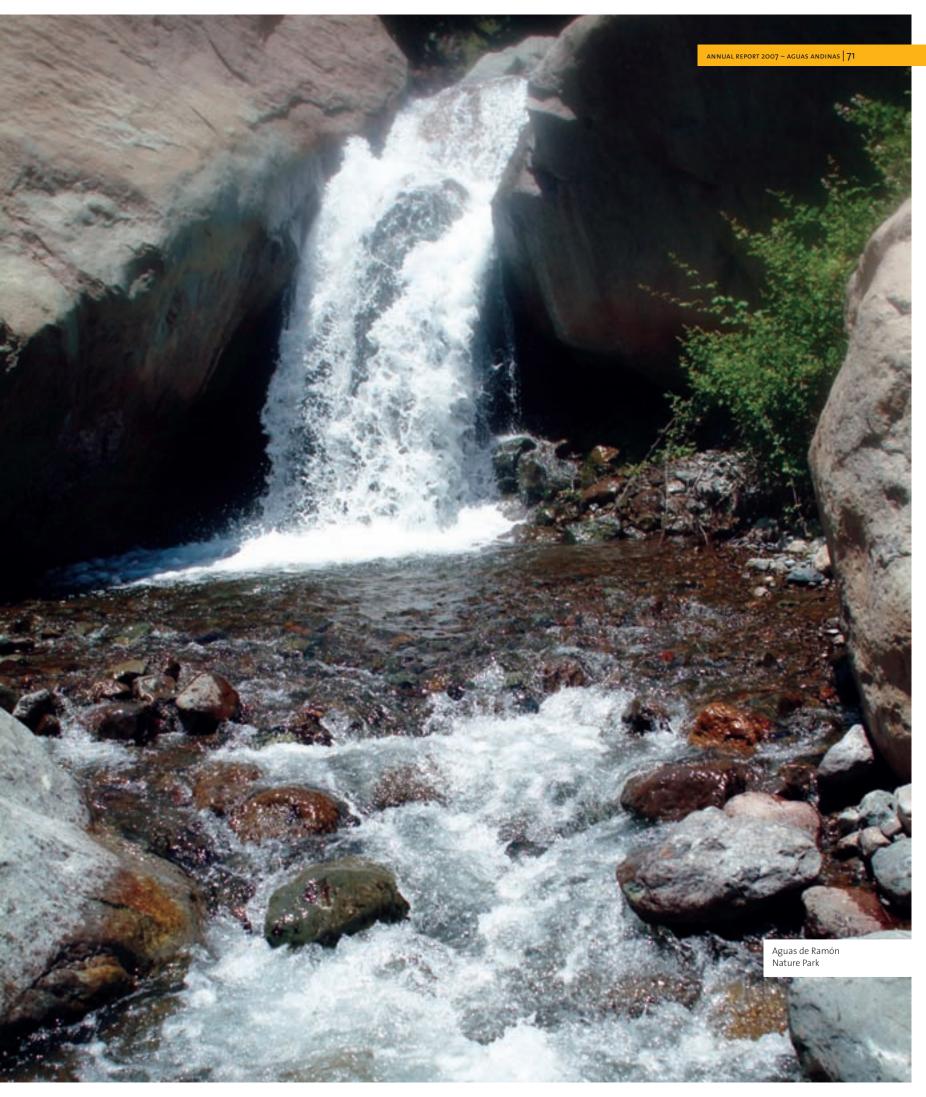
In the month of November, the Environmental Impact Study was submitted to the Metropolitan Region's National Environmental Commission for its approval.

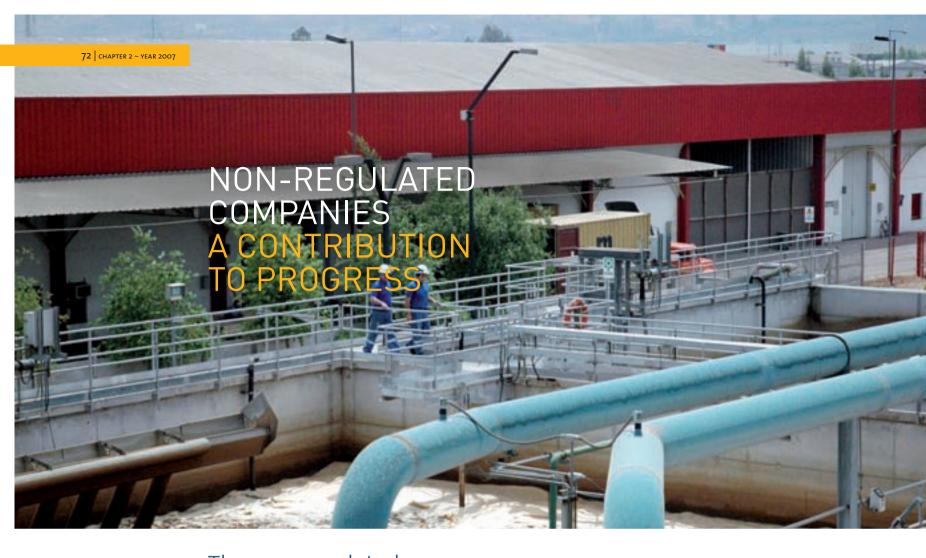
OVERALL TREATMENT OF BIOSOLIDS

As a result of the process of treating sewage, three products favorable to the environment are obtained: treated and clean water, which can be returned to the natural river beds or be used for irrigating crops; natural gas, to be utilized as a non-conventional renewable energy and contribute to the energy effort the country so needs; and biosolids, which contain nutrients and organic matter, reusable in agricultural activities.

Aguas Andinas foments an overall treatment of biosolids in order to generate sustainable solutions in time and to maximize the beneficial use of this product. For this, during the year 2007, various research experiments were carried out, utilizing 11 thousand tons of biosolids on rundown agricultural land and forest plantations.

Along these same lines, in mid-2007, the Company received the environmental authorization to implement a new process of biological drying of the biosolids, known as "biodrying". This process has permitted a very significant change in the operation of the El Trebal drying field, avoiding the accumulation of biosolids in winter and improving substantially the environmental conditions of the surroundings.





The non-regulated subsidiaries of the Aguas Group have the role of supporting the activities of our sanitation companies and, thus, contribute towards the sustainable development and progress of the country's industrial sector.

ECORILES

Provides consultancy and management services on liquid industrial residues to various industries in this country, operating the processes and the environmental problems associated with liquid or solid industrial waste.

During 2007, EcoRiles achieved revenues of USD 10 million, with a return on sales of over 20%, becoming the most important company in the country in outsourcing industrial waste plants by means of their comprehensive management. Currently, this subsidiary of Aguas Andinas operates 20 industrial waste plants, with over100 employees.

At the beginning of the year, the liquid residue treatment plant at Agricola Ariztía's processing plant located in El Paico started operations. This installation was financed and constructed by EcoRiles for the client and today it is complying fully with the DS90, which regulates the discharge of industrial residues to surface beds.

During the period, the company started operating the industrial residue plant at Soprole, one of the most important plants in the Metropolitan Region. Furthermore, it successfully started its expansion in the southern area of the country on incorporating the operations of the Pesquera San José plant in Coronel and the Watt's plant in Osorno.

During the 2007 period, EcoRiles obtained the ISO 9,001-2000 certification, thanks to the joint work of its personnel with the people from support on matters of quality from the Aguas Group.



GESTIÓN Y SERVICIOS

Sells mainly materials for the sanitation industry and its principal clients are construction companies, property developers and installers of sanitary services.

In 2006 it started offering global solutions related to road projects and, as of 2007, it initiated a new stage of growth through the development of new businesses. Among these are the study of new technologies for restoring collectors – to be launched onto the Chilean market – and the participation in the development of the project for supply of biogas from the La Farfana Plant to Metrogas, where it is expected to invest the sum of USD 2.5 million in order to enter into the business during the second half of 2008.

During the current period, Gestión y Servicios showed a significant growth that permitted it to consolidate its leadership in the supply of materials for the sanitary industry. It achieved sales of Ch\$ 9,796 million with an operating income of Ch\$ 1,616 million, which reflects increases of 36% and 47%, respectively.

ANAM

A laboratory involved in taking samples and the analyses of water, sludge and soil, duly accredited under local requirements and the demands of the Agbar Group's network of laboratories.

As part of its strategy, it has continued with the development of leading edge analytic techniques, permitting the achievement of the highest level of detection and quantification for organic compounds and metals present in water.

Currently, Anam has become a referent to both the local potable water market, operating with 9 sanitation companies, and the bottled water market in which it operates with the principal international brands with a presence in Chile, Argentina, Bolivia, Peru, Uruguay and Paraguay. In the same way, in the market of industrial waste and sewage, it provides services to the principal industries in the country, mainly in the food and agroindustrial sector.

In this way Anam has consolidated its position as the principal water laboratory on the local market, with its outstanding commercial development and care for its workers. During the 2007 period, revenues came to Ch\$ 2,586 million, an increase of 39% with respect to the previous year, and it showed an increase in net earnings of 52% in respect of the previous period.

FINANCIAL INFORMATION EFFICIENT MANAGEMENT

Taking advantage of market conditions, during 2007 we carried out a restructuring of our borrowings which permitted us to improve our maturity curve and reduce the Company's financial costs.

Market conditions permitted us to carry out a restructuring of our borrowings during the first half of 2007, which implied the financing of 100% of our obligations with banks and, in addition, the negotiation of fresh bank financing to cover cash requirements for the period. Both operations contributed to the reduction in our financial costs.

This combination of sources of finance permitted us to support the operations and comply with our plan of investments, reduce our financial expenses and improve the liquidity ratios of the Company. The above, added to the low operational risk of the industry and our solid financial profile, ratified our risk rating of AA+ granted by the risk rating agencies, one of the best categories assigned to a private company on the local market.

As part of the plans to optimize the corporate structure of the Group, during the period we arranged the merger of companies, the elimination of investment companies and a tidying up of the companies in a sector of regulated businesses and another with non-regulated businesses, concluding various stages of the corporate simplification project.

We also worked on the analysis of the adoption of the international financial reporting standards (IFRS) which will permit us to issue our financial statements as of the year 2009 in accordance with the norms demanded by the Superintendence of Securities and Insurance.

In order to strengthen the relationship with our suppliers, we implemented a space in our web page that allows them to consult, on-line, the statement and history of payments of their invoices, having quick access to quality information.



The Company shows a favorable situation in terms of risk. This is due to the particular characteristics of the sanitation sector and to a proactive policy on the control of risks in which we have applied the ample experience of our controlling shareholder.

OPERATIONS

NEW INVESTMENTS

Aguas Andinas is carrying out a plan of investments in accordance with the development programs to which it is committed with the Superintendence of Sanitation Services (SISS), which involve a significant effort in terms of financial, administrative and technical resources for their implementation and control. Nevertheless, tariffs incorporate the cost of these new investments, ensuring a minimum yield.

REGULATED MARKET

Due to its monopolistic nature, the sanitation services industry is highly regulated by the State and is exposed to possible changes in the norms established. The current legal framework regulates the operation of the concessions as well as the tariffs that are charged to customers, which are set every 5 years. The current tariff period runs from March 2005 to February 2010 for Aguas Andinas and to May and June 2010 for its sanitation subsidiaries.

WEATHER CONDITIONS

The weather conditions in the hydrographic basins determine, to a great extent, the quantity, quality and continuity of the raw waters available for the processes of abstracting and producing potable water.

Currently, Aguas Andinas holds sufficient water rights to ensure an adequate production of potable water, even in

adverse climatic conditions. Also, in the Company we have the technical and human capacities to overcome critical situations.

CLIENTS

The Company currently attends 1,597,537 potable water clients located in our area under concession and who have Aguas Andinas and its subsidiaries as their supplier. The principal 100 clients represent only 6.78% of the total sales for the year 2007.

FINANCE

EXCHANGE RISK

Aguas Andinas' revenues are tied to the local currency and therefore, the Company's borrowings are in this same currency with no debt in foreign currency.

INTEREST RATE RISK

As of December 31, 2007, Aguas Andinas had 75% of its debt at a fixed rate, comprised as follows: approximately 82% in short and long-term bonds and 18% in reimbursable financial contributions. The other 25% of the debt is at a variable rate and corresponds to credits from local banks.

The situations described have determined that the risk rating agencies have assigned the Company a rating of AA+ on the long-term debt. In the case of shares, Feller Rate has assigned a rate of First Class Level 3, whilst ICR assigned a rate of First Class Level 2.

INVESTMENTS AND FINANCING POLICY

(1) Net earnings for the period adjusted to reflect the negative goodwill generated by the subsidiary, Gestión y Servicios S.A., equivalent to ThCh\$ 1,109.

INVESTMENTS

Of the total investments made during the period, 65.1% corresponded to expansion works, thus complying with the Company's long-term development plan.

The rest of the resources invested were assigned mainly to renewing existing operating assets and, to a lesser degree, to the implementation of technological development and to investments in the non-sanitation subsidiaries.

FINANCING

During the first half of 2007 we carried out a restructuring of our borrowings which implied refinancing 100% of our obligations with banks, equivalent to 22% of the financial debt of the Company as of April, 2007 substantially improving the maturity curve for the forthcoming years and increasing the duration of the bank debt from 1.8 to 4.5 years.

Furthermore, we obtained a new bank credit to cover cash requirements during the period. This credit was for Ch\$20,000 million, matures in 2013 and has an average duration of 4.5 years. Both operations permitted us to reduce our financial expenses.

During the period, we obtained financing through reimbursable financial contributions of Ch\$16,645 million, issued in UFs plus a fixed rate, with maturities between 10 and 15 years. In addition, we utilize bank credit lines to finance our temporary need of funds.

In December the Company informed the Superintendence of Securities and Insurance (SVS) of its intention of undertaking a bond issue for up to UF2.5 million in order to finance investment projects for the year 2008.

DIVIDEND POLICY

At the Seventeenth Ordinary Shareholders Meeting, the Board of Directors agreed on a dividend policy consisting of paying 100% of the net earnings, with 30% corresponding to the net earnings for the period as an obligatory dividend and the other 70% as an additional dividend.

This policy shall remain in force whilst the Company maintains the current level of capitalization and that it continues to be compatible with the policies on investments and financing determined for each period.

On September 25, 2007 we informed the Superintendence of Securities and Insurance that the Board of Directors of the Company had agreed to distribute an interim dividend of Ch\$M 30,000,062 on account of the net earnings for the year 2007. As a result of this, the Company's dividend number 45 amounted to Ch\$ 4.9028 per share and was payable as of October 24, 2007.

On September 28, 2007 we informed the Superintendence of Securities and Insurance that the Board of Directors of the Company, at its meeting held on August 28, 2007, in accordance with the provisions of Article 44 of Law N° 18,046 and considering that the Directors Joaquín Villarino and Marta Colet are, in turn, Directors of Empresa Depuradora de Aguas Servidas Ltda., agreed to inform that Superintendence that a Contract had been signed between the two companies for the Operation and Maintenance of

the La Farfana Sewage Treatment Plant.

On October 3, 2007 we informed the Superintendence of Securities and Insurance that with communication ORD. SVS N° 11602 of October 2 the Company was required to inform on specific aspects of the Contract for the Operation and Maintenance of the La Farfana Sewage Treatment Plant signed between Aguas Andinas S.A. and Empresa Depuradora de Aguas Servidas Ltda.

With respect to this, we reported the following:

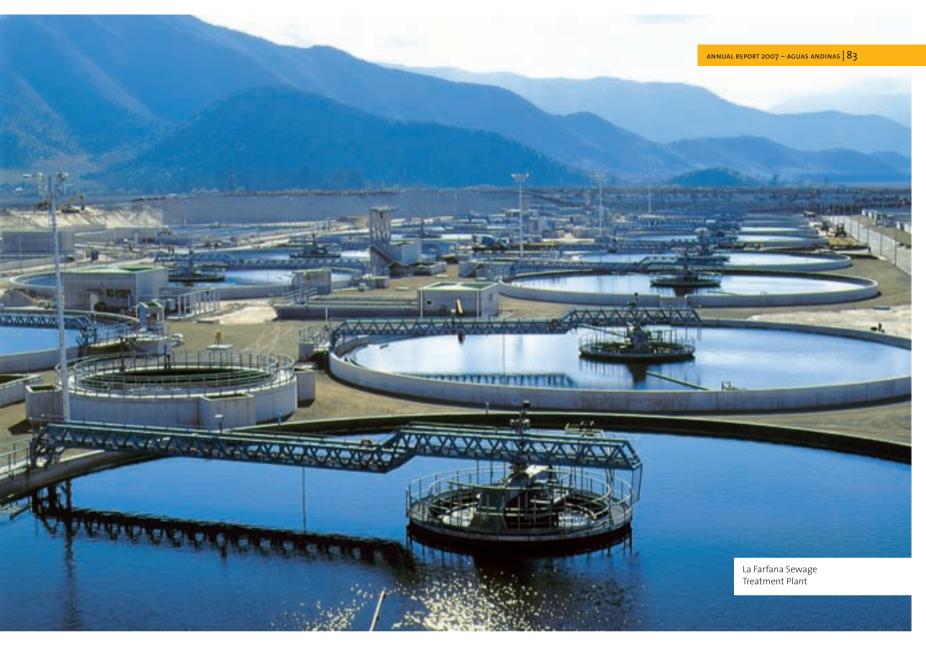
The contract in question originated from an international public tender, as established in Article 67 of Decree Law MOP N° 382/88, General Law on Sanitation Services which was announced for by Aguas Andinas on May 12, 2007.

Nine companies acquired the bidding conditions and the following submitted their offers: Cadagua S.A., Omnium de Traitment et de Valorisation S.A. (OTV) and the consortium formed by Degrémont S.A. and Sociedad General de Aguas de Barcelona S.A. (Agbar), the latter two being companies related to Aguas Andinas S.A. The Minutes of the Opening of the Financial Offers was attached.

On August 2, 2007 Aguas Andinas informed the consortium referred to above, which obtained the highest points in their technical and financial bid, that it had been awarded the contract. This took place after a favorable agreement of the Committee of Directors of Aguas Andinas, adopted in its meeting held on July 23, 2007 and by its Board of Directors in its Ordinary Meeting N° 351 held on July 24, 2007. The agreements mentioned were adopted unanimously by the members present declaring that they carried conditions of fairness similar to those that habitually prevail on the market.

In order to attend the signing of the contract, and in line with the Tender Conditions, Degrémont and Agbar, through their subsidiary in Chile, Agbar Conosur Ltda., created a company named Empresa Depuradora de Aguas Servidas Ltda. (EDAS), and designated as Board Members were the Directors of Aguas Andinas, Joaquín Villarino and Marta Colet.

With respect to the above, the contract signed with EDAS is one of those operations contemplated in Article 44 of Law N° 18,046 on corporations. Left on record was the fact that the signature of the contract with EDAS was approved by the Committee of Directors of Aguas Andinas in its meeting held on August 27, 2007 and by its Board of



Directors at its Ordinary Meeting N° 352 held on August 28, 2007. These agreements were also adopted unanimously by the Directors present, with the abstention of the Directors, Villarino and Colet.

The contract was signed utilizing the series of unit prices system for an estimated value of UF 2,774,994.4 (two million seven hundred and seventy four thousand nine hundred and ninety four point four Unidades de Fomento) plus VAT, with a duration of 60 months from October 1, 2007 renewable for a consecutive period of 60 months in the terms established in the contract.

Finally, we pointed out that the purpose of the contract is to operate and maintain the La Farfana Sewage Treatment Plant, owned by Aguas Andinas S.A., including the entire scope of a correct management of the operation and maintenance of the plant, considering among others, the supply of personnel, electricity costs, provision of chemicals, spare parts, etc., in the terms contemplated in the Tender Conditions and other documents pertaining to the contract.



DIRECTORS' REMUNERATIONS

In accordance with Law No.18.046, the Ordinary General Meeting of Shareholder held on April 23, 2007 approved the remuneration for the Board of Directors, the Committee of Directors and their budgets for expenses for the 2007 period.

The remuneration for the Board is divided into two types: one fixed per month of UF 100 for the Chairman, UF 75 for the Vice-Chairman and UF 50 for the directors and the alternate directors; and a variable remuneration that is paid according to the attendance at each meeting, of UF

80 for the Chairman, UF 60 for the Vice-Chairman, UF 40 for the directors and UF 40 for the alternate directors only when they replace the director.

The remuneration for the Committee of Directors for the year 2007 was set at: a fixed monthly remuneration of UF 25 for each member and alternate and a variable remuneration for the attendance at each meeting of UF 20.

Furthermore, a budget for expenses was approved for a total of UF 3,000.

REPORT OF THE COMMITTEE OF DIRECTORS

In accordance with Article N° 50 bis, Point Ten, of Law 18,046 on Corporations, this report provides information on the Committee's activities during the year ended on December 31, 2007 together with the expenses incurred, including those of its consultants. The main activities of the Committee during the year ended on December 31, 2007 were the following:

COMPOSITION OF THE COMMITTEE

The members of the Committee of Directors of Aguas Andinas S.A., as referred to in Article N° 50 bis, Point Ten, of Law 18,046 on Corporations, during the year 2007 were the Directors independent of the controlling shareholder, Carlos Mladinic and Mónica Singer, and the director related to the controller and Chairman of the Board of the Company, Alfredo Norman.

After the Ordinary Meeting of Shareholders held in 2007 that completely renewed the Board of Directors, the latter appointed as members of the Committee of Directors, the directors independent of the controlling shareholder, Carlos Mladinic and Mónica Singer, and the director related to the controller, Joaquín Villarino.

The Committee appointed Carlos Mladinic as its Chairman

Since it was founded, the Committee has held ordinary meetings once a month to discuss matters delegated to it in Article N° 50 bis of Law 18,046.

PRINCIPAL ACTIVITIES DURING THE YEAR

- 1) Examine the remunerations systems and compensation plans for the managers and senior executives of Aguas Andinas S.A.
- 2) Examine the reports of the independent auditors, the balance sheet and the other financial statements of Aguas Andinas S.A. corresponding to the year ended on December 31, 2006 and presented by the Company's management to the shareholders and comment on these before their presentation to the shareholders for their approval.
- 3) Selection by the Committee of Directors and proposal to the Board on the appointment of the independent auditors and the private risk rating agencies for Aguas Andinas S.A. that were suggested at the Ordinary Meeting

- of Shareholders for the year 2007.
- **4)** Follow-upthestateoftheapprovaloftheSuperintendence of Sanitation Services (SISS) of the request for authorization to modify the contract on the operations and maintenance of the La Farfana Sewage Treatment Plant with related company, Degrémont S.A.
- 5) Analysis of the various alternatives proposed by management for the international tender for a new Contract for Technological Contributions to Aguas Andinas S Δ
- **6)** Analysis of the various alternatives proposed by management for the possible contract with related company AGBAR to develop a System of Information for the New Commercial Activity of Aguas Andinas S.A. (ALGOL Project).
- **7)** Examine the information and report to the Board on the following public tenders, award of bids and contracts carried out for related companies:
- a) Extension of the contract that was still in force for the operation and maintenance of the La Farfana Sewage Treatment Plant signed between Aguas Andinas S.A. and related company, Degrémont S.A., up to the month of September, 2007 and the preparation of a new public tender for similar services, as required by the General Law on Sanitation Services in its Article 67.
- b) Examine and approve the awards proposed by management on the international public tender for the Supply of Piping, Valves, Joints and Accessories for Potable Water and Sewerage Networks, including 12 lines to related company, Agbar Servicios Compartidos S.A. (ASERCO), of the 18 lines awarded, considering that these are cheaper offers for the respective line, in a competitive public tender that guarantees to be an operation carried out on conditions of fairness similar to those prevailing on the market.
- c) Examine and approve the rental contracts proposed by Aguas Andinas S.A.'s management to its subsidiary, ANALISIS AMBIENTALES SA., on a 180-square meter property on Calle Lira N° 2370, with a rent of 0.15 UF/square meter/month with a total per month of UF 27; and of 40 square meters on the 6th floor of the corporate building, with a rent of 0.37 UF/square meter/month, equivalent to a UF 14.8 per month, that correspond to conditions of fairness similar to those prevailing on the market.
- d) Examine and approve the award proposed by management on the public tender labeled "Service of Operating the Laboratory at the Talagante Sewage

Treatment Plant" to ANALISIS AMBIENTALES S.A., ANAM S.A., a company related to Aguas Andinas S.A. considering that it is the only offer received through a public tender, in an operation carried our in conditions of fairness similar to those prevailing on the market and that in no way could such an operation have a detrimental effect on the company or its shareholders, given that this subsidiary is 100% consolidated with Aguas Andinas S.A. which is the direct or indirect owner of 100% of its shares.

- e) Examine and approve the award proposed by management on the public tender labeled "Service of Certifying the Works of Installing Domestic Potable Water and Sewage Connections for Aguas Andinas S.A. and related companies" to the related company, NORCONTROL S.A. AGENCIA en CHILE for all the sectors tendered, at a price for the three zones of Ch\$ 138,186,230 considering that it is the cheapest offer received in a public tender, in an operation carried our in conditions of fairness similar to those prevailing on the market.
- f) Examine and approve the award proposed by the management of the Company on the international public tender labeled "Operation and maintenance of the La Farfana Sewage Treatment Plant, to the Consortium being created and comprising the companies related to the controlling shareholder, Aguas de Barcelona S.A (AGBAR) and DEGREMONT S.A., for a referential value of UF 2,774,994.7 plus VAT, considering that it is the offer best evaluated in terms of technology and cost of all the ones received in an international and competitive public tender, for which we feel that it is in a condition of fairness similar to that prevailing on the market.
- g) Examine and approve the modification to the PLE-o1 contract still in force with Degrémont S.A., Agency in Chile, to put an end to the service of operating and maintaining the La Farfana Sewage Treatment Plant by Degrémont S.A., Agency in Chile and to regulate the obligations still in force between the parties, considering that this falls within the contract in force and within habitual fairness conditions equivalent to those prevailing on the market.
- h) Examine and approve the contracts on the sale of unprocessed biogas from the La Farfana Plant for 6 years and on the rental of a surface area of approximately 600 square meters in the La Farfana Plant to a subsidiary company of Aguas Andinas S.A., Gestión y Servicios S.A., along the pricing, terms and conditions proposed by the management, considering that they are conditions of

fairness similar to those prevailing on the market.

i) Examine and approve the public tender and proposed award to a company related to the controlling shareholder, Agbar Servicios Compartidos S.A., for the supply of Domestic Cold Water Meters and union parts for Aguas Andinas S.A. and related companies, for a period of 12 months, considering that this tender was carried our in a well informed, accessible, open and competitive manner in which 7 interested companies participated and 5 submitted offers, that ensures that the best offers are in conditions of fairness similar to those prevailing on the market, and that the offers from the company related to the controlling shareholder, in all the lines in which management proposed to the Committee they be awarded, is the cheapest and most convenient for the interests of Aguas Andinas S.A., under the system of unit prices and on consignment.

COMMITTEE OF DIRECTORS' BUDGET AND EXPENSES

At the Ordinary Meeting of Shareholders held in April, 2007 an annual budget of UF 2,700 was set for the Committee of Directors and this was only partly utilized. The only expenses incurred by the Committee during the year 2007 were the fees paid to the legal adviser and secretary of the Committee amounting to Ch\$1 million gross per month.



As of December 2007, the list of managers and senior executives of Aguas Andinas totaled 56 professionals. Their total remunerations for the year came to Ch\$4,622 million and the indemnities for years' service amounted to Ch\$156 million.

The policy on incentives for executives is focused on the achievement of the Company's general targets and on individual performance.

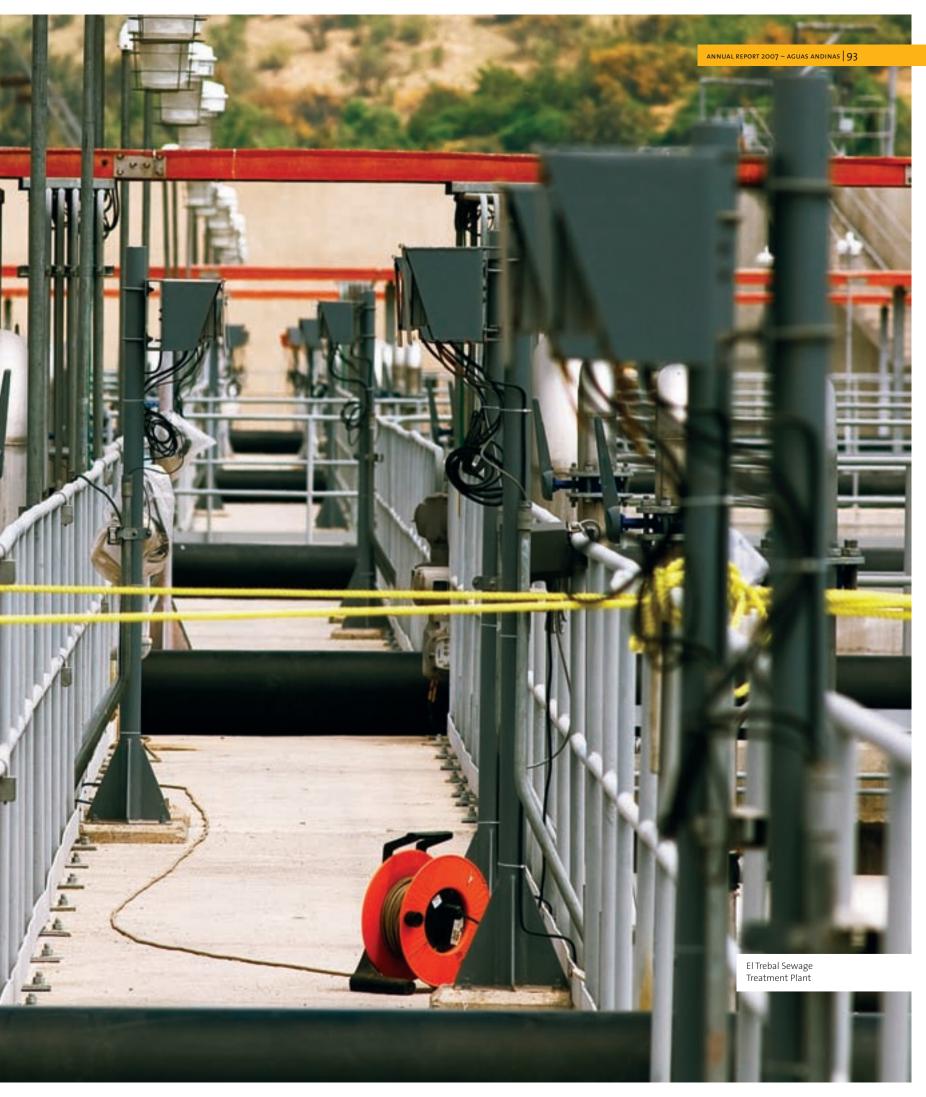

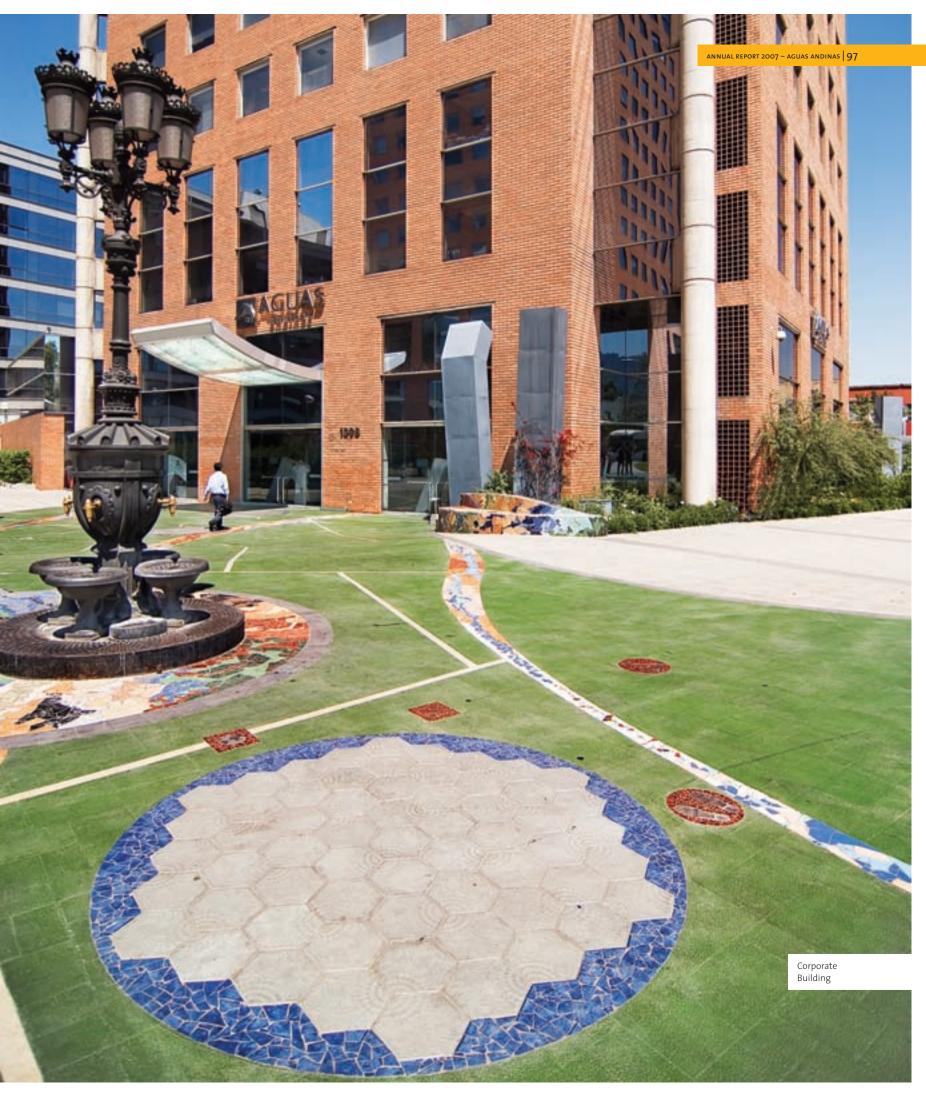

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

(IN THOUSANDS OF CHILEAN PESOS - THCH\$)

01. REGISTRATION IN THE SECURITIES REGISTER

Aguas Andinas S.A., Aguas Cordillera S.A., Aguas Los Dominicos S.A. and Aguas Manquehue S.A. are registered in the Securities Register of the Superintendency of Securities and Insurance under numbers 0346, 0975, 0389 and 0402; respectively. As a result, such companies are regulated by such Superintendency.

02. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a) Accounting period

These consolidated financial statements relate to the years between January 1 and December 31, 2007 and 2006, respectively.

b) Basis of preparation

These consolidated financial statements have been prepared in accordance with accounting principles generally accepted in Chile, issued by the Chilean Institute of Accountants, and the instructions of the Superintendency of Securities and Insurance.

In the event of differences between accounting principles generally accepted, as issued by the Chilean Institute of Accountants, and the instructions of the Superintendency of Securities and Insurance, the instructions of the Superintendency of Securities and Insurance will prevail.

c) Basis of presentation

For comparison purposes, the consolidated financial statements at December 31, 2006 and their respective notes have been restated off the books by 7.4%. This percentage corresponds to the variation in the Consumer Price Index during the last twelve months, with a one-month time lag.

For comparison purposes, some items of the 2006 consolidated financial statements have been reclassified.

d) Basis of consolidation

The consolidated financial statements include the assets, liabilities, results and cash flows of the Parent company and its subsidiaries. Transactions between the consolidated companies have been eliminated and the participation of minority investors has been recognized under Minority interest.

e) Price-level restatement

The consolidated financial statements have been restated by 7.4% in 2007 and 2.1% in 2006 to reflect the effects of variations in the purchasing power of the local currency during each year in accordance with accounting principles generally accepted in Chile.

Income statement balances were also restated to express them at year-end values.

f) Basis of currency translation

Assets and liabilities in Unidades de Fomento and/or foreign currencies are shown at their respective values and/or exchange rates at each year end, at the following rates:

g) Marketable securities

Marketable securities relate to investments in mutual funds units. These are shown at their redemption value at the closing date of these financial statements.

h) Inventories

Materials are shown at their restated cost which does not exceed their respective replacement costs at each yearend

There is an allowance for obsolescence for disposable items remaining in stock for more than one year with no activity.

i) Allowance for doubtful accounts

The allowance for doubtful accounts depends on the aging of the accounts receivable and the historical recovery, as follows:

For Aguas Andinas S.A. and the subsidiaries Aguas Cordillera S.A., Aguas Los Dominicos S.A. and Aguas Manquehue S.A., a 100% allowance is provided for customers with debts overdue for over 8 months.

For Aguas Andinas S.A. and its subsidiary Aguas Cordillera S.A., an allowance of 100% of accounts receivables converted

into repayment plans is established for cases classified as "non-government subsidized". For cases classified as "government subsidized" customers, an allowance of 55% is made and the remaining 45% is accrued as a commercial discount.

For the subsidiaries Gestión y Servicios S.A., Anam S.A. and Ecoriles S.A., allowances are provided for 100% of all customers debts more than 120 days past due.

A 100% allowance is provided for past-due notes receivable.

j) Property, plant and equipment

Property, plant and equipment transferred by the predecessor entity are shown at their restated appraisal values determined by independent consultants in a technical study made in 1977. Acquisitions after 1977 are shown at their restated cost.

The subsidiary Aguas Cordillera S.A. shows its specific accounts at cost, plus the incremental or discounted value resulting from technical appraisal performed in 1977, both restated.

The other subsidiaries show their property, plant and equipment at restated cost.

The property, plant and equipment include the main renewals and improvements. Maintenance costs or minor repair expenses are charged to income in the year in which they are incurred.

Work in progress include financing costs incurred until the assets are in a condition to be used, in accordance with Technical Bulletin No.31 of the Chilean Institute of Accountants.

Direct remunerations, consultancy costs and other inherent and identifiable expenses are also included in the cost of some work in progress.

k) Depreciation of property, plant and equipment

Depreciation is calculated using the straight-line method on the restated book values over the remaining useful lives of the respective assets.

I) Leased assets

Lease agreements classified as capital leases are recorded in accordance with Technical Bulletin No.22 of the Chilean Institute of Accountants.

Leased assets are valued and its depreciation is calculated according to the accounting principle generally accepted

for the property, plant and equipment.

Assets acquired under lease agreements are not legally owned by the Company until it has exercised its purchase option and therefore the Company can not freely dispose them.

m) Intangibles

Water rights, rights of ways, software and other rights are shown at their restated cost net of amortization, in accordance with Technical Bulletin No.55 of the Chilean Institute of Accountants.

Intangible assets are being amortized over a period of 40 years from the date of acquisition or as from 1998 as it is believed that they will provide benefits during that period.

Software is amortized over a period of 4 years from the acquisition date, as it is believed they will provide benefits in such period.

n) Goodwill and negative goodwill

Goodwill represents the excess paid over the proportional equity value on the purchase date of the shares in Aguas Cordillera S.A. Negative goodwill represents the discount obtained as compare with the proportional equity value on the purchase date of the shares in Aguas Manquehue S.A. Goodwill and negative goodwill are being amortized over a maximum period of 20 years from the date of acquisition as this is the estimated period of return on the investment.

o) Transactions under resale agreements

Acquisitions of securities under resale agreements are valued as fixed-income investments and are shown in Other current assets, in accordance with Circular No. 768 of the Superintendency of Securities and Insurance.

p) Bonds payable

This is the obligation for the placement of bonds issued by the Company on the domestic market and shown at their nominal value plus indexation adjustments and interest accrued at each year-end. The discount incurred and the issuance costs on the placement of the bonds are deferred and amortized over their respective terms, in accordance with Circular 1,370 of the Superintendency of Securities and Insurance.

q) Income tax and deferred taxes

The Company has provided for income tax on the

basis of its net taxable income determined in accordance with the provisions of the Income Tax Law. According to Technical Bulletin No.60 and other instructions from the Chilean Institute of Accountants and Circular 1,466 of the Superintendency of Securities and Insurance, the Company records the effects of deferred taxes resulting from temporary differences, tax benefits related to tax loss carryforward and other events that create differences between the financial and tax basis of assets and liabilities.

The subsidiaries Aguas Cordillera S.A., Aguas Los Dominicos S.A. and Aguas Manquehue S.A. record these effects as from the beginning of 2000, recording deferred taxes arising on the accumulated temporary differences in asset and liability accounts with credits and charges, respectively, to complementary accounts which are amortized, affecting income tax for the year, over the weighted average reversal period. These complementary accounts are shown deducted from the corresponding deferred tax assets and liabilities that originated them.

r) Severance payments

Severance payments will be paid in accordance with the Labor Code, except for the amount of accumulated indemnities in Aguas Andinas S.A., Aguas Cordillera S.A. and Aguas Los Dominicos S.A. at July, November and December 2002, respectively, for employees included in the respective union labor agreement and those to whom the same benefits apply in accordance with their individual labor contracts. The accumulated amount at that date is adjusted quarterly according to changes in the consumer price index. The union labor agreement contract also established that employees who retire from the company within 120 days of having reached the legal retirement age, will continue to accrue this benefit after July 2002, until their retirement date, while, for Aguas Cordillera S.A. and Aguas Los Dominicos S.A., the mentioned agreements

state that employees who retire from the company on having reached the legal retirement age, will continue to accrue this benefit after November and December 2002, respectively, until their retirement date.

The Company's obligation for the accrued indemnity for employees up to July 2002 for Aguas Andinas S.A. and up to November and December 2002 for Aguas Cordillera S.A. and Aguas Los Dominicos S.A. is accounted for at its current value, and the obligation for the additional indemnity that is estimated the employees who retire from the company will accrue' is accounted for at its present value, calculated according to the accrued cost of the benefit method and at an annual discount rate of 4.1% in 2007 and 4.8% in 2006.

There are also individual contracts which are accounted for by the current value according to their terms.

Advances granted to personnel against such funds are shown as long-term debtors. These advances price level restated will be deducted from the final settlement, as stated in the respective contracts.

s) Revenue recognition

The Company's sales are recorded on the basis of the consumption read and billed to each customer, divided into monthly billing groups and valued in accordance with the tariff fixed by the Superintendency of Sanitation Services (SISS) for five-year periods.

Consumption read but not billed at the year-end is also recorded at the tariff defined for each invoicing group.

t) Research and development costs

Expenses in research and development studies which are not related to any project, are charged to income in the year in which they are incurred. Otherwise, they form part of the costs of the corresponding work in progress.

u) Statement of cash flows

The Company considers as cash and cash equivalents its

balances in cash, in unrestricted bank checking accounts, time deposits, marketable securities and resale agreements whose redemption will take place within 90 days from the date the investment was made and that carry no significant loss risk at the time of redemption.

Cash flows from operating activities include revenues and expenses of the Company and all other income and expenses that are treated as non-operating in the Statement of Income.

v) Derivative contracts

The subsidiary Gestión y Servicios S.A. has signed a currency hedge agreement with a financial institution. This contract has been designated as a hedge of an existing item and has been assigned as a financial hedge against foreign exchange variations. The contract is accounted for as indicated in Technical Bulletin No. 57 of the Chilean Institute of Accountants.

03. ACCOUNTING CHANGES

On August 31, 2007, the subsidiary Aguas Cordillera S.A. was dissolved, tax identification number 80.311.300-9, recorded in the Securities Record of the Superintendency of Securities and Insurance under No. 0369, due to acquisition of all the shares by Aguas Cordillera S.A., tax identification number 96.809.310-K, company that previously operated under the name of Comercial Orbi II S.A., recorded under No. 0975, as the Securities Record of the Superintendency of Securities and Insurance.

The merger took effect on September 1, 2007.

This transaction was recorded in according with the established in Technical Bulletin No. 72 of the Chilean Institute of Accountants, combinations of business under common control based on the methodology of pooling of interest.

Due to the change in the reporting entity, the financial statements of prior years presented for comparison were restated retroactively, in order to present the financial information corresponding to the new reporting entity (paragraph 20, Technical Bulletin No.15).

In addition, the subsidiaries made the following changes in accounting estimates during 2007:

Aguas Andinas S.A. and the subsidiaries Aguas Cordillera S.A. and Aguas Los Dominicos S.A. have collective labor agreements with their employees which provide for indemnities in accordance with the Labor Code and an additional indemnity if they retire while being employed by the Company.

To calculate this additional indemnity, the companies used the present value of such obligations based on the accrued cost method for those who are covered by the union labor agreements and who are believed will remain employed until their retirement age. The discount rate used for this calculation has been changed from 4.8% at December 2007, in accordance with a study performed by the Company.

The effect of this change on income for 2007 amounts to a greater charge of ThCh\$68,875.

The Subsidiaries have agreed to deferred payments, for the past due accounts receivable from clients, through payment agreements which are collectible upon maturity of each of the installments. The accounts receivable with payment agreements are classified as "government subsidized", in

the case of special agreements with customers of a lower socio-economic level and as "non-government subsidized" for the other payment agreements.

During 2007 the companies increased the allowance of agreements classified as non-government subsidized from 20% to 100%; and in the case of the government subsidized agreements, it increased the allowance for doubtful accounts from 40% to 55%, accruing the remaining 45% as a commercial discount. In both cases, due to the low recovery of the verified debts in the previous year.

The effect of this change on the income for 2007 amounts to a greater charge of ThCh\$2,761,344.

There have been no other accounting changes that could affect the comparison of those financial statements.

05. SHORT- AND LONG-TERM DEBTORS

Trade accounts receivable relate to the billings for drinking water, sewage services, sewage treatment and other associated services, with balances classified as short and long term.

The balance of trade accounts receivable includes an allowance for revenues accrued as at December 31, 2007 and 2006 of ThCh\$13,677,484 and ThCh\$15,015,143, respectively, corresponding to unbilled meter readings at each year-end.

For Aguas Andinas S.A. the balance of debtors at December 31, 2007 is divided into Residential 80.65%, Commercial 16.71%, Industrial and others 2.64%. The balance of debtors at December 31, 2006 was divided into Residential 80.40%, Commercial 16.43%, Industrial and others 3.17%.

For Aguas Cordillera S.A. the balance of debtors at December 31, 2007 is divided into Residential 81.81%, Commercial 17.99%, Industrial and others 0.20%. The balance at December 31, 2006 was divided into Residential 81.48%, Commercial 18.25%, Industrial and others 0.27%.

For Aguas Los Dominicos S.A. the balance of debtors at December 31, 2007 is divided into Residential 88.88%, Commercial 11.11%, Industrial and others 0.01%. The balance at December 31, 2006 was divided into Residential 88.43%, Commercial 11.53%, Industrial and others 0.04%.

For Aguas Manquehue S.A. the balance of debtors at December 31, 2007 is divided into Residential 71.53%, Commercial 28.63%, Industrial and others 0.11%. The balance at December 31, 2006 was divided into Residential 71.10%, Commercial 28.47%, Industrial and others 0.43%.

Allowances for doubtful accounts have been recorded, as follows:

- a) An allowance for doubtful accounts has been provided as explained in Note 2i), amounting to ThCh\$15,167,199 and ThCh\$12,967,418 as of December 31, 2007 and 2006, respectively. The charge to income for the years 2007 and 2006 were ThCh\$3,199,314 and ThCh\$997,812, respectively. In addition, at December 31, 2007 and 2006, debts of ThCh\$137,375 and ThCh\$230,853, respectively, were written off
- b) Provision for payment agreements. Provision for commercial discounts relate to payment agreements of debts signed by customers of Aguas Andinas S.A. and Aguas Cordillera S.A. through which they can obtain a commercial discount if they fully comply with such agreement. This allowance amounts to ThCh\$3,755,528 and ThCh\$3,034.971 at December 31, 2007 and 2006, respectively. The charge to income at December 31, 2007 and 2006 amounted to ThCh\$953,336 and ThCh\$517,999, respectively. Out of these provisions commercial discounts amount to ThCh\$26,780 and ThCh\$0 as of December 31, 2007 and 2006, respectively.

Notes receivable is comprised mainly of promissory notes signed by customers as a result of agreements with property developers.

The balance of short-term sundry debtors as at December 31, 2007 and 2006 relates mainly to collection agreements through credit cards and accounts receivable from personnel.

The main component of long-term debtors relates to agreements signed with property developers and advances against severance payments, as indicated in Note 2r) and to trade accounts receivables net of their corresponding allowance.

The debt with Acsa Agbar Construcción S.A., corresponding to a withholding indicated in the contract for the renewal of piping.

The debt with Brisaguas S.A., corresponds to collections payable, according to the contract.

With Empresa Depuradora de Aguas Servidas Ltda., exists an operations and maintenance contract of the La Farfana Sewage Treatment Plant, its invoicing is upon expired month, and is paid at 30 days after the approval of the payment statement.

Accounts receivable

Empresa Depuradora de Aguas Servidas Ltda. has purchased material and spare parts and has a pending balance, with maturity on January 31, 2008.

The accounts receivable from Degrémont S.A., Chilean Agency and Brisaguas S.A. relate to chemical and bacteriological laboratory analysis services, payable at 30 days without interests.

The debt of Constructora Acsa Ltda. and Aguas de Levante S.A. relates to sales of materials, payable at 30 days without interest.

The materiality criterion to inform the transactions with related parties relates to amounts in excess of ThCh\$100,000.

The Company has sixty eight plots of land that were transferred free of charge by the Chilean State and are booked at a value of Ch\$1 each. There are also fixed assets with an expired accounting useful life and are therefore shown valued at Ch\$1 even though, they are still in operation.

There are also amounts which are contributions from third parties and these are governed by Decree Law 70 of 1988 of the Ministry of Public Works and by the provisions of clause 36 of D.S. MINECON Regulation 453 of 1989. These are explained in Note 32.

In 1989 and in accordance with Transitory Clause 3 of

Decree Law 382 of 1988, the General Law on Sanitation Services, Aguas Cordillera S.A. removed from its accounts all assets financed by third parties and Chilean state assets.

As a result of the application of this regulation, the Company maintains an off-balance sheet physical control over those assets, but the calculations of the price-level restatement and depreciation of these assets do not affect its financial statements in any way. As these assets form part of the sanitation infrastructure that it has to operate and maintain, the mentioned off-balance sheet control is performed.

LEASING

For Aguas Andinas S.A., assets under financial leases were acquired from GTD Telesat S.A. and shown in Other fixed assets, under an agreement for a 48-month term and an amount of ThCh\$56,166.

For Aguas Cordillera S.A., the assets under financial leases were acquired from Teletronic S.A. and shown in Other fixed assets, under an agreement for a 48-month term and an amount of ThCh\$11,236.

14. BONDS PAYABLE (SHORT- AND LONG-TERM)

This heading covers the amounts owed to the public due to the issuance of bonds by the Company in September 2001, December 2002, December 2005 and January 2006 on the domestic market.

In September 2001, Series bond B were issued for U.F.1.8 million for a 21-year term with repayments beginning in 2008.

On October 10, 2002, the Superintendency of Securities and Insurance certified the registration of bonds for up to U.F.10 million. Of this amount, Series C bonds were issued with a nominal value of U.F.4.2 million and Series D with a nominal value of U.F.5.8 million.

In December 2002, Series C bonds for U.F.4.0 million were placed, with repayments starting in June 2005 and extending through to December 2010.

On December 9, 2005, the Superintendency of Securities and Insurance approved a new bond issue totaling U.F.

5.0 million (Serie F), in order to finance the prepayment of the Series D bonds and refinance other obligations of Aguas Andinas S.A. in January 2006. The repayment will be performed quarterly starting June 1, 2008 through to December 1, 2026.

On December 23, 2005, the Series E bonds were placed for U.F.1.65 million, with repayment in June 2012.

The corresponding accrued interest is shown in short-term liabilities.

The bond issuances carry no special collateral except for the general pledge over the Company's assets.

The Board Meeting held on September 25, 2007, agreed to distribute ThCh\$30,000,062 (historic) as interim dividend, equivalent to Ch\$4.9028 per share, against net income for 2007. This payment was made on October 24, 2007.

Other reserves On August 31, 2007, Aguas Cordillera S.A. was dissolved, as Aguas Cordillera S.A., (ex Comercial Orbi II. S.A.), had bought all shares of this company. On September 1, 2007 both companies merged, as established in Technical

Bulletin No. 72 of the Chilean Institute of Accountants, combinations of business under common control based on the interest unification methodology, recording an equity of ThCh\$6,725,927 of which, Aguas Andinas recognized it held 99.99003% in the item Other reserves, equivalent to the participation it has in Aguas Cordillera S.A. (Note 9).

As established in clause 10 of the Corporations Law 18,046, the proportional amount of the restatement of capital was added to capital, this being divided at December 31, 2007 into 6,118,965,160 subscribed and paid shares.

The Ordinary Shareholders' Meeting held on April 26, 2006 agreed to distribute all the Company's net income for the year 2005 plus ThCh\$499,549 (historic) of reserves for future dividends, after deducting the interim dividend paid in September 2005. 25. CONTINGENCIES AND RESTRICTIONS

DIRECT GUARANTEES

Guarantee policies and performance bonds have been submitted to the Superintendency of Sanitation Services to guarantee the conditions for the rendering of services and development programs in the Company's concession areas. Performance bonds have also been submitted to SERVIU Metropolitan Area for the replacement of paving, and to other institutions, in the amount of ThCh\$11,635,775 and ThCh\$18,056,826 at December 31, 2007 and 2006,

respectively.

PENDING LAWSUITS

The following are the main outstanding lawsuits:

Court: 11th Civil Court of Santiago; Case file: 5716-1999. Aguas Andinas S.A. was sued severally by a gas company for damages to a pipeline made by a construction company. Aguas Andinas S.A. alleges that it has no responsibility in

this incident as it has no relationship whatsoever with the cause of the damage. The amount demanded is ThCh\$85,816, plus indexation and interest. Sentence has been passed at the first instance rejecting the suit against Aguas Andinas S.A. accepting only a part of the suit against the construction company for a far lower figure. The gas company has appealed and asked that the suit be entirely accepted, also against Aguas Andinas S.A.

Court: 14th Civil Court of Santiago; Case file: 169-2003. A company sued Aguas Andinas S.A. seeking the absolute nullity of Sociedad Gestión y Servicios S.A. in which Aguas Andinas S.A. had a 1% participation at the time of the demand.

The first instance final sentence was given rejecting the demand in all its parts and condemning the plaintiff to pay the costs. The plaintiff has appealed.

Court: 5th Civil Court of Santiago; Case file: 3684-2001.

Aguas Andinas S.A. was sued for the payment of an indemnity for extra-contractual liability for environmental damage in breach of Law 19,300. It is claimed that the failure to arrive at a prompt and adequate solution to the emission of bad odors from the Santiago Poniente Plant and subsequently from the La Farfana Plant, caused the prolonged suffering or moral damage to the neighbors, in addition to enormous financial damage as a result of the drop in the value of their properties. Amount involved: U.F.81,848. Current status: Discussion period has concluded, and the judge has requested the parties to provide evidence, as of December 31, 2007 the parties had not been notified. Sentence estimation: There is a moderate possibility of success in this case as the suit lacks a solid foundation. Current status: Sentence is pending on the provision of evidence.

There is a second lawsuit presented at the 11th Civil Court of Santiago, Case file 3541-2004 for U.F.506,594. Two other lawsuits have been presented which were requested to be added to this case: 20th Civil Court of Santiago, Case file: 7900-2046 for U.F.81,848 and 25th Civil Court of Santiago, Case file: 8305-2006, for U.F.42,161, plus indexation and interests.

Court: 19th Civil Court of Santiago; Case file: 2632-2004. A private individual is requesting the reversal of the sale of some water rights to Aguas Andinas S.A. through a

third party, sustaining that this has violated his rights. He is demanding the restitution of the water rights that were acquired for U.F. 5,525. Current status: Sentence has been passed, notification not yet executed. Estimation: an appeal has been filed against second instance sentence, its admission is still pending.

Court: 11th Civil Court of Santiago; Case No.13.214 - 2004. Aguas Andinas S.A. was sued for damages and extracontractual liability for environmental damage, an offense under Law 19,300. It is claimed that the failure to arrive at a prompt and adequate solution to the emission of bad odors from the Santiago Poniente Plants and subsequently from the La Farfana Plant, caused the prolonged suffering or moral damage to the neighbors, in addition to an enormous financial damage as a result of the drop in the value of their properties.

Amount demanded: U.F. 410,759 plus indexation and interest. Current status: First instance - discussion period. Exceptions were presented in order to correct irregularities in the suit. There is a moderate possibility of success; the result will depend on the proof of damages submitted. The court process has not yet commenced.

Court: 18th Civil Court of Santiago; Case No. 322-2005. Aguas Andinas S.A. was sued for technical faults and defects at the La Farfana Sewage Plant, causing bad odors that have affected the physical and psychological health of the neighbors.

Amount demanded: ThCh\$3,890,000 plus indexation and interest

It is believed that it is improbable that damage can be shown to have affected or put at risk the psychological or physical health of the plaintiffs from the bad odors, at the most the damage could be related to nuisances to the neighborhood. Current status: Sentence has not yet been passed.

A second lawsuit filed at the 19th Civil Court of Santiago (Case file 1105-2006) for ThCh940,000 was added to this case.

Court: 5th Civil Court of Santiago; Case No. 10852-2005. Aguas Andinas S.A. was sued for its civil liability for the accidental death of Mario Cañete Muñoz, a worker at the Kennedy-Estoril works. Amount demanded ThCh\$110,000, approximately, plus indexation, interests and costs.

Current status: Evidence period. Expected result: the claim should be rejected as Aguas Andinas had not requested the execution of these works.

Court: 24th Civil Court of Santiago; Case No. 6539-2006. A company is suing CORFO for the restitution of land at a property in Avenida Andrés Bello, Las Condes. Such land was acquired by CORFO from Aguas Andinas S.A. in September 1999.

Amount claimed: undetermined. Current status: Evidence period. Expected result: The claim should be rejected.

Court: 27th Civil Court of Santiago; Case No. 552-2007. Aguas Andinas S.A. was sued, as well as other entities, by a private individual who pretends the nullity of the DGA Resolution 3268, which approved the works of the emissary ElTrebal, Supreme Decrees No.76 and No.100 of the Economy Ministry which establish the tariff formulas for the periods between 200-2005 and 2005-2010, respectively.

Amount claimed: undetermined. Current status: Discussion period. Expected result. The claim should be rejected.

Court: Arbitrage Center of the Chamber of Commerce; Case file: 744-2007. A contractor sued Aguas Andinas S.A. for the payment of additional costs incurred in the works related to the renewal of networks in the areas of Yarur II and Sewage drain Arturo Prat.

Amount claimed: ThCh\$170,000, plus indexation and interests. Current status: Evidence period. Expected result: A favorable result for Aguas Andinas S.A. is expected.

Aguas Andinas S.A. is also a party in other lawsuits of lower amounts (in favor or against):

The amounts involved in lawsuits with favorable outcome go back to 2002 and amount to ThCh\$111,000, plus indexation and interests.

The lawsuits that could be unfavorable for the Company correspond to:

Nine labor lawsuits in which the Company was sued solidarily for ThCh\$52,100, between 2003-2007.

Three sued related to the Company's line of business, which are covered by hired insurances, the amounts involved amount to ThCh\$164,000.

Aguas Cordillera S.A.

Case No.4693-99, 11th Civil Court of Santiago. Demand for damages file by 79 neighbours of the district of Lo Barnechea concerning supply problems on October and November 1996. The demand is for ThCh\$728,626. The discussion period has finished. There are good probabilities that the Company will win the case.

Case No. 1158-2002, 8th Civil Court of Santiago. Demand for moral damages following dismissal for dishonesty by a former employee of the Company, which was declared as unjustified by the Supreme Court. Demand ThCh\$140,000. State: sentence favourable to the Company. The plaintiff presented an appeal. It is probable that the Court will confirm the first instance sentence.

The other lawsuits of lower amounts that could be unfavorable for Aguas Cordillera S.A. correspond to:

Two claims for activities related to the line of business, which have been accrued at the closing of the financial statements in the amount of ThCh\$49,280.

Aguas los Dominicos S.A.

Case No. 1189-2004, 19th Civil Court of Santiago

Claim of fine for non-compliance of the written orders and instruction of the SISS by not sending on time information for the "sewage treatment coverage" and "drinking water production" process.

Resolution 426 of February 9, 2004 for 10 UTA. State: Sentence unfavorable; appeal has been presented, there is a probability that the fine will be reduced.

The management, together with their legal advisers, consider that the above lawsuits will have no material effect on the financial statements. Nevertheless, provisions have been made, as shown in Note 15.

The Company complies with all provisions established by DFL No. 382 of the General Law on Sanitary Services, of 1988, as well as its Regulations (D.S. MOP No. 1199/2004, published in November 2005).

As the Company has no public shares as of December 31, 2007 it is not subject to any restriction.

As of December 31,2007 and 2006 there are no mortgages, pledges or interdictions that affect the ownership titles on any asset of the Company.

AGUAS MANQUEHUE S.A.

1) Case No. 2829-2003, 7th Civil Court of Santiago. Claim against Resolution 1194 of May 19, 2003 that applied a fine

of 26 UTM concerning discharges from the Los Trapenses sewage treatment plant on July 16, 2002 that exceeding the legally allowed limit.

Current status: Appeal has been conceded to sentence rejecting the claim. Expected result: Low probabilities of success; the applied fine will probably be maintained.

- 2) Case No. 1134-2004, 7th Civil Court of Santiago. Claim of fine for non-compliance of the written orders and instruction of the SISS by not sending on time information for the "sewage treatment coverage" and "drinking water production" process. Current status: Unfavorable sentence. Appeal has been presented. Expected result: It is probable that the sentence will be confirmed.
- 3) Case No. 15.178-2006, 27th Civil Court of Santiago. Claim against Resolution No. 554 that applied a fine of 30 UTA, due to the non-compliance of the written orders and instruction of the SISS by not sending on information on costs and expenses for 2004. Current status: Claim has been presented. Expected result: Low probabilities that the fine will be reduced.
- 4) Case No. 764-2003, Lower Court of Colina. The Owners' Community of the Condominium Los Algarrobos IVA and IVB, filed a lawsuit due to noise coming from the discharge of water to the Quebrada Las Ñipas, coming from the sewage water treatment plant located in the Condominio Polo de Manquehue, and has requested its closing. In addition they request the withdrawal of all piping installed at that location. Current status: Sentence should be passed. Expected result: According to the documents of the lawsuit, the claim should not be accepted. Amount: Undetermined.

The Company is also a party in other lawsuits of lower amounts (in favor or against).

The management, together with their legal advisers, considers that the above lawsuits will have no material effect on the financial statements. Nevertheless, provisions have been recorded, as indicated in Note 15.

BOND ISSUANCE COVENANTS

The Company has the following restrictions and obligations arising from the issuance of bonds on the domestic market:

- 1) Send to the bond-holders' representative a copy of the quarterly and annually audited unconsolidated and consolidated financial statements and of the subsidiaries registered with the Superintendency of Securities and Insurance, within the same time limits set by the Superintendency of Securities and Insurance together with all the public information reported to that Superintendency.
- 2) Recordinits books any provision for adverse contingencies that may anise and which, in managements opinion, should be reflected in its own and /or its subsidiaries financial statements.
- **3)** Maintain insurance coverage that reasonably protects its assets including its main offices, buildings, plants, office furniture and equipment and vehicles, in accordance with normal practices for similar businesses.
- **4)** The Company ensures that its transactions with its subsidiaries and other related parties are carried out in equitable conditions similar to those normally prevailing in the market.
- 5) Maintain a debt ratio no greater than 1.5:1, calculated on the figures in the consolidated and unconsolidated balance sheets, defined as the ratio of liabilities to shareholders' equity.
- **6)** The Company may not sell, assign or transfer essential assets (public-utility concessions granted by the S.I.S.S for Greater Santiago), except for contributions or transfers of essential assets to subsidiary companies.

BANK LOAN RESTRICTIONS

The Company has the following obligations and restrictions contained in loan agreements with several local banks:

- 1) A debt ratio not greater than 1.5:1, calculated on the figures in the consolidated and unconsolidated balance sheets, defined as the ratio of liabilities to shareholders' equity.
- 2) Prohibition on the disposal or loss of title over essential assets except for contributions or transfers of essential

assets to subsidiaries.

- 3) Send to the different banks with which the Company has credit facilities, a copy of its quarterly and audited annual unconsolidated and consolidated financial statements within a maximum of five days from the time they are sent to the Superintendency of Securities and Insurance.
- **4)** Recordinits books any provisions for adverse contingencies that might arise and which, in the management's opinion, should be reflected in the Company's financial statements.
- **5)** Maintain insurance cover that reasonably protects its assets including its main offices, buildings, plants, inventories, office furniture and equipment and vehicles, in accordance with normal practices for similar businesses.
- **6)** Send a certificate issued by the general manager of the Company confirming compliance with the obligations assumed in the loan agreement.

- **7)** Prohibition on the payment of dividends if there is a case of past due payments or delays in the payment of some loan installment, except for the obligatory minimum dividend.
- **8)** Maintain a financial expense coverage ratio of at least 3:1 calculated on the figures in the consolidated and unconsolidated balance sheets, defined as the ratio between operating income plus depreciation and amortization of intangible assets for the year, divided by financial expenses.
- **9)** Prohibition on the liquidation or dissolution of the Company, its operations or the business in which it engages; or to participate in any action or contract with the purpose of creating a merger or a consolidation, except in the case of a merger with its present subsidiaries.
- **10)** The Company ensures that its transactions with its subsidiaries and other related parties are carried out in equitable conditions similar to those normally prevailing in the market.

The Company complies with all provisions established by DFL No. 382 of the General Law on Sanitary Services, of 1988, as well as its Regulations (D.S. MOP No. 1199/2004, published in November 2005).

28. SANCTIONS

AGUAS ANDINAS S.A.

- a) Superintendency of Securities and Insurance: Neither the Company nor its directors or executives, were sanctioned during the years 2007 and 2006.
- b) Other administrative authorities.

2007

The Secretaria Regional Ministerial de Salud applied a fine of 10 UTM due to the existence of a generator which was operating without the accreditation of the isokinetic sampling, which constitutes an infringement of the indicated in article 4 of D.S. No. 4 of 1992, MINSAL. The fine was paid in December 2007.

By Resolution No. 2195 dated July 20, 2007, the Superintendency of Sanitation Services (SISS) applied a fine of 6 UTA due to the non-compliance in the services provided in the Sewage Water Treatment Plant of Curacaví, as established in the self-evaluation report of the first quarter of 2007. The fine was paid in August of the same year.

At December 31, 2007 no other sanctions were applied to the Company by other administrative authorities.

2006

1) The Superintendency of Sanitation Services (SISS) applied the following fines:

By Resolution SISS No. 553 of February 8, 2006, it applied a fine of 50 UTA for non-compliance of written instructions from the Superintendency to provide information on expenses and costs for the year 2004, requested in several notifications. Proceedings were started to appeal against such fine at the 26th Civil Court of Santiago (Case file 15200-2006), intending to obtain a reduction in the fine. Current status: Unfavorable first instance sentence, appeal has been presented.

By Resolution SISS No. 1454 of April 28, 2006, the SISS applied a fine of 20 UTA for deficiencies in the quality of the sewer system in the Quilicura district. Proceedings were started to appeal against such fine at the 29th Civil Court of Santiago (Case file 6509-2006), intending to obtain a reduction in the fine. Current status: Unfavorable first instance sentence, appeal has been presented.

- 2) The National Economic Inspector proponed to the Free Competition Defense Tribunal the application of a fine to Aguas Andinas S.A. for 50,000 UTM due to the following 1) situations: abusive demands and charges for new services in urban areas outside the concession area; 2) abusive demands and charges for services in rural areas outside the concession area, and 3) abusive application of Reimbursable Financial Contributions (AFR). Current status: Evidence period. The Company expects it will be absolved from the claims against it.
- 3) The National Labor authority applied a fine of 60 UTM "for not effectively protecting the health of employees". The facts relate to the death of four employees of a contractor firm working on the Dagoberto Godoy sewage drain. There are possibilities of the fine being annulled. One third of the fine was paid. Ordinary labor lawsuit filed at the 8th Labor Court of Santiago (Case file: 2449-2006). Currently in evidence period, there are possibilities of annulling the fine.

2005

- 1) The Superintendency of Sanitation Services (SISS) applied the following fine:
- By Resolution SISS 710-2005, it applied a fine for non-compliance of written instructions given by the Superintendency in its Official Letter No.1908 and in Chapter XI of the Invoicing Manual. Amount payable 40 "UTA" ("Annual Tax Units" an official monetary unit). An appeal to this fine was filed at the 29th Civil Court of Santiago, Case file 4779-2005. Current status: unfavorable outcome, appeal was presented in order to obtain a reduction in the fine
- 2) The COREMA RM (regional environmental authority) applied a fine of 300 UTM (monthly tax units) through Resolution 069/2005 of February 17, 2005, as a result of bad odors emanating from the La Farfana treatment pant. 10% of the fine was paid to initiate an appeal in the courts. An appeal to this fine was presented at the 27th Civil Court of Santiago, case No. 6857-2005, which is at the evidence stage.

2004

1) The Superintendency of Sanitation Services (SISS) applied the following fines:

By Resolution No. 415 dated February 9, 2004, the SISS fined the Company for not complying with written orders and instructions to submit, within the established term, information for the "Cover of the treatment of sewage" and "Production of drinking water" processes. A summary complaint judgment took place in the 29th Civil Court of Santiago (case file No.1189-2004). State of the case: demand rejected in the first instance. Appeal made. The amount of the sanction is 30 Annual Taxation Units (UTA).

The Company was sanctioned when the SISS detected a failure to comply with the parameters established on fecal coliforms during a self-evaluation carried out during the second quarter of 2003 at the Paine sewage treatment plant. An appeal was filed against the fine at the 29th Civil Court of Santiago (case file: 1434-2004). In the second instance stage, the appeal against the sanction is pending. The amount of the sanction is 26 Annual Taxation Units (UTA).

2) SESMA applied the following fines:

By its Resolution 5180 of December 15, 2003, a fine of 1,000 UTM (Monthly Taxation Units) was applied due to bad odors emanating from the La Farfana plant. The fine was paid in order to be able to bring a claim before the courts. This was presented to the 17th Civil Court of Santiago (Case No.2999-2004). State of the case: awaiting start of evidence stage.

By its Resolution 4838 of October 19, 2004, confirmed by Resolution 782 of February 2, 2005, SESMA, the national environmental authority, fined the Company with 2,000 Monthly Taxation Units (UTM) for breach of Law 144/61 issued by the Ministry of Health, which sets standards for avoiding atmospheric emanations or contaminants of any kind. The fine was paid in order to bring a claim before the court. This was presented to the 17th Civil Court of Santiago (Case No.4566-2005). State of the case: evidence stage pending.

3) The COREMA RM (regional environmental authority) fined the Company on May 28, 2004 (Resolution 177) with 1,000 Monthly Taxation Units (UTM) for bad odors emanating from the La Farfana Plant. 5% of the fine was

duly paid in order to commence an appeal through the law courts (28th Civil Court of Santiago - Case No.6593-2004). State of the case: in the evidence stage.

Neither the Company nor its directors or executives, were sanctioned during the years 2007 and 2006.

b) Other administrative authorities.

By Resolution 425 dated February 9, 2004, the Superintendency of Sanitation Services fined the Company for not complying with its written orders and instructions to remit, within the established term, information on the "Cover of the treatment of sewage" and "Production of drinking water" processes.

This fine is being appealed by the Company in the 4th Civil Court of Santiago (Case File Nº1195-2004). Current status: Unfavorable sentence; appealed against.

The Superintendency of Sanitation Services fined the Company under its Resolution 2734 for not complying with its written orders contained in Official Memorandum 2774 and in the development plan.

This fine is being appealed by the Company in the 29th Civil Court of Santiago (Case File N°11,129). Current status: Unfavorable sentence; appealed against.

AGUAS LOS DOMINICOS S.A.

a) Superintendency of Securities and Insurance:

Neither the Company nor its directors or executives, were sanctioned during the years 2007 and 2006.

b) Other administrative authorities.

By Resolution 426 dated February 9, 2004, the Superintendency of Sanitation Services fined the Company for not complying with its written orders and instructions to remit, within the established term, information on the "Cover of the treatment of sewage" and "Production of drinking water" processes.

This fine is being appealed by the Company in the 19th Civil Court of Santiago (Case File N°1189-2004). Current status: Unfavorable sentence; appealed against.

AGUAS MANQUEHUE S.A.

a) Superintendency of Securities and Insurance:
Neither the Company nor its directors or executives, were sanctioned during the years 2007 and 2006.

b) Other administrative authorities.

On May 19, 2003, the Superintendency of Sanitation Services fined the Company under its Resolution 1194 for failure to comply with the NCH 1333 Of 78 standard.

The Company paid the fine and this case is under appeal in the 7th Civil Court of Santiago (Case file N°2829-2003). The appeal was granted against the sentence that rejected the demand.

By Resolution 424 dated February 9, 2004 the Superintendency of Sanitation Services fined the Company for not complying with its written orders and instructions to remit, within the established term, information on the "Cover of the treatment of sewage" and "Production of drinking water" processes.

This fine is being appealed against by the Company in the 7th Civil Court of Santiago (Case File N°1134-2004). Current status: Unfavorable sentence; appealed against.

Case file No. 15.178-2006, 27th Civil Court of Santiago. Proceedings against Resolution SISS No. 554, which applied a fine of 30 UTA for non-compliance of written instructions from the Superintendency to provide information on expenses and costs for the year 2004.. Current status: Claim has been presented. Expected result: It is probable that the fine will not be reduced.

At December 31, 2007 and 2006, no other sanctions were applied to the Company or its Subsidiaries, its Directors or Executives.

31. NOTES PAYABLE AT LONG TERM

Clause 14 of Decree Law 70 published in the Official Gazette on March 30,1998 and clause 42 of Supreme Decree 453 set out the rules for demanding reimbursable financial contributions for capacity and for the provision of the corresponding service to whoever asks to be incorporated as a customer or requires a service expansion.

The debt for reimbursable contributions is shown in Long-term notes payable for ThCh\$44,406,775 and ThCh\$34,019,419 at December 31, 2007 and 2006, respectively.

32. TRANSFER OF OWNERSHIP OF SANITATION WORKS

Under an agreement signed on June 30,1998 between the metropolitan regional government and Aguas Andinas S.A., ownership of the sanitation works constructed or acquired with resources of the National Regional Development Fund was transferred to the company. The assets transferred under this agreement, which constitute contributions from third parties, are governed by Decree Law 70 issued by the Ministry of Public Works in 1988 and the provisions of clause 36 of the respective MINECON Law 453 of 1989.

At December 31, 1998, these assets were incorporated into the Company's fixed assets at a nominal value of Ch\$1 for each one, as there is a prohibition on considering these assets transferred by the regional government as an investment for purposes of tariff setting, so the Company cannot earn a return on them and they do not represent any additional operating profit-generating operations for the Company in addition to those already obtained since they started operations.

Furthermore, the income-cost benefit is not altered with respect to previous years as the Company made no disbursements.

The maximum tariff contemplated for this type of contribution is intended only to cover the operating and maintenance costs required.

According to the instructions of the Superintendency of Securities and Insurance, in its Resolution 01489 of March 22, 2000, the estimated technical value of these works was determined for information purposes. This now amounts to ThCh\$1,756,689 and its depreciation, determined on the basis of its time in use, amounts to ThCh\$712,605.

The main criteria used in the valuation of these works include: earth movement, supply pipes, drinking water and sewage chambers and labor costs, all as at December 2007. The average useful life of these assets is 406 months and their remaining average useful life as at December 2007 is 267 months.

Board of Directors of the Company agreed to distribute ThCh\$30,000,062, as interim dividend. Therefore, dividend No. 45 of the Company, will amount to Ch\$4.9028 per share and will be paid as of October 24, 2007.

On September 28, 2007 the following was informed to the Superintendency of Securities and Insurance (SVS):

The Board of Directors of the Company, during its Meeting of August 28, 2007, and in compliance with Clause 44 of Law 18,046, considering that the Directors Mr. Joaquín Villarino Herrera and Mrs. Marta Colet Gonzalo are also Directors of Empresa Depuradora de Aguas Servidas Ltda. (EDAS), has agreed to inform the SVS regarding the signing between both companies, on September 27, 2007, of the Operations and Maintenance Contract of the Sewage Water Treatment Plant La Farfana.

On October 3, 2007 the following was informed to the Superintendency of Securities and Insurance (SVS):

By Ord. SVS No. 11602 dated October 2, the Company was requested to report on certain aspects related to the Operations and Maintenance Contract of the Sewage Water Treatment Plant La Farfana signed between Aguas Andinas S.A. and Empresa Depuradora de Aguas Servidas Ltda., as follow:

The mentioned Contract had its origin in the international public bid, as established in Clause 67 of DFL MOP No. 382/88, General Law of Sanitation Services, which was called by Aguas Andinas S.A. on May 12, 2007.

Nine companies purchased the corresponding Bid bases, and the following companies presented an offer: Cadagua S.A., Omnium de Traitment et de Valorisation S.A. (OTV) and the consortium made up by the companies Degrémont S.A. and Sociedad General de Aguas de Barcelona S.A. (Agbar), being the latter companies related to Aguas Andinas S.A..

Subsequently, on August 2, 2007, Aguas Andinas informed the above mentioned consortium, which had the highest technical and economical qualifications, that it had been awarded the bid. The aforementioned was performed after a favorable agreement of the Directors' Committee of Aguas Andinas adopted on July 23, 2007, and by its Board of Directors, in Ordinary Meeting No. 351, held on July 24, 2007. The mentioned agreements were adopted unanimously by the assisting members, stating that is was an operation that is adjusted to equity conditions similar to those that usually prevail in the market.

In order to concur to the celebration of the agreement, and in conformity with the bid bases, Degrémont and Agbar through its subsidiary in Chile, Agbar Conosur Ltda., constituted a company called Empresa Depuradora de Aguas Servidas Ltda. (EDAS), in which the Directors of Aguas Andinas Mr. Joaquín Villarino and Mrs. Marta Colet were assigned as Directors.

According to the stated above, the celebration of the contract with EDAS is an operation contemplated in Clause 44 of Law No18,046, on Public Companies.

Note that the signing of the contract with EDAS was approved by the Directors' Committee of Aguas Andinas during the Meeting held on August 27, 2007 and by its Board of Directors during the Ordinary Meeting No. 352 held on August 28, 2007. The mentioned agreements were approved unanimously by the assisting Directors, with the abstention of Mr. Villarino and Mrs. Colet.

The Contract was celebrated under the method of series of unit prices, in the amount of UF2,774,994.4 (two million seven hundred and seventy four thousand nine hundred and ninety four point 4 Unidades de Fomento) plus VAT and it will have a validity period of 60 months, with the possibility of renewal for another period of 60 months, according to the terms and conditions established in the contract.

Finally, note that the purpose of the Contract is to develop the operations and maintenance services of the Sewage Water Treatment Plant La Farfana, owned by Aguas Andinas S.A., including all the scopes of an adequate operations and maintenance management of the Plant, considering among other: the supply of personnel, the expenses of electric power, supply of chemical material, spare parts, etc., as established in the Bid bases and all other documents of the Contract.

On December 11, 2007 the following was informed to the Superintendency of Securities and Insurance (SVS):

Aguas Andinas S.A., company registered in the Securities Register under No. 346, in accordance with the established in Clause 9 and chapter two of Clause 10 of Law No. 18,045 and the General Standard No. 30 of the SVS, communicates hereby the essential issue of the Company, of its business, of its public offer securities or their offers, according to the following:

- 1) Maximum amount of issuance: A maximum no par value amount will be issued of 2,500,000 Unidades de fomento.
- 2) Maximum expiration of the bonds: The bonds will expire in the period of 25 years as of the date of the public deed related to the issuance.
- 3) Use of the funds: Financing of investments.
- **4)** Other general conditions: The bonds could be placed in the general market within the period of 36 months after the issuance registration at the SVS. These will be issued to the bearer, with no special warranties, they will not become shares of the Company and will be payable in local currency.

AGUAS CORDILLERA S.A.

On August 31, 2007, the SVS was informed regarding the dissolution of Aguas Cordillera S.A., tax identification number 80.311.300-9, recorded in the Securities Record of the Superintendency of Securities and Insurance under No. 0369, due to acquisition of all shares by Aguas Cordillera S.A., tax identification number 96.809.310-K, company that previously operated under the name of Comercial Orbi II S.A. Note that at the Meeting of the Board of Directors of Aguas Cordillera S.A. (ex Comercial Orbi II S.A.) held on March 5, 2007 due to the dissolution of the absorbed company, Aguas Cordillera S.A. (ex Comercial Orbi II S.A.) is constituted irrevocably as the only responsible for the payment of every direct or indirect obligation that the absorbed company could have, with any natural or legal person. Furthermore, in relation to the clauses 69 and 71 of the Tax Code, it will be responsible for all taxes, burdens, levies, contributions and other tax obligations.

REASONED ANALYSIS

AS OF DECEMBER 31, 2007 AND 2006

GENERAL

The capital of Aguas Andinas is divided into 6,118,965,160 shares of no par value. At December 31, 2007, our principal shareholders are Inversiones Aguas Metropolitanas S.A. and CORFO, with 50.1% and 35% shareholdings, respectively.

REVENUES

Our revenues derive mainly from the regulated services we provide related to the production and distribution of drinking water, the collection, treatment and disposal of sewage water, other regulated services (which include revenues related to the cutting off and re-connection of supplies and charges relating to certain liquid industrial waste discharge monitoring activities and fixed charges). Sales for 2007 amounted to Ch\$253,756 million, amount which is Ch\$4,434 million higher (1.8%) than the one obtained in 2006. The net income of Aguas Andinas S.A. at December 31, 2007 was Ch\$97,059, Ch\$6,175 million (6.8%) more than in 2006.

COSTS AND OPERATING EXPENSES

Our costs and operating expenses are composed of the operating cost and administration and sales expenses. The most important items in the operating cost are depreciation, which represented 36.2%; the outsourcing of certain services to contractors, which represented 33.1%; and personnel, which represented 16.3% in 2007. The most important items of administration and sales expenses is personnel, which represented 43.2%; outsourced services, which represented 26.7%; and general expenses, which represented 11.9%, in 2007.

TARIFFS

The most important factor in determining the results of our business and our financial situation is the tariffs set for our regulated sales and services. As a natural monopoly, we are regulated by the SISS and our tariffs are set in accordance with the Sanitation Services Tariffs Law D.F.L. N° 70 de 1988.

Our tariff levels are reviewed every five years and, during that time, are subject to additional adjustments linked to polynomial of indexation if the accumulated change since the previous adjustment is 3 % or more, according to calculations made as a function of various inflation indices. The adjustments are specifically applied as a function of a formula that includes the Chilean Consumer Price Index,

the Wholesale Price Index for Imported Industrial Goods and the Wholesale Price Index for National Industrial Goods, all measured by the Chilean National Institute of Statistics. Tariffs are also subject to adjustment to reflect additional services previously authorized by the SISS.

During 2005, the tariff negotiation process was concluded for the period 2005-2010. The new tariffs approved by Decree No. 100 for Aguas Andinas S.A., Decree No. 149 for Aguas Manquehue S.A., Decree No. 179 for Aguas Cordillera S.A. and Decree No. 178 for Aguas Los Dominicos S.A. of the Ministry of the Economy came into effect on March 1, May, 19, and June 30, 2005 for the last two companies, respectively.

MARKET RISK

Our Company shows a favorable situation in terms of risk, mainly due to the special characteristics of the sanitation sector, but our business is seasonal and our operating results can fluctuate from one quarter to another. We tend to see the greatest demand and sales during the Chilean summer months (December to March) and the weakest demand and sales in the winter (June to September). In general, demand for water is greater in the warmer months than in the more temperate ones mainly due to the additional water needs for watering systems and other outdoor uses of water.

Adverse weather conditions can eventually affect the optimum delivery of sanitation services because the processes of capturing and producing drinking water depend to a large degree on weather conditions in the water basins. Factors like rainfall (snow, sleet, rain and fog), temperature, humidity, the flow of sediments, river flows and transparency, determine the quality and continuity of crude water available at each sluiceway that is capable of being treated at the drinking water plant. In the event of drought, we have large water reserves held in the El Yeso, Laguna Negra and Lo Encañado reservoirs, apart from the contingency plans we have developed, which enable us to reduce the eventual negative impacts that might be caused by adverse weather conditions for our operations.

CAPITAL INVESTMENTS

One of the variables that most affects the result of our business and financial situation is capital investments. These are of two types: Committed investments: We have to agree an investment plan with the SISS which states the investments we have to make during the following 15 years. The investment plan specifically reflects a commitment on our part to carry out certain projects related to the maintenance of certain quality standards and coverage. This investment plan is reviewed every five years, and Aguas Andinas can request modifications to it when certain relevant facts are ascertained.

The approval dates for the update of the development plans for the Aguas Group are.

Un-committed investments: These are investments that are not contemplated in the investment plan and which we make voluntarily to ensure the quality of our services and replace obsolete assets. These generally relate to the replacement of network infrastructure and other assets,

the acquisition of water rights and investments in non-regulated businesses, among other.

As required by Chilean regulations, interest on capital investments in works in progress is capitalized. Changes to our capital investment plan therefore affect the interest credited in our income statement and consigned as works in progress in Fixed assets in the balance sheet.

Assets

Current assets are Ch\$11,758 million higher than the year before, mainly due to a decrease in Marketable securities for Ch\$9,327, explained basically by funds held in some subsidiaries, and the increase in trade accounts receivable of Ch\$2,415.

The Company's property, plant and equipment increased in 0.19% in comparison to prior year, from Ch\$646,751 million to Ch\$647,966 million. This variation is explained by more investments and the corresponding increases in depreciations, as explained next.

The main increases of property, plant and equipment are in the item Constructions and Infrastructure in Ch\$12,807 million and Machinery and equipment for Ch\$379, due to investments performed in operating equipment, sanitation infrastructure and supporting equipment.

The charge for depreciation at December 2007 amounts to Ch\$36,111 million, 0.72% higher than in 2006 (Ch\$35,855

million). This is mainly explained by plants and equipment that have come into operation during 2007. Due to this reason, and due to plants and equipment performed in previous years, accumulated depreciation increased by Ch\$12,344 million, in comparison to the previous year (2.0%).

Other assets decreased by Ch\$1,372 million, explained mainly by the decrease of goodwill by Ch\$4,357, offset by the increase in deferred taxes (Ch\$3,256 million) due to the reorganization of the company, which implied the merger between the companies Aguas Cordillera S.A. and Orbi II.

Liabilities

Current liabilities decreased by Ch\$20,980 million, in comparison to prior year, mainly due to the decrease in Short-term borrowings from banks of Ch\$19,365 million, Long-term bank obligations, current portion of Ch\$13,412 million, due to the refinancing of the bank debt performed in the first quarter of the year; offset partially with the increase of bonds payable, short term portion, of Ch\$5,294 million, increase in unearned income (Ch\$2,148 million), corresponding to advanced income from property developers, higher income taxes of Ch\$1,664 and the higher amounts of accounts payable of Ch\$1,450 million.

Long-term liabilities increased by Ch\$19,521 million compared to prior year. The main change is the item long-term bank liabilities of Ch\$30,345 million, due to the refinancing of the bank debt, and the increase in notes payable by Ch\$10,387 million, corresponding to reimbursable financial contributions, offset partially by the bonds payable by Ch\$19,211 million due to the transfer of installments to the short-term in the period and the decrease of deferred taxes by Ch\$3,778 million (due to the merger effects of the subsidiaries).

Shareholders' equity compared to 2006 increased by Ch\$12,879 million. The main changes are the increase of net Income for the year by Ch\$6,175 million and the increase of Other reserves in Ch\$6,873, due to the merger of both subsidiaries.

As of December 2007 the current ration increased by 53.4%, in comparison to prior year, mainly due to the increase of current assets in 20.8% and to the decrease of the current liabilities in 21.17%; both items are specified in the balance sheet analysis.

The debt ration decreased in 3.32%, due to the amortization of installments of the debt in bonds and to the increase of equity (Ch\$12,880 million), which is offset partially through the new loans obtained.

For the calculation of the return on operating assets, the operating income is divided by the sum of the fixed assets

(average) and the intangible assets (average). This indicator increased by 0.12%, due to the variations in the operating income (0.08%) and the average assets (-0.4%).

The return on average equity shows a 5.03% increase, mainly because of the increase in profits and an increase in the average equity.

The return on dividends increased in 14.81% in 2007, as a higher dividend was paid (1.05%), and the price of the share decreased in 11.93%.

Under the heading of regulated services, the main variations are:

Water: this covers water production and distribution services. These show an increase of Ch\$500 million as a result of 2.0 million m₃ higher sales volumes. This sales volume is explained by the combination of a growth in

customers of 2.8% and a reduction in unit consumption by -2.3%.

Sewage: this covers the collection, treatment, disposal and interconnection of sewage water. These show an increase of Ch\$485 (0.5%) as a result of:

- a) higher treatment revenues of Ch\$529 million (41,167 million in 2007, in comparison to Ch\$40,638 million in 2006), due to a higher average tariff applied (1.4%);
- **b)** higher collection revenues of Ch\$208 million due to the increased average tariff applied, and a higher sales volume of 0.6 million m₃; and;
- c) less income from sewage interconnections of Ch\$251 million (Ch\$11,534 million in 2007, compared to Ch\$11.785 million in 2006) due to a lower average tariff applied (3.5%), offset partially by a higher sales volume of 1.6 million m3. The variations in the average tariffs are explained by the accumulated effect of indexation during 2006 and 2007.

Other regulated revenues this includes customers' fixed charges, supply cutting off and re-connection services, the control of liquid industrial waste discharges and provisions for non-billed consumption and discounts granted on payment agreements. These revenues show a decrease of Ch\$2,052.

The non-regulated services present an increase of Ch\$5.500, due to:

Sanitation services: increase of Ch\$1,229, related to the growth of domicile connection installations services, repairs, calibrations and other services.

Non-sanitation services: increase of Ch\$2,620 due to sales of material of water networks (Gestión y Servicios); increase of Ch\$1,470 million in operation services of the treatment plants of liquid industrial waste discharges and the treatment of excess of organic loads (Ecoriles, through new contracts) and Ch\$181 million in sales of laboratory services (sampling and analysis, ANAM).

Operating costs and expenses:

At year-end 2007, the consolidated costs amount to Ch\$132,442 million, which is Ch\$4,341 million higher (3.4%) in comparison to 2006. This increase is mainly explained by the following:

Operating costs decreased in Ch\$172 million (0.2%) to Ch\$98,495 million, compared to Ch\$98,667 million at year-end 2006. This is mainly explained by higher costs of non-regulated products offset by lower costs in services for regulated activities.

Administrative and selling expenses increased by Ch\$4,514 million (15.3%) to Ch\$33,947 million, compared to Ch\$29,434 million the year before. This was due basically to a higher allowance for doubtful accounts, explained in note 3, and higher severance payments programs.

Operating income

Because of the factors mentioned above, the consolidated operating income of Aguas Andinas for 2007 was Ch\$121,314 million, Ch\$93 million more in comparison to 2006. As a percentage of net sales, the margin decreased from 48.6% in 2006 to 47.8% in 2007.

Non-operating results

The consolidated non-operating result of Aguas Andinas increased by Ch\$6,768 million reaching Ch\$4,118 million in comparison to Ch\$10,886 million of 2006.

The main variations are explained by the increase in price-level restatement in Ch\$4,514 million, in addition to better results in other non-operating income/expense of Ch\$2,783 million, offset partially by a lower financial result of Ch\$501 million.

Income tax

The provision for income tax for 2007 is Ch\$685 million higher than the one recorded in the previous year, related to the better pre-tax income.

Net income

As a result of the factors indicated above, the consolidated net income of Aguas Andinas for 2007 amounted to Ch\$97,059 million, Ch\$6,175 million more than in 2006.

The positive operating cash flows in 2007 increased in Ch\$9,571 million, compared to the previous year, and the main variations relate to the increase of the collection of trade accounts receivable of Ch\$3,471 million, the decrease in payment to suppliers and personnel of Ch\$3,664 million and a lower payment of interests of Ch\$3,387 million, offset partially by an increase in VAT and other similar taxes of Ch\$974 million.

The financing flows decreased in Ch\$11,766 million compared to the year-end 2006, the main variation corresponds to the obtaining of loans (net increase of Ch\$8,226 million) and other financing sources of Ch\$2,569million.

The investing cash flows decreased by Ch\$12,637 million due to the decrease of the addition of property, plant and equipment by Ch\$7,638 million, and by higher proceeds from sales of property, plant and equipment of Ch\$5,456 million.

DIFFERENCE BETWEEN THE BOOK AND ECONOMIC VALUES OF THE PRINCIPAL ASSETS

The property, plant and equipment are shown valued in accordance with accounting principles generally accepted and regulations and the instructions of the Superintendency of Securities and Insurance. It is therefore believed that there should not be significant differences between the economic or market value and the book value of the assets, taking into account also the stated in Note 2j)

of the financial statements at December 31, 2007.

However, Aguas Andinas S.A. has sixty eight plots of land recorded that were transferred to it gratuitously by the Chilean Treasury and are booked at Ch\$1. There are also fixed assets with an exhausted accounting useful life booked at Ch\$1, but which are still in operation.

There are also transfers constituting third-party contributions covered by Decree Law 70 of the Ministry of Public Works of 1988 and the provisions of clause 36 of the respective regulations (MINECON 453 of 1989) which are explained in Note 31.

Aguas Cordillera S.A., in accordance with transitory clause 3 of Decree 382 of 1988, the General Sanitation Services Law, ceased in 1989 to book the assets financed by third parties and fiscal assets. As a result, the company keeps an off-the-books control of these assets and the calculation of price-level restatements and depreciation of these assets does not therefore affect its financial statements in any way. It has to keep this off-the-books control as the assets form part of the sanitation infrastructure that it has to operate and maintain.

The Company has water rights to various natural sources including Laguna Negra, Laguna Lo Encañado and Quebrada de Ramón. These rights were acquired gratuitously and no value has been assigned to them in the accounts.

The production of underground streams are fed by various wells located in the Metropolitan Region, for which Aguas Andinas S.A. has the water rights concessions that were granted to it gratuitously by the Water Authority as part of the Ministry of Public Works.

In summary, and as indicated above, Aguas Andinas S.A. and its Subsidiaries have no significant differences between the economic or market value and the book value of its assets, except the items mentioned in the preceding paragraphs. The principal assets of the Company relate to sanitation infrastructure works which have an exclusive use and are shown in accordance with accounting principles generally accepted in Chile.

MARKET ANALYSIS

The Company shows no change in the market in which it participates as, due to the nature of its services and the current legislation, it has no competition in its concession area.

Aguas Andinas S.A. currently has a 100% coverage in drinking water, 98.4% in sewage services and approximately 72% in sewage water treatment.

Aguas Cordillera S.A. currently has a 100% coverage in drinking water and 98.6% in sewage services.

Aguas Los Dominicos S.A. currently has a 99.9% coverage in drinking water and 97.6% in sewage services.

Aguas Manquehue S.A. currently has a 100% coverage in drinking water and 99.3% in sewage services.

FINANCIAL ASPECTS

Currency risks: our revenues are largely linked to the local currency. Our debt therefore is mainly denominated in that same currency so we do not have significant debts in foreign currencies.

At December 31, 2007, Aguas Andinas had 75% of its debt at fixed rates and 25% at variable rates. The fixed-rate debt is comprised of bonds payable (82%) and reimbursable financial contributions (18%), while the variable-rate debt is with local banks.

At December 30, 2006, 80% of the debt was at fixed rates and 20% at variable rates. The fixed-rate debt was comprised of short- and long-term bonds payable (80%); loans from local banks (7%) and reimbursable financial contributions (13%), while the variable-rate debt is with local banks.

The Company follows a policy of monitoring and managing interest rates in order to optimize financing costs and of constantly evaluating hedging instruments available in the financial market.

This favorable situation has led the credit-rating agencies to assign a credit rating of AA+ to our long-term debt. In the case of the shares, Feller Rate granted us a rating of First class Level 3, while ICR granted us a rating of First class Level 2.

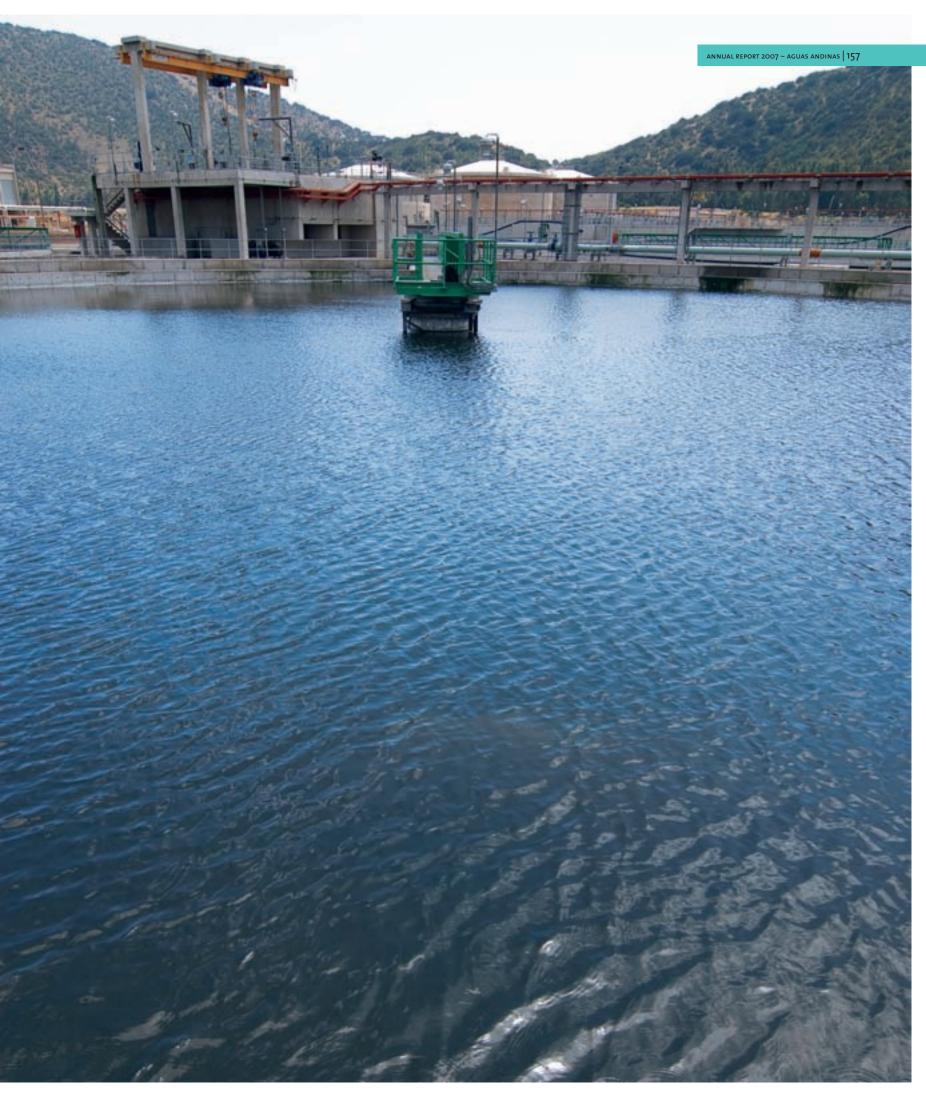

NOTES TO THE FINANCIAL STATEMENTS

(IN THOUSANDS OF CHILEAN PESOS-THCH\$)

1. REGISTRATION IN THE SECURITIES REGISTER

Aguas Andinas S.A. is registered under number 0346 in the Securities Register of the Superintendency of Securities and Insurance and is subject to the regulatory authority of that Superintendency.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a) Accounting period

These unconsolidated financial statements relate to the years between January 1 and December 31, 2007 and 2006, respectively.

b) Basis of preparation

These unconsolidated financial statements have been prepared in accordance with accounting principles generally accepted in Chile, issued by the Chilean Institute of Accountants, and the instructions of the Superintendency of Securities and Insurance, except for investment in subsidiaries which are stated using the equity method of accounting and have therefore not been consolidated. This treatment does not alter the net result for the year or the net shareholders' equity.

In the event of differences between the accounting principles generally accepted, as issued by the Chilean Institute of Accountants, and the instructions of the Superintendency of Securities and Insurance, the instructions of the Superintendency of Securities and Insurance will prevail.

These financial statements have been issued only for the purposes of an individual analysis of the company and should therefore be read and together with the consolidated financial statements, which are required by accounting principles generally accepted in Chile.

c) Basis of presentation

For comparison purposes, the financial statements at December 31, 2006 and their respective notes have been restated of the books by 7.4%. This percentage corresponds to the variation in the Consumer Price Index during the last twelve months, with a one-month time lag.

For comparison purposes, some items of the 2006 financial statements have been reclassified.

d) Price-level restatement

The financial statements have been restated by 7.4% in 2007 and 2.1% in 2006, to reflect the effects of variations in the purchasing power of the local currency during each year in accordance with accounting principles generally accepted in Chile.

Income statement balances were also restated to express them at year-end values.

e) Basis of currency translation

Assets and liabilities in Unidades de Fomento and/or foreign currencies are shown at their respective values and/or exchange rates at each year end, at the following rates:

f) Marketable securities

Marketable securities relate to investments in mutual funds units. These are shown at their redemption value at the closing date of these financial statements.

g) Inventories

Materials are shown at their restated cost which does not exceed their respective replacement costs at each yearend

There is an allowance for obsolescence for disposable items remaining in stock for more than one year with no activity. The company uses the system of weighed average cost, to value its inventories.

h) Allowance for doubtful accounts

The allowance for doubtful accounts depends on the aging of the accounts receivable and the historical recovery, as follows:

- A 100% allowance is provided for customers with debts overdue for over 8 months.
- The accounts receivable converted into repayment plans are classified in:
- "non-government subsidized", which are accrued as bad debts in 100%, of the agreed amount, in 2007. In 2006

an allowance of 20% was accrued for these amounts.

- "government subsidized", with an allowance for doubtful accounts of 55% of the agreed amount, and 45% is accrued as a commercial discount, in 2007. In 2006, the Company accrued as bad debts 40% of the total agreed amount and 45% as a commercial discount.
- A 100% allowance is provided for past-due notes receivable.

i) Property, plant and equipment

Property, plant and equipment transferred by the predecessor entity are shown at their restated appraisal values determined by independent consultants in a technical study made in 1977. Acquisitions after 1977 are shown at their restated cost.

The property, plant and equipment include the main renewals and improvements. Maintenance costs or minor repair expenses are charged to income in the year in which they are incurred.

Works in progress include financing costs incurred until the assets are in a condition to be used, in accordance with Technical Bulletin No.31 of the Chilean Institute of Accountants.

Direct remunerations, consultancy costs and other inherent and identifiable expenses are also included in the cost of some work in progress.

j) Depreciation of property, plant and equipment

Depreciation is calculated using the straight-line method on the restated book values over the remaining useful lives of the respective assets.

k) Leased assets

Lease agreements classified as capital leases are recorded in accordance with Technical Bulletin No.22 of the Chilean Institute of Accountants.

Leased assets are valued and its depreciation is calculated according to the accounting principle generally accepted for the property, plant and equipment.

Assets acquired under lease agreements are not legally owned by the Company until it has exercised its purchase option and therefore the Company can not freely dispose them.

l) Intangibles

Water rights, rights of ways, software and other rights

are shown at their restated cost net of amortization, in accordance with Technical Bulletin No.55 of the Chilean Institute of Accountants.

Intangible assets are being amortized over a period of 40 years from the date of acquisition or as from 1998 as it is believed that they will provide benefits during that period.

Software is amortized over a period of 4 years from the acquisition date as it is believed they will provide benefit in such period.

m) Investments in related companies

Investment in related companies, with the ability to exercise a significant influence over the company, are accounted for using the equity method, determined on the basis of the respective financial statements of the company at December 31, 2007 and 2006. Equity in earnings or losses of such companies is recognized on an accrual basis.

n) Goodwill

Goodwill represents the excess paid over the proportional equity value on the purchase date of the shares in Aguas Cordillera S.A. This is being amortized over a period of 20 years from the date of acquisition as this is the estimated period of return on the investment.

o) Transactions under resale agreements

Acquisitions of securities under resale agreements are valued as fixed-income investments and are shown in Other current assets, in accordance with Circular No.768 of the Superintendency of Securities and Insurance.

p) Bonds payable

This is the obligation for the placement of bonds issued by the Company on the domestic market and shown at their nominal value plus indexation adjustments and interest accrued at each year-end. The discount incurred and the issuance costs on the placement of the bonds are deferred and amortized over their respective terms, in accordance with Circular 1,370 of the Superintendency of Securities and Insurance.

q) Income tax and deferred taxes

The Company has provided for income tax on the basis of its net taxable income determined in accordance with the provisions of the Income Tax Law. According to Technical Bulletin No.60 and other instructions from

the Chilean Institute of Accountants and Circular 1,466 of the Superintendency of Securities and Insurance, the Company records the effects of deferred taxes resulting from temporary differences, tax benefits related to tax losses carry-forward and other events that create differences between the financial and tax basis of assets and liabilities.

r) Severance payments

Severance payments will be paid in accordance with the Labor Code, except for the amount of accumulated indemnities at July 31, 2002, for employees included in the respective union labor agreement and those to whom the same benefits apply in accordance with their individual labor contracts. The accumulated amount at that date is adjusted quarterly according to changes in the consumer price index. The collective labor contract also established that employees who retire from the company within 120 days of having reached the legal retirement age, will continue to accrue this benefit after July 2002, until their retirement date.

The Company's obligation for the accrued indemnity for employees up to July 2002 is accounted for at its current value, and the obligation for the additional indemnity that is estimated the employees who retire from the company will accrue, is accounted for at its present value, calculated according to the accrued cost of the benefit method and at an annual discount rate of 4.1% in 2007 and 4.8% in 2006.

There are also individual contracts which are accounted for by the current value according to their terms.

Advances granted to personnel against such funds are shown as long-term debtors. These, advances price level restated, will be deducted from the final settlement, as stated in the respective contracts.

s) Revenue recognition

The Company's sales are recorded on the basis of the consumption read and billed to each customer, divided into monthly billing groups and valued in accordance with the tariff fixed by the Superintendency of Sanitation Services (SISS) for five-year periods.

Consumption read but not billed at the year-end is also recorded at the tariff defined for each invoicing group.

t) Research and development costs

Expenses in research and development studies which are not related to any project, are charged to income in the year in which they are incurred. Otherwise, they form part of the costs of the corresponding work in progress.

u) Statement of cash flows

The Company considers as cash and cash equivalents its balances in cash, in unrestricted bank checking accounts, time deposits, marketable securities and resale agreements whose redemption will take place within 90 days from the date the investment was made and that carry no significant loss risk at the time of redemption.

Cash flows from operating activities include revenues and expenses of the Company and all other income and expenses that are treated as non-operating in the Statement of Income.

3. ACCOUNTING CHANGES

The following changes in accounting estimates were made during 2007:

The Company has collective labor agreements with its employees which provide for indemnities in accordance with the Labor Code and an additional indemnity if they retire while being employed.

To calculate this additional indemnity, the Company uses the present value of such obligations based on the accrued cost method for those who are covered by the union labor agreement and who are believed will remain employed until their retirement age. The discount rate used for this calculation has been changed from 4.8% at December 2006 to 4.1% at December 2007, in accordance with a study performed by the Company.

The effect of this change on income for 2007 amounts to a greater charge of ThCh\$63,789.

The Company has agreed to deferred payments, for the past due accounts receivables from clients, through payment agreements which are collectible upon maturity of each of the installments. The accounts receivables from with payment agreements are classified as "government subsidized",inthecaseofspecialagreements with customers of a lower socio-economic level and as "non-government subsidized" for the other payment agreements.

During 2007 the Company increased the allowance of agreements classified as non-government subsidized from 20% to 100%; and in the case of the government subsidized agreements, it increased the allowance for doubtful accounts from 40% to 55%, accruing the remaining 45% as a commercial discount. In both cases, due to the low recovery of the verified debts in the previous year.

The effect of this change on income for 2007 amounts to a greater charge of ThCh\$2,706,346.

There have been no other accounting changes that could affect the comparative of those financial statements.

4. SHORT AND LONG-TERM DEBTORS

Trade accounts receivable relate to the billings for drinking water, sewage services, sewage treatment and other associated services, with balances classified as short and long term.

The balance of trade accounts receivable includes an allowance for revenues accrued as at December 31, 2007 and 2006 of ThCh\$11,707,771 and ThCh\$12,975,457, respectively, corresponding to unbilled meter readings at each year-end.

The balance of debtors at December 31, 2007 is divided into Residential 80.65%, Commercial 16.71%, Industrial and others 2.64%. The balance of debtors at December 31, 2006 was divided into Residential 80.40%, Commercial 16.43%, Industrial and others 3.17%.

Allowances for doubtful accounts have been recorded, as follows:

- a) An allowance for doubtful accounts has been provided as explained in Note 2h), amounting to ThCh\$14,181,875 and ThCh\$12,153,064 as of December 31, 2007 and 2006, respectively. The charge to income for the years 2007 and 2006 were ThCh\$2,995,843 and ThCh\$818,756, respectively. In addition, at December 31, 2007 and 2006, debts of ThCh\$129,670 and ThCh\$206,632, respectively, were written off
- b) Provisions for commercial discounts relate to payment agreements of debts signed by customers by which they can obtain a commercial discount if they fully comply with the agreement. This allowance amounts to ThCh\$3,689,090 and ThCh\$2,989,795 at December 31, 2007 and 2006, respectively. The charge to income at December 31, 2007 and 2006 amounted to ThCh\$932,076 and ThCh\$510,462, respectively. Out of the provisions commercial discounts to amount to ThCh\$26,780 and ThCh\$0 as of December 31, 2007 and 2006, respectively.

The main component of long-term debtors relates to advances against severance payments, as indicated in Note 2r) and to trade accounts receivables net of their corresponding allowance.

Property rental guarantees are owed to Aguas Cordillera S.A., Aguas Los Dominicos S.A., Aguas Manquehue S.A., Gestión y Servicios S.A., Ecoriles S.A. and Análisis Ambientales S.A.

There is a drinking water and sewage interconnection contract with Aguas Cordillera S.A., with payments at 30 days without interest.

Análisis Ambientales S.A. provides chemical and

bacteriological analysis services, whose payment terms are 30 days without interest.

The debt with Gestión y Servicios S.A. related to purchases of materials, payable at 30 days without interest.

Transactions

As at December 31, 2007 and 2006 short terms loans were granted to and/or received by Aguas Cordilleras S.A., Aguas Manquehue S.A., Gestión y Servicios S.A., Análisis Ambientales S.A., Aguas Los Dominicos S.A., Ecoriles S.A., with an annual interest of TAB UF at 90 days or more: 0.15% during 2007 and 1% during 2006.

TRANSACTIONS WITH PARENT COMPANY

Notes and accounts receivable

There is a property rental agreement in Unidades de Fomento with Inversiones Aguas Metropolitanas S.A. which uses the premises of Aguas Andinas S.A., payable within the first five working days of each month.

As of December 31, 2006 ended a technical services contract signed with Inversiones Aguas Metropolitanas S.A., these payments were performed at 90 days.

8. INVESTMENTS IN RELATED COMPANIES

The Extraordinary Shareholders' Meeting of Aguas Cordillera S.A. (formerly Commercial Orbi II S.A.), held in October 2006, agreed to a capital increase of Ch\$118,341,203.847 (historic pesos), equivalent to 49,127 shares for payment. This capital increase was fully subscribed and paid by the shareholder Aguas Andinas S.A., and the other shareholder renounced their pre-emptive subscription rights. The same Extraordinary Meeting accepted that Aguas Andinas S.A. could pay for the increase by contributing shares in Aguas Cordillera S.A. which were valued at Ch\$118,339,453.286 (historic pesos), with the balance in cash.

On November 29, 2006, Gestión y Servicios S.A. held an Extraordinary Shareholders' Meeting where it approved a capital increase from Ch\$13,220,228 (historic pesos) divided into 100,000 fully paid no par value common shares to Ch\$608,130,488 (historic pesos) divided into 4,600,000 shares of the same characteristics. The capital increase of Ch\$594,910,260 (historic pesos) was performed through the issuance of 4,500,000 shares for payment. The shares corresponding to this new issuance were fully subscribed and paid by Aguas Andinas S.A., for which Aguas Cordillera S.A. renounced to their pre-emptive subscription rights.

A share sale agreement was signed on November 30, 2006 between Aguas Andinas S.A. and Aguas Manquehue S.A. whereby the latter sold to the former one share in Aguas Manquehue S.A. for Ch\$64,379 (historic pesos). This transaction was carried out within the terms of clause 27 of the Corporations Law which states, in the pertinent part, that corporations may only acquire their own shares when the acquisition results in a merger with another company that is shareholder in the absorbing company, which situation occurred with the merger of Aguas Manquehue S.A. with Hidráulica Manquehue Ltda.

On August 31, 2007, Aguas Cordillera S.A. was dissolved, tax identification number 80.311.300-9, as Aguas Cordillera S.A., tax identification number 96.809.310-K, had bought all shares of this company, the company previously operated under the name Comercial Orbi II S.A.. The effects of this merger are generated starting September 1, 2007. This transaction was recorded in according with the established in Technical Bulletin No.72 of the Chilean Institute of Accountants, combinations of business under common control based on the methodology of pooling of interest.

The Company records under the equity method of accounting the investments in related parties whose percentage is lower than 20%, as it has significant influence in their decision making process, and belong to the same business group.

13. BONDS PAYABLE (SHORT AN LONG-TERM)

This heading covers the amounts owed to the public due to the issuance of bonds by the Company in September 2001, December 2002, December 2005 and January 2006 on the domestic market.

In September 2001, Series bond B were issued for U.F.1.8 million for a 21-year term with repayments beginning in 2008.

On October 10, 2002, the Superintendency of Securities and Insurance certified the registration of bonds for up to U.F.10 million. Of this amount, Series C bonds were issued with a nominal value of U.F.4.2 million and Series D with a nominal value of U.F.5.8 million.

In December 2002, Series C bonds for U.F.4.0 million were placed, with repayments starting in June 2005 and extending through to December 2010.

On December 9, 2005, the Superintendency of Securities and Insurance approved a new bond issue totaling U.F. 5.0 million (Serie F), in order to finance the prepayment of the Series D bonds and refinance other obligations of Aguas Andinas S.A. in January 2006. The repayment will be performed quarterly starting June 1, 2008 through to December 1, 2026.

On December 23, 2005, the Series E bonds were placed for U.F.1.65 million, with repayment in June 2012.

The corresponding accrued interest is shown in short-term liabilities.

The bond issuances carry no special collateral except for the general pledge over the Company's assets.

The increase is generated by the change of the discount rate from 4.8% to 4.1%, the effect in net income of this change amounted to ThCh\$63,789. During 2007, a provision was established for the voluntary retirement program which included 35 employees; its effect in net income was of ThCh\$1,069,650.

The Ordinary Shareholders' Meeting held on April 23, 2007 resolved to distribute 100% of the Company's net income for 2006 and the distribution of ThCh\$73,938 (historic pesos) of the reserves for future dividends, discounting the provisory dividend paid in October 2006. The dividend amounted to ThCh\$56,600,428 (historic pesos), equivalent to Ch\$9.25 per share. The payment was made on May 22, 2007.

The Board Meeting held on September 25,2007, agreed to distribute ThCh\$30,000,062 (historic) as interim dividend, equivalent to Ch\$4.9028 per share, against net income for 2007. This payment was made on October 24, 2007.

Other reserves

On August 31, 2007, Aguas Cordillera S.A. was dissolved, as Aguas Cordillera S.A., (ex Comercial Orbi II. S.A.), had bought all shares of this company. On September 1, 2007 both companies merged, as established in Technical Bulletin No. 72 of the Chilean Institute of Accountants, combinations of business under common control based on the interest unification methodology, recording an equity of ThCh\$6,725,927 of which, Aguas Andinas recognized it held 99.99003% in the item Other reserves, equivalent to the participation it has in Aguas Cordillera S.A. (Note 8).

As established in clause 10 of the Corporations Law 18,046, the proportional amount of the restatement of capital was added to capital, this being divided at December 31, 2006 into 6,118,965,160 subscribed and paid shares.

2006

The Ordinary Shareholders' Meeting held on April 26, 2006 agreed to distribute all the Company's net income for the year 2005 plus ThCh\$499,549 (historic) of reserves for future dividends, after deducting the interim dividend paid in September 2005. The amount of the dividend was ThCh\$54,556,693 (historic), equivalent to Ch\$8,9160 per share and was paid on May 25, 2006.

The Board Meeting held on September 19, 2006, agreed to distribute ThCh\$28,208,429 (historic) an interim dividend, equivalent to Ch\$4,61 per share, against the income for 2006. This payment was made on October 26, 2006.

As established in clause 10 of the Corporations Law 18,046, the proportional amount of the restatement of capital was added to capital, this being divided at December 31, 2006 into 6,118,965,160 subscribed and paid shares.

Other reserves

As required by Technical Bulletin No.72 of the Chilean Institute of Accountants, paragraph 29, groups of companies under common control based on the methodology of pooling of interests the Company recorded under the caption Other reserves the variations generated by the increase in investments by Aguas Andinas S.A. through the purchases of shares in Gestión y Servicios S.A., Aguas Cordillera S.A., (Ex - Comercial ORBI II S.A.) and Aguas Manquehue S.A., and the reduction in its participation in Aguas Cordillera S.A. through the disposal of 100% of the shares (Note 8).

b) Pending lawsuits

The following are the Company's main outstanding lawsuits:

Court: 11th Civil Court of Santiago; Case file: 5716-1999

Aguas Andinas S.A. was sued severally by a gas company for damages to a pipeline made by a construction company. Aguas Andinas S.A. alleges that it has no responsibility in this incident as it has no relationship whatsoever with the cause of the damage. The amount demanded is ThCh\$85,816, plus indexation and interest. Sentence has been passed at the first instance rejecting the suit against Aguas Andinas S.A. accepting only a part of the suit against the construction company for a far lower figure. The gas company has appealed and asked that the suit be entirely accepted, also against Aguas Andinas S.A.

Court: 14th Civil Court of Santiago; Case file: 169-2003

A company sued *Aguas Andinas S.A.* seeking the absolute nullity of Sociedad Gestión y Servicios S.A. in which Aguas Andinas S.A. had a 1% participation at the time of the demand.

The first instance final sentence was given rejecting the demand in all its parts and condemning the plaintiff to pay the costs. The plaintiff has appealed.

Court: 5th Civil Court of Santiago; Case file: 3684-2001

Aguas Andinas S.A. was sued for the payment of an indemnity for extra-contractual liability for environmental damage in breach of Law 19,300. It is claimed that the failure to arrive at a prompt and adequate solution to the emission of bad odors from the Santiago Poniente Plant and subsequently from the La Farfana Plant, caused the prolonged suffering or moral damage to the neighbors, in addition to enormous financial damage as a result of the drop in the value of their properties. Amount involved: U.F.81,848. Current status: Discussion period has concluded, and the judge has requested the parties to provide evidence, as of December 31, 2007 the parties had not been notified. Sentence estimation: There is a moderate possibility of success in this case as the suit lacks a solid foundation. Current status: Sentence is pending on the provision of evidence.

There is a second lawsuit presented at the 11th Civil Court of Santiago, Case file 3541-2004 for U.F.506,594. Two other lawsuits have been presented which were requested to be added to this case: 20th Civil Court of Santiago, Case file: 7900-2046 for U.F.81,848 and 25th Civil Court of Santiago, Case file: 8305-2006, for U.F.42,161, plus indexation and interests.

Court: 19th Civil Court of Santiago; Case file: 2632-2004

A private individual is requesting the reversal of the sale of some water rights to *Aguas Andinas S.A.* through a third party, sustaining that this has violated his rights. He is demanding the restitution of the water rights that were acquired for U.F. 5,525. Current status: Sentence has been passed, notification not yet executed. Estimation: an appeal has been filed against second instance sentence, its admission is still pending.

•11th Civil Court of Santiago; Case No.13.214 - 2004

Aguas Andinas S.A. was sued for damages and extracontractual liability for environmental damage, an offense under Law 19,300. It is claimed that the failure to arrive at a prompt and adequate solution to the emission of bad odors from the Santiago Poniente Plants and subsequently from the La Farfana Plant, caused the prolonged suffering or moral damage to the neighbors, in addition to an enormous financial damage as a result of the drop in the value of their properties.

Amount demanded: U.F. 410,759 plus indexation and interest. Current status: First instance - discussion period. Exceptions were presented in order to correct irregularities in the suit. There is a moderate possibility of success; the result will depend on the proof of damages submitted. The court process has not yet commenced.

18th Civil Court of Santiago; Case No. 322-2005

Aguas Andinas S.A. was sued for technical faults and defects at the La Farfana Sewage Plant, causing bad odors that have affected the physical and psychological health of the neighbors.

Amount demanded: ThCh\$3,890,000 plus indexation and interest.

It is believed that it is improbable that damage can be shown to have affected or put at risk the psychological or physical health of the plaintiffs from the bad odors, at the most the damage could be related to nuisances to the neighborhood. Current status: Sentence has not yet been passed.

A second lawsuit filed at the 19th Civil Court of Santiago (Case file 1105-2006) for ThCh940,000 was added to this case.

5th Civil Court of Santiago; Case No. 10852-2005Aguas Andinas S.A. was sued for its civil liability for the accidental death of Mario Cañete Muñoz, a worker at the Kennedy-Estoril works. Amount demanded ThCh\$110,000, approximately, plus indexation, interests and costs. Current status: Evidence period. Expected result: the claim should be rejected as Aguas Andinas had not requested the execution of these works.

24th Civil Court of Santiago; Case No. 6539-2006

A company is suing CORFO for the restitution of land at a property in Avenida Andrés Bello, Las Condes. Such land was acquired by CORFO from *Aguas Andinas S.A.* in September 1999.

Amount claimed: undetermined. Current status: Evidence period. Expected result: The claim should be rejected.

27th Civil Court of Santiago; Case No. 552-2007

Aguas Andinas S.A., was sued, as well as other entities, by a private individual who pretends the nullity of the DGA Resolution 3268, which approved the works of the emissary El Trebal, Supreme Decrees No. 76 and No. 100 of the Economy Ministry which establish the tariff formulas for the periods between 2000-2005 and 2005-2010, respectively.

Amount claimed: undetermined. Current status: Discussion period. Expected result. The claim should be rejected.

Court: Arbitrage Center of the Chamber of Commerce; Case file: 744-2007

A contractor sued *Aguas Andinas S.A.* for the payment of additional costs incurred in the works related to the renewal of networks in the areas of Yarur II and Colector Arturo Prat.

Amount claimed: ThCh\$170,000, plus indexation and interests. Current status: Evidence period. Expected result: A favorable result for *Aguas Andinas S.A.* is expected.

The Company is also a party in other lawsuits of lower amounts (in favor or against):

The amounts involved in lawsuits with favorable outcome go back to 2002 and amount to ThCh\$110,000, plus indexation and interests.

The lawsuits that could be unfavorable for the Company correspond to:

- Nine labor lawsuits in which the Company was sued solidarily for ThCh\$52,100, between 2003-2007.
- Three claims related to the Company's line of business, which are covered by hired insurances, the amounts involved amount to ThCh\$164,000.

The management, together with their legal advisers, considers that the above lawsuits will have no material effect on the financial statements. Nevertheless, provisions have been recorded, as indicated in Note 14.

c) Bond issuance covenants

The Company has the following restrictions and obligations arising from the issuance of bonds on the domestic market:

- 1) Send to the bond-holders' representative a copy of the quarterly and annually audited unconsolidated and consolidated financial statements and of the subsidiaries registered with the Superintendency of Securities and Insurance, within the same time limits set by the Superintendency of Securities and Insurance together with all the public information reported to that Superintendency.
- 2) Record in its books any provisions for adverse contingencies that may arise and which, in management's opinion, should be reflected in its own and/or its subsidiaries' financial statements
- **3)** Maintain insurance coverage that reasonably protects its assets including its main offices, buildings, plants, office furniture and equipment and vehicles, in accordance with normal practices for similar businesses.
- **4)** The Company ensures that its transactions with its subsidiaries and other related parties are carried out in equitable conditions similar to those normally prevailing in the market.
- **5)** Maintain a debt ratio no greater than 1.5:1, calculated on the figures in the consolidated and unconsolidated balance sheets, defined as the ratio of liabilities to shareholders' equity.

6) The Company may not sell, assign or transfer essential assets (public-utility concessions granted by the S.I.S.S for Greater Santiago), except for contributions or transfers of essential assets to subsidiary companies.

d) Bank loan restrictions

The Company has the following obligations and restrictions contained in loan agreements with several local banks:

- 1) A debt ratio not greater than 1.5:1, calculated on the figures in the consolidated and unconsolidated balance sheets, defined as the ratio of liabilities to shareholders' equity.
- 2) Prohibition on the disposal or loss of title over essential assets except for contributions or transfers of essential assets to subsidiaries.
- 3) Send to the different banks with which the Company has credit facilities, a copy of its quarterly and audited annual unconsolidated and consolidated financial statements within a maximum of five days from the time they are sent to the Superintendency of Securities and Insurance.
- **4)** Recordinits books any provisions for adverse contingencies that might arise and which, in the management's opinion, should be reflected in the Company's financial statements.
- 5) Maintain insurance cover that reasonably protects its assets including its main offices, buildings, plants, inventories, office furniture and equipment and vehicles, in accordance with normal practices for similar businesses.
- **6)** Send a certificate issued by the general manager of the Company confirming compliance with the obligations assumed in the loan agreement.
- 7) Prohibition on the payment of dividends if there is a case of past due payments or delays in the payment of some loan installment, except for the obligatory minimum dividend.
- 8) Maintain a financial expense coverage ratio of at least 3:1 calculated on the figures in the consolidated and unconsolidated balance sheets, defined as the ratio between operating income plus depreciation and

amortization of intangible assets for the year, divided by financial expenses.

- **g)** Prohibition on the liquidation or dissolution of the Company, its operations or the business in which it engages; or to participate in any action or contract with the purpose of creating a merger or a consolidation, except in the case of a merger with its present subsidiaries.
- **10)** The Company ensures that its transactions with its subsidiaries and other related parties are carried out in equitable conditions similar to those normally prevailing in the market.

The Company complies with all provisions established by DFL No.382 of the General Law on Sanitary Services, of 1988, as well as its Regulations (D.S. MOP No.1199/2004, published in November 2005).

23. GUARANTEES RECEIVED FROM THIRD PARTIES

At December 31, 2007 and 2006, the Company has received documents in guarantee for ThCh\$24,855,222 and ThCh\$19,301,754, respectively, arising mainly from work contracts with construction companies to guarantee full compliance with their conditions. There are also other guarantees to ensure the compliance of service and materials supply contracts to ensure their timely provision or delivery.

25. SANCTIONS

- a) Superintendency of Securities and Insurance: Neither the Company nor its directors or executives, were sanctioned during the years 2007 and 2006.
- b) Other administrative authorities.

2007

The Secretaria Regional Ministerial de Salud applied a fine of 10 UTM ("Monthly Tax Units") due to the existence of a generator which was operating without the accreditation of the isokinetic sampling, which constitutes an infringement of the indicated in article 4 of D.S. No. 4 of 1992, MINSAL. The fine was paid in December 2007.

By Resolution No. 2195 dated July 20, 2007, the Superintendency of Sanitation Services (SISS) applied a fine of 6 UTA ("Annual Tax Units") due to the non-compliance in the services provided in the Sewage Water Treatment Plant of Curacaví, as established in the self-evaluation report of the first quarter of 2007. The fine was paid in August of the same year.

At December 31, 2007 no other sanctions were applied to the Company by other administrative authorities.

2006

1) The Superintendency of Sanitation Services (SISS) applied the following fines:

By Resolution SISS No. 553 of February 8, 2006, it applied a fine of 50 UTA ("Annual Tax Units") for non-compliance of written instructions from the Superintendency to provide information on expenses and costs for the year 2004, requested in several notifications. Proceedings were started to appeal against such fine at the 26th Civil Court of Santiago (Case file 15,200-2006), intending to obtain a reduction in the fine. Current status: Unfavorable first instance sentence, appeal has been presented.

By Resolution SISS No. 1454 of April 28, 2006, it applied a fine of 20 UTA ("Annual Tax Units") for deficiencies in the quality of the sewer system in the Quilicura district. Proceedings were started to appeal against such fine at the 29th Civil Court of Santiago (Case file 6,509-2006), intending to obtain a reduction in the fine. Current status: Unfavorable first instance sentence, appeal has been presented.

- 2) The National Economic Inspector proponed to the Free Competition Defense Tribunal the application of a fine to Aguas Andinas S.A.for 50,000 UTM ("MonthlyTax Units") due to the following 1) situations: abusive demands and charges for new services in urban areas outside the concession area; 2) abusive demands and charges for services in rural areas outside the concession area, and 3) abusive application of Reimbursable Financial Contributions (AFR). Current status: Evidence period. The Company expects it will be absolved from the claims against it.
- 3) The National Labor authority applied a fine of 60 UTM ("Monthly Tax Units") "for not effectively protecting the health of employees". The facts relate to the death of four employees of a contractor firm working on the Dagoberto Godoy sewage drain. There are possibilities of the fine being annulled. One third of the fine was paid. Ordinary labor lawsuit filed at the 8th Labor Court of Santiago (Case file: 2449-2006). Currently in evidence period, there are possibilities of annulling the fine.

2005

1) The Superintendency of Sanitation Services (SISS) applied the following fine:

By Resolution SISS 710-2005, it applied a fine for non-compliance of written instructions given by the Superintendency in its Official Letter No.1908 and in Chapter XI of the Invoicing Manual. Amount payable 40 UTA ("Annual Tax Units" - an official monetary unit). An appeal to this fine was filed at the 29th Civil Court of Santiago, Case file 4779-2005. Current status: unfavorable outcome, appeal was presented in order to obtain a reduction in the fine

2) The COREMA RM (regional environmental authority) applied a fine of 300 UTM (monthly tax units) through Resolution 069/2005 of February 17, 2005, as a result of bad odors emanating from the La Farfana treatment plant. 10% of the fine was paid to initiate an appeal in the courts. An appeal to this fine was presented at the 27th Civil Court of Santiago, case No. 6857-2005, which is at the evidence stage.

2004

1) The Superintendency of Sanitation Services (SISS) applied the following fines:

By Resolution No. 415 dated February 9, 2004, the SISS fined the Company for not complying with written orders and instructions to submit, within the established term, information for the "Cover of the treatment of sewage" and "Production of drinking water" processes. A summary complaint judgment took place in the 29th Civil Court of Santiago (case file No.1189-2004). State of the case: demand rejected in the first instance. Appeal made. The amount of the sanction is 30 Annual Taxation Units (UTA).

The Company was sanctioned when the SISS detected a failure to comply with the parameters established on fecal coliforms during a self-evaluation carried out during the second quarter of 2003 at the Paine sewage treatment plant. An appeal was filed against the fine at the 29th Civil Court of Santiago (case file: 1434-2004). In the second instance stage, the appeal against the sanction is pending. The amount of the sanction is 26 Annual Taxation Units (UTA ("Annual Tax Units")).

2) SESMA APPLIED THE FOLLOWING FINES:

By its Resolution No.5180 of December 15, 2003, a fine of 1,000 UTM (Monthly Taxation Units) was applied due to bad odors emanating from the La Farfana plant. The fine was paid in order to be able to bring a claim before the courts. This was presented to the 17th Civil Court of Santiago (Case No.2999-2004). State of the case: awaiting start of evidence stage.

By its Resolution 4838 of October 19, 2004, confirmed by Resolution 782 of February 2, 2005, SESMA, the national environmental authority, fined the Company with 2,000 Monthly Taxation Units (UTM) for breach of Law 144/61 issued by the Ministry of Health, which sets standards for avoiding atmospheric emanations or contaminants of any kind. The fine was paid in order to bring a claim before the court. This was presented to the 17th Civil Court of Santiago (Case No.4566-2005). State of the case: evidence stage pending.

3) The COREMA RM (regional environmental authority) fined the Company on May 28, 2004 (Resolution 177) with 1,000 Monthly Taxation Units (UTM) for bad odors emanating from the La Farfana Plant. 5% of the fine was duly paid in order to commence an appeal through the law courts (28th Civil Court of Santiago - Case No.6593-2004). State of the case: in the evidence stage.

28. TRANSFER OF OWNERSHIP OF SANITATION WORKS

Under an agreement signed on June 30,1998 between the metropolitan regional government and Aguas Andinas S.A., ownership of the sanitation works constructed or acquired with resources of the National Regional Development Fund was transferred to the company. The assets transferred under this agreement, which constitute contributions from third parties, are governed by Decree Law 70 issued by the Ministry of Public Works in 1988 and the provisions of clause 36 of the respective MINECON Law No.453 of 1989.

At December 31, 1998, these assets were incorporated into the Company's fixed assets at a nominal value of Ch\$1 for each one, as there is a prohibition on considering these assets transferred by the regional government as an investment for purposes of tariff setting, so the Company cannot earn a return on them and they do not represent any additional operating profit-generating operations for the Company in addition to those already obtained since they started operations.

Furthermore, the income-cost benefit is not altered with respect to previous years as the Company made no disbursements.

The maximum tariff contemplated for this type of contribution is intended only to cover the operating and maintenance costs required.

According to the instructions of the Superintendency of Securities and Insurance, in its Resolution No.01489 of March 22, 2000, the estimated technical value of these works was determined for information purposes. This now amounts to ThCh\$1,756,689 and its depreciation, determined on the basis of its time in use, amounts to ThCh\$712,605.

The main criteria used in the valuation of these works include: earth movement, supply pipes, drinking water and sewage chambers and labor costs, all as at December 2007. The average useful life of these assets is 406 months and their remaining average useful life as at December 2007 is 267 months.

29. LONG-TERM NOTES PAYABLE

Clause 14 of Decree Law No.70 published in the Official Gazette on March 30,1988 and clause 42 of Supreme Decree No.453 set the regulations for demanding reimbursable financing contributions for capacity and or extensions of the corresponding service to those requesting to be added as customers or require an expansion of the service.

The debt for reimbursable contributions is shown in Long-term notes payable, for ThCh\$25,882,309 and ThCh\$17,700,915 at December 2007 and 2006, respectively.

At the Meeting of the Board of Directors, held on April 24, 2007, the Directors' Committee was constituted with its members Mrs. Mónica Singer González, Mr. Carlos Mladinic Alonso and Mr. Joaquín Villarino Herrera.

On September 25, 2007 the following was informed to the Superintendency of Securities and Insurance (SVS):

On September 25, 2007 the Board of Directors of the Company agreed to distribute ThCh\$30,000,062, as interim dividend. Therefore, dividend No. 45 of the Company, will amount to Ch\$4.9028 per share and will be paid as of October 24, 2007.

On September 28, 2007 the following was informed to the Superintendency of Securities and Insurance (SVS):

The Board of Directors of the Company, during its Meeting of August 28, 2007, and in compliance with Clause No.44 of Law 18,046, considering that the Directors Mr. Joaquín Villarino Herrera and Mrs. Marta Colet Gonzalo are also Directors of Empresa Depuradora de Aguas Servidas Ltda. (EDAS), has agreed to inform the SVS regarding the signing between both companies, on September 27, 2007, of the Operations and Maintenance Contract of the Sewage Water Treatment Plant La Farfana.

On October 3, 2007 the following was informed to the Superintendency of Securities and Insurance (SVS):

By Ord. SVS No. 11602 dated October 2, the Company was requested to report on certain aspects related to the Operations and Maintenance Contract of the Sewage Water Treatment Plant La Farfana signed between Aguas Andinas S.A. and Empresa Depuradora de Aguas Servidas Ltda.

In this regard, I would like to indicate the following:

The mentioned Contract had its origin in the international public bid, as established in Clause 67 of DFL MOP No. 382/88, General Law of Sanitation Services, which was called by Aguas Andinas S.A. on May 12, 2007.

9 companies purchased the corresponding Bid bases, and the following companies presented an offer: Cadagua S.A., Omnium de Traitment et de Valorisation S.A. (OTV) and the consortium made up by the companies Degrémont S.A. and Sociedad General de Aguas de Barcelona S.A. (Agbar), being the latter companies related to Aguas Andinas S.A.. Please find attached the Opening Document of the Economic Bids.

Subsequently, on August 2, 2007, Aguas Andinas informed the above mentioned consortium, which had the highest technical and economical qualifications, that it had been awarded the bid. The aforementioned was performed after a favorable agreement of the Directors' Committee of Aguas Andinas adopted on July 23, 2007, and by its Board of Directors, in Ordinary Meeting No. 351, held on July 24, 2007. The mentioned agreements were adopted unanimously by the assisting members, stating that is was an operation that is adjusted to equity conditions similar to those that usually prevail in the market.

In order to concur to the celebration of the agreement, and in conformity with the bid bases, Degrémont and Agbar through its subsidiary in Chile, Agbar Conosur Ltda., constituted a company called Empresa Depuradora de Aguas Servidas Ltda. (EDAS), in which the Directors of Aguas Andinas Mr. Joaquín Villarino and Mrs. Marta Colet were assigned as Directors.

According to the stated above, the celebration of the contract with EDAS is an operation contemplated in Clause No.44 of Law No18,046, on Public Companies.

Note that the signing of the contract with EDAS was approved by the Directors' Committee of Aguas Andinas during the Meeting held on August 27, 2007 and by its Board of Directors during the Ordinary Meeting No. 352 held on August 28, 2007. The mentioned agreements were approved unanimously by the assisting Directors, with the abstention of Mr. Villarino and Mrs. Colet.

The Contract was celebrated under the method of series of unit prices, in the amount of UF2,774,994.4 (two million

seven hundred and seventy four thousand nine hundred and ninety four point 4 Unidades de Fomento) plus VAT and it will have a validity period of 60 months, with the possibility of renewal for another period of 60 months, according to the terms and conditions established in the contract.

Finally, note that the purpose of the Contract is to develop the operations and maintenance services of the Sewage Water Treatment Plant La Farfana, owned by Aguas Andinas S.A., including all the scopes of an adequate operations and maintenance management of the Plant, considering among other: the supply of personnel, the expenses of electric power, supply of chemical material, spare parts, etc., as established in the Bid bases and all other documents of the Contract.

On December 11, 2007 the following was informed to the Superintendency of Securities and Insurance (SVS):

Aguas Andinas S.A., company registered in the Securities Register under No. 346, in accordance with the established in Clause 9 and chapter two of Clause 10 of Law No. 18,046 and the General Standard No. 30 of the SVS, communicates hereby the essential issue of the Company, of its business, of its public offer securities or their offers, according to the following:

- 1) Maximum amount of issuance: A maximum no par value amount will be issued of 2,500,000 Unidades de fomento
- 2) Maximum expiration of the bonds: The bonds will expire in the period of 25 years as of the date of the public deed related to the issuance.
- 3) Use of the funds: Financing of investments.
- **4)** Other general conditions: The bonds could be placed in the general market within the period of 36 months after the issuance registration at the SVS. These will be issued to the bearer, with no special warranties, they will not become shares of the Company and will be payable in local currency.

At the date of these financial statements, Company management is not aware of any other significant issue that could affect significantly the financial situation and/or results of the Company as at December 31, 2007.

REASONED ANALYSIS

GENERAL

The capital of Aguas Andinas is divided into 6,118,965,160 shares of no par value. At December 31, 2007, our principal shareholders are Inversiones Aguas Metropolitanas S.A. and CORFO, with 50.1% and 34.98% shareholdings, respectively.

REVENUES

Our revenues derive mainly from the regulated services we provide related to the production and distribution of drinking water, the collection, treatment and disposal of sewage water, other regulated services (which include revenues related to the cutting off and re-connection of supplies and charges relating to certain liquid industrial waste discharge monitoring activities and fixed charges).

Sales for 2007 amounted to Ch\$208,539 million, amount which is Ch\$362 million lower (0.17%) than the one obtained in 2006. The net income of Aguas Andinas S.A. at December 31, 2007 was Ch\$97,059, Ch\$6,175 million (6.8%) more than in 2006.

COSTS AND OPERATING EXPENSES

Our costs and operating expenses are composed of the operating cost and administration and selling expenses. The most important items in the operating cost are depreciation, which represented 39.7%; the outsourcing of certain services to contractors, which represented 30.4%; and personnel, which represented 16.7% in 2007. The most important items of administration and sales expenses is personnel, which represented 43.5%; outsourced services, which represented 26.5%; and general expenses, which represented 11.1%, in 2007.

TARIFFS

The most important factor in determining the results of our business and our financial situation is the tariffs set for our regulated sales and services. As a natural monopoly, we are regulated by the SISS and our tariffs are set in accordance with the Sanitation Services Tariffs Law D.F.L. $N^{\circ}70$ de 1988.

Our tariff levels are reviewed every five years and, during that time, are subject to additional adjustments linked to polynomial of indexation if the accumulated change since the previous adjustment is 3 % or more, according to calculations made as a function of various inflation indices. The adjustments are specifically applied as a function of a formula that includes the Chilean Consumer Price Index, the Wholesale Price Index for Imported Industrial Goods and the Wholesale Price Index for National Industrial Goods, all measured by the Chilean National Institute of Statistics. Tariffs are also subject to adjustment to reflect additional services previously authorized by the SISS.

During 2005, the tariff negotiation process was concluded for the period 2005-2010. The tariff increases approved by Decree No.100 of the Ministry of the Economy came into effect on March 1, 2005.

MARKET RISK

Our Company shows a favorable situation in terms of risk, mainly due to the special characteristics of the sanitation sector, but our business is seasonal and our operating results can fluctuate from one quarter to another. We tend to see the greatest demand and sales during the Chilean summer months (December to March) and the weakest demand and sales in the winter (June to September). In general, demand for water is greater in the warmer months than in the more temperate ones mainly due to the additional water needs for watering systems and other outdoor uses of water.

Adverse weather conditions can eventually affect the optimum delivery of sanitation services because the processes of capturing and producing drinking water depend to a large degree on weather conditions in the water basins. Factors like rainfall (snow, sleet, rain and fog), temperature, humidity, the flow of sediments, river flows and transparency, determine the quality and continuity of crude water available at each sluiceway that is capable of being treated at the drinking water plant. In the event of drought, we have large water reserves held in the El Yeso, Laguna Negra and Lo Encañado reservoirs, apart from the contingency plans we have developed, which enable us to

reduce the eventual negative impacts that might be caused by adverse weather conditions for our operations.

CAPITAL INVESTMENTS

One of the variables that most affects the result of our business and financial situation is capital investments. These are of two types:

Committed investments:We have to agree an investment plan with the SISS which states the investments we have to make during the following 15 years. The investment plan specifically reflects a commitment on our part to carry out certain projects related to the maintenance of certain quality standards and coverage. This investment plan is reviewed every five years, and Aguas Andinas can request modifications to it when certain relevant facts are ascertained. The approval dates of the development plans of Aguas Andinas S.A. were May 23, 2006 and February 16, 2007 for the Greater Santiago and for other areas between May and August 2006.

Un-committed investments: These are investments that are not contemplated in the investment plan and which we make voluntarily to ensure the quality of our services and replace obsolete assets. These generally relate to the replacement of network infrastructure and other assets, the acquisition of water rights and investments in non-regulated businesses, among other.

As required by Chilean regulations, interest on capital investments in works in progress is capitalized. Changes to our capital investment plan therefore affect the interest credited in our income statement and consigned as works in progress in Fixed assets in the balance sheet.

Current assets are Ch\$1,369 million higher than the year before, mainly due to a decrease in the following items:

- 1) Other current assets in Ch\$791 million (due to increase in investments in promissory notes for Ch\$268 million, and Advanced income for Ch\$567 million);
- **2)** Trade accounts receivable for Ch\$685 million (due to the increase of net sales for Ch\$3,894 million);
- **3)** Deferred taxes for Ch\$593 million (mainly due to the increase of the allowance for doubtful accounts)

These increases are offset, partially, by the decrease in Notes receivable of Ch\$1,196 million.

The Company's property, plant and equipment decreased in Ch\$4,077 million in comparison to prior year, mainly due to the increase of the accumulated depreciation in Ch\$8,893, million offset by the increase in the item Constructions and Infrastructure in Ch\$5,200 million, due to the investments performed in sanitation infrastructure and operating equipment.

Other non - current assets increased by Ch\$17,076 million, the main changes being the increase in investments in related companies of Ch\$21,833 million, due to the higher recognition of the larger equity in earnings of the related companies, offset by decrease of goodwill in Ch\$4,351 million.

Current liabilities decreased by Ch\$19,051 million, in comparison to prior year, mainly due to the decrease in Short-term borrowings from banks of Ch\$19,365 million, Long-term bank obligations, current portion of Ch\$13,412 million, due to a lower transfer from the long term of installments, due to the refinancing of the bank debt, changing the maturity periods of the amortization of loans, offset with the increase of bonds payable, short term portion, of Ch\$5,293 million, corresponding to installment of bonds series B and F, that start their amortization period, increase of the Accounts payable to related parties of Ch\$3,231 million (due to the obtaining of loans from related parties), and increase in Other income received in advance

of Ch\$2,599 million and Income taxes of Ch\$1,355 million.

Long-term liabilities increased by Ch\$20,539 million compared to prior year. The main change is the item long - term bank liabilities of Ch\$30,345 million, due to the refinancing of the bank debt, changing the maturity date from 3 to 6 years with a two year grace period, in addition to the obtaining of new bank loans in the amount of Ch\$25,000 million. The Notes payable (reimbursable financial contributions made by the Company as established in the current legal regulations DFL No. 70, 1988) increased in Ch\$8,181 million. On the other hand, the bonds payable decreased in Ch\$19,211 due to the transfer of installments, with expiration during January 2008, of the Bonds series B, C and F, in the short term.

Shareholders' equity compared to 2006 increased by Ch\$12,880 million, the main changes are the increase of Other reserves in Ch\$6,873 million, and the increase of net income for the year of Ch\$6,175 million. Reserves increased due to the recognition of the variation caused with the merger with Aguas Cordillera S.A. (Ex ORBI II) with Aguas Cordillera S.A. This merger was performed in accordance with Technical Bulletin No. 72 of the Chilean Institute of Accountants Combination of Companies under Common Control based on the methodology of pooling of interest.

As of December 2007 the current ration increased by 29.17%, in comparison to prior year due to the increase of current assets in 2.99% and to the decrease of the current liabilities in 19.97%. The decrease of current liabilities is mainly due to the extension of the amortization of installments of the Long term bank borrowings, current portion, as defined in the established refinancing, and to the decrease of Obligations with banks and financial institutions, short-term.

The debt ratio decreased in 2.60%, due to the decrease of short term liabilities (20.3%) of the debt in bonds and the increase in equity (3.07%).

The return on the average assets increased in 6.91% due to the increase of current assets and other assets in 2.99% and 8.50%, respectively, while the property, plant and equipment decreased in 0.73%.

The return on the average asset remained at 17.72%, as the operating income decreased in 1.04% and the average assets decreased in 1.03%. For the calculation of the return on operating assets, the operating income is divided by the sum of the average assets (as operating assets are considered the fixed and the intangible assets).

The return on average equity shows a 5.03% increase, mainly because of the increase in profits (6.79%) and an increase in the average equity (1.66%).

The return on dividends increased in 14.81% in 2007, as a higher dividend was paid (1.05%), and the price of the share decreased in 11.93%.

Under the heading of regulated services, the main variations are:

- a) Water: this covers water production and distribution services. These show an increase of Ch\$147 million as a result of 0.5 million m3 of greater volumes and a higher average tariff applied. The higher sales volume is explained by the combination of a growth in customers of 2.7% and a reduction in unit consumption by -2.4%; while the higher average tariff followed the accumulated effect of indexation adjustments of 2007 and 2006.
- **b)** Sewage: this covers the collection, treatment, disposal and interconnection of sewage water. These show an increase of Ch\$314 million(0.3%) as a result of:
- 1) higher collection revenues of Ch\$99 million.
- **2)** higher treatment revenues of Ch\$505 million due to the increased average tariff applied.
- 3) less income from sewage interconnections of Ch\$290 million due to a lower average tariff applied, offset partially by a higher sales volume of 1.3 million m3.

The changes in the average tariffs are explained by the accumulated effect of indexation adjustments of 2007 and 2006.

c) Other regulated revenues: this includes customers' fixed charges, supply cutting off and re-connection services, the control of liquid industrial waste discharges and provisions for non-billed consumption and discounts granted on payment agreements. These revenues show a decrease of Ch\$2,112 million.

In the case of non-regulated services, the main variations are:

Increase of Ch\$1,289 million related to the growth of domicile connection installations services, repairs, calibrations and other services.

Operating costs and expenses:

At year-end 2007, the costs amount to Ch\$107,451 million, which is Ch\$705 million higher in comparison to 2006. This increase is mainly explained by the following:

Operating costs decreased in Ch\$3,046 million (3.8%) to Ch\$77,522 million, compared to Ch\$80,568 million at year-end 2006. This is mainly explained by lower costs in contractors.

Administrative and selling expenses increased by Ch\$3,751 million (14.3%) to Ch\$29,929 million, compared to Ch\$26,178 million the year before. This was due basically to a higher allowance for doubtful accounts, higher personnel expenses and severance payments programs.

Operating income

Because of the factors mentioned above, the operating income of Aguas Andinas S.A. for 2007 was Ch\$101,088 million, Ch\$1,067 million less in comparison to 2006. As a percentage of net sales, the margin decreased from 48.9% in 2006 to 48.5% in 2007.

Non-operating results

The non-operating result of Aguas Andinas S.A. amounted to Ch\$12,602 million, Ch\$8,242 million more than in 2006.

The main variations are explained by the price-level restatement in Ch\$4,659 million, in addition to better results in subsidiaries of Ch\$3,061 million and a higher result of Other non-operating income (expenses) of Ch\$994 million, offset by a lower financial result of Ch\$476 million.

Income tax

The provision for income tax for 2007 is Ch\$999 million higher than the one recorded in the previous year, related to the better pre-tax income.

Net income

As a result of the factors indicated above, the net income of Aguas Andinas S.A. for 2007 amounted to Ch\$97,059 million (6.8%), Ch\$6,175 million more than in 2006.

The positive operating cash flows in 2007 increased in Ch\$11,154 million, compared to the previous year, and the main variations relate to the increase of the dividends and other amounts received of Ch\$4,476 million, the collection of trade accounts receivable of Ch\$3,796 million, and a lower payment of interests of Ch\$2,972 million.

The financing flows increased in Ch\$5,551 million compared to the year-end 2006, the main increased correspond to the lower payments of bank borrowings and obligations with the public of Ch\$41,195 million and Ch\$5,144 million, respectively, and the higher obtaining of Other financing sources of Ch\$3,051 million, offset by the decreases in: Obtaining of borrowings of Ch\$33,204 million; Obtaining of other loans from related companies of Ch\$5,425 million and the Obligations with the public (bonds) of Ch\$4,781 million.

The investment cash flows decreased by Ch\$4,289 million due to the increase of the Disposal of property, plant and equipment of Ch\$3,802 million and less additions to property, plant and equipment of Ch\$2,765 million, offset by the decrease in the Collection of other loans to related parties of Ch\$2,482 million.

DIFFERENCE BETWEEN THE BOOK AND ECONOMIC VALUES OF THE PRINCIPAL ASSETS

The property, plant and equipment are shown valued in accordance with accounting principles generally accepted and regulations and the instructions of the Superintendency of Securities and Insurance. It is therefore believed that there should not be significant differences between the economic or market value and the book value of the assets, taking into account also that stated in Note 2i) of the financial statements at December 31, 2007.

However, Aguas Andinas S.A. has sixty eight plots of land recorded that were transferred to it gratuitously by the Chilean Treasury and are booked at Ch\$1. There are also fixed assets with an exhausted accounting useful life booked at Ch\$1, but which are still in operation.

There are also transfers constituting third-party contributions covered by Decree Law No.70 of the Ministry of Public Works of 1988 and the provisions of clause No.36 of the respective regulations (MINECON No.453 of 1989) which are explained in Note 28.

The Company has water rights to various natural sources including Laguna Negra, Laguna Lo Encañado and Quebrada de Ramón. These rights were acquired gratuitously and no value has been assigned to them in the accounts.

The production of underground streams are fed by various wells located in the Metropolitan Region, for which Aguas Andinas S.A. has the water rights concessions that were granted to it gratuitously by the Water Authority as part of the Ministry of Public Works.

In summary, and as indicated above, Aguas Andinas S.A. has no significant differences between the economic or market value and the book value of its assets, except the items mentioned in the preceding paragraphs. The principal assets of the Company relate to sanitation infrastructure works which have an exclusive use and are shown in accordance with accounting principles generally accepted in Chile.

MARKET ANALYSIS

The Company shows no change in the market in which it participates as, due to the nature of its services and the current legislation, it has no competition in its concession area.

Aguas Andinas S.A. currently has a 100% coverage in drinking water, 98.4% in sewage services and approximately 70% in sewage water treatment.

FINANCIAL ASPECTS

Currency risks: our revenues are largely linked to the local currency. Our debt therefore is mainly denominated in that same currency so we do not have significant debts in foreign currencies.

At December 31, 2007, Aguas Andinas had 73% of its debt at fixed rates and 27% at variable rates. The fixed-rate debt is comprised of bonds payable (89%) and reimbursable

financial contributions (11%), while the variable-rate debt is with local banks.

At December 30, 2006, 79% of the debt was at fixed rates and 21% at variable rates. The fixed-rate debt was comprised of short- and long-term bonds payable (86%); loans from local banks (7%) and reimbursable financial contributions (7%), while the variable-rate debt is with local banks.

The Company follows a policy of monitoring and managing interest rates in order to optimize financing costs and of constantly evaluating hedging instruments available in the financial market.

This favorable situation has led the credit-rating agencies to assign a credit rating of AA+ to our long-term debt. In the case of the shares, Feller Rate granted us a rating of First class Level 3, while ICR Risk Rate granted us a rating of First class Level 2.

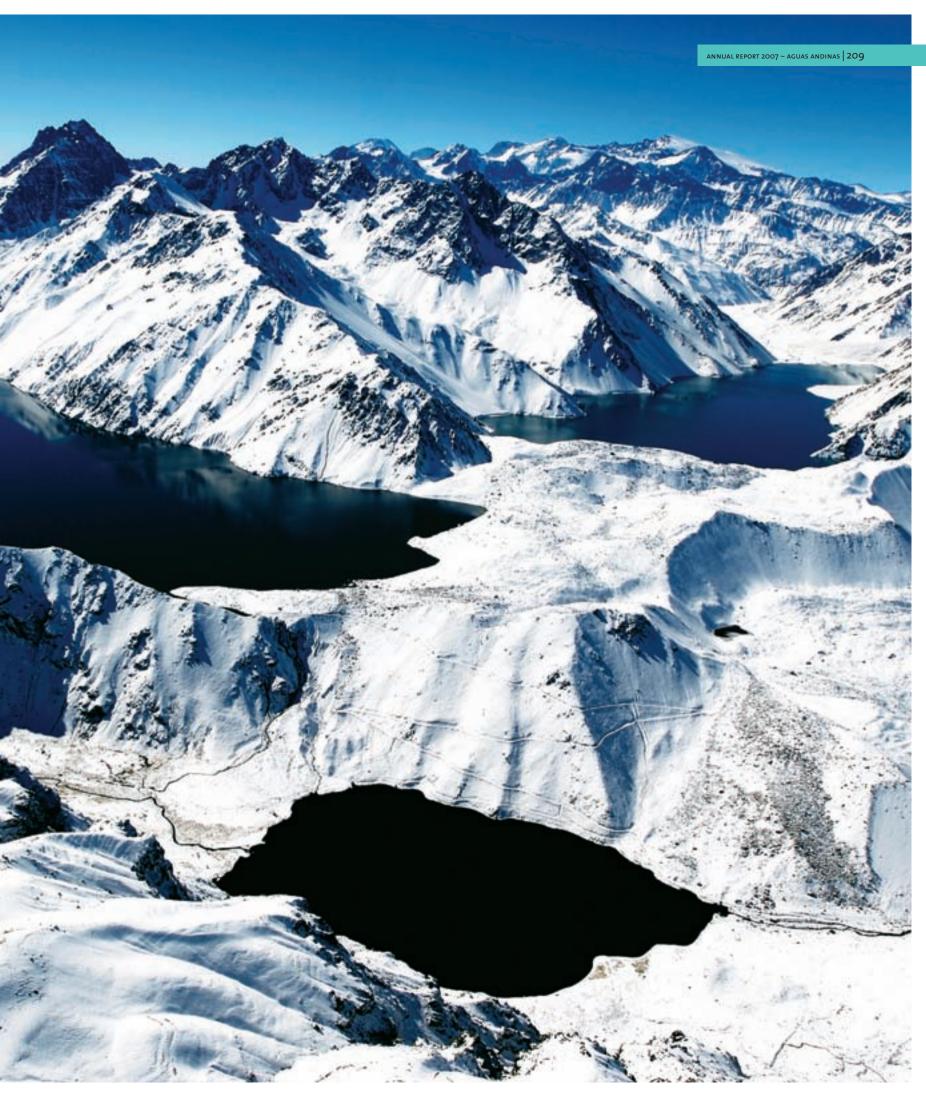
